INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Michigan United Food and Commercial Workers
Union and Employers Joint Prepaid Legal Services Plan

Opinion

We have audited the accompanying financial statements of Michigan United Food and Commercial Workers Union and Employers Joint Prepaid Legal Services Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of March 31, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

March 31, 2025 and 2024

1. DESCRIPTION OF PLAN

The following description of Michigan United Food and Commercial Workers Union and Employers Joint Prepaid Legal Services Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established as a defined benefit plan during 1993 as a result of collective bargaining agreements to provide legal services to all hourly employees of participating employers who have completed one year of service. The first contributions to the Plan began in April 1996 while the first benefits paid were in September 1996.

To become initially eligible for benefits, an employee must have been employed by a contributing employer. Coverage is effective the month following the first month in which employer contributions are received by the Plan.

The Plan is administered by a Board of Trustees consisting of a union group and an employer group of representatives, each having equal voting power.

Contributions

The participating employers contribute such amounts as are required under their collective bargaining agreements. During the years ended March 31, 2025 and 2024, employers contributed \$.02 per hour. Employer contributions are received from employers for the operation of the Plan. Employer contributions are recognized in the period of benefit coverage.

Benefits

The Plan is designed to provide specific legal service benefits on a prepaid basis to eligible employees working under collective bargaining agreements and eligible dependents. Legal service benefits are provided up to the maximum cost of the service as provided in the Plan document. Participants, together with eligible dependents, may receive no more than \$1,500 in legal service benefits in any 12-month period. As of January 1, 2025, participants, together with eligible dependents, may receive no more than \$1,750 in legal service benefits in any 12-month period.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Cash

Cash is defined as currency on hand, in demand deposits.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentrations

Employer contributions - The Plan has one employer which accounted for approximately 97% of total employer contributions for the years ended March 31, 2025 and 2024.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment adviser. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Payments to legal services provider for the provision of benefits are recorded when paid. Amounts due to the legal services provider that have not yet been paid are recorded as benefit obligations payable and included in accounts payable on the statements of net assets available for benefits.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

3. FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Cash and cash equivalents: Valued at the deposit account balances, payable on demand.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to discontinue benefits at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the Trustees shall satisfy or make provisions to satisfy the Plan. Any remaining assets of the Plan shall be distributed under the opinion of the Trustees to bring about the purpose of the Plan.

5. TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax laws. The trust has obtained a favorable tax determination letter on August 24, 1994 from the Internal Revenue Service (IRS) and the Trustees believe that the trust and the Plan, as amended, continues to qualify and to operate in accordance with the applicable provision of the IRC.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

7. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through January 12, 2026, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
