Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of National Raisin Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of February 28, 2025 and August 31, 2024, and the related statements of changes in net assets available for benefits (in liquidation) for the period September 1, 2024 through February 28, 2025 and for the year ended August 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National Raisin Company 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 28, 2025 and August 31, 2024, and for the period September 1, 2024 through February 28, 2025 and for the year ended August 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Raisin Company 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of National Raisin Company 401(k) Plan approved a plan of liquidation on August 3, 2023, and management determined liquidation is imminent. As a result, the financial statements of National Raisin Company 401(k) Plan are presented on the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 – Description of Plan

The following description of the National Raisin Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of Plan provisions.

General – The Plan was a 401(k) cash or deferred profit-sharing plan covering substantially all employees of Sunshine Raisin Corporation dba National Raisin Company (the Company) and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan’s sponsor and served as plan administrator.

Plan termination – On August 3, 2023, the Board of Directors of the Company approved a resolution to terminate the Plan effective August 31, 2023. Subsequent to August 31, 2023, except for corrective contributions made by the Company on behalf of the participants, no contributions were allowed into the Plan. All participants became fully vested in their balances and had the option of either receiving a taxable cash distribution, a non-taxable rollover to an IRA account established in their name, or a non-taxable rollover to a new employer’s qualified retirement plan if employed by a different employer. All the Plan’s assets were distributed as elected by each participant, by February 28, 2025.

Eligibility – Employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which at least 1,000 hours were worked.

Contributions

Participant contributions – Each year, participants could contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants could also elect to make Roth contributions utilizing after-tax contributions. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer safe harbor contributions – The Company made safe harbor contributions to participants who had met the Plan’s eligibility requirements at a rate equal to 3% of the participant’s eligible compensation. There were no safe harbor contributions for the period September 1, 2024 through February 28, 2025 or for the year ended August 31, 2024.

Employer nonelective contributions – The Company could elect to make discretionary nonelective contributions to the Plan. Participants must have completed at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year, to be eligible to receive any employer-paid nonelective contributions. Nonelective contributions were allocated to eligible participants in the same proportion as a participant’s compensation bears to the total of all eligible participants’ compensation. There were no employer nonelective contributions for the period September 1, 2024 through February 28, 2025 or for the year ended August 31, 2024.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant’s account was credited with the participant’s contributions and employer safe harbor contributions, as well as allocations of the Company’s nonelective contributions (if any) and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant’s vested account. Participants directed the investment of their account into various investment options offered by the Plan.

Vesting – Participants were vested immediately in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the Company’s nonelective contribution portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service.

Payment of benefits – On termination of service due to termination, death, disability, retirement, or other reasons, a participant could elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, partial nonperiodic distributions, or annuities for the life of the participant and spouse. The Plan allowed for automatic lump sum cash distribution of participant vested account balances that were greater than \$200, and did not exceed \$1,000.

Forfeitures – Forfeitures were the nonvested portion of a participant’s account that was lost upon termination of employment. Forfeitures were retained in the Plan and would first be used to pay the Plan’s administrative expenses, with any remaining amount used to reduce future Company contributions. As of February 28, 2025 and August 31, 2024, there were \$0 and \$11,915, respectively, of forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan’s custodian, John Hancock Life Insurance Company (U.S.A.) (John Hancock USA), certifies the fair value of all investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date.

Income recognition – Purchases and sales of securities are recorded on a settlement-date basis. Dividends are recorded when received. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund’s prospectus. All such fees are charged directly against the fund’s investment performance; thus, they are not separately disclosed in the accompanying financial statements. Participants are assessed separately for transaction-related fees, which are separately disclosed in the financial statements. All other administrative expenses related to the Plan are paid by the Plan sponsor.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through December 18, 2025, which is the date the financial statements were available to be issued.

Note 3 – Investment Contract with Insurance Company

The Plan had a group annuity contract with John Hancock USA, which offered various pooled separate accounts (PSAs) from a variety of investment managers. PSAs established by John Hancock USA are segregated from other assets of John Hancock USA.

The Plan held sub-accounts within these PSAs, which were invested in shares of a corresponding fund issued by John Hancock USA, or in shares of funds issued by other management investment companies or collective investment trusts. Units held in sub-accounts of the PSAs were valued using the net asset value (NAV) practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. There have been no changes in the methodology used to determine the fair value of the PSAs at February 28, 2025 and August 31, 2024. All of the sub-accounts can be redeemed daily. There are no unfunded commitments, redemption frequency restrictions, or redemption notice requirements.

The valuation method used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan invested in the following PSAs with significant balances at August 31, 2024:

John Hancock Stable Value – The fund seeks to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The fund is invested primarily in benefit-responsive contracts issued by state regulated insurance companies and banks, including but not limited to John Hancock USA. In addition, each insurance company either contractually guarantees or obtains contractual guarantees from third parties insuring against the loss of principal deposited into the fund and providing that individual participant withdrawals will be paid promptly at book value (i.e., the amount of participant contributions plus interest previously credited, less previous withdrawals), even if the fund's total book value exceeds the market value of its underlying securities. However, if the book value of the fund exceeds the market value of underlying securities, the stabilizing agreements provide that the payment of certain withdrawals may be delayed for up to 12 months unless the Plan or the participant requesting the withdrawal elects to accept such payment subject to a market value adjustment.

John Hancock Multimanager 20xx Lifetime Portfolio – The fund seeks total return through its target retirement date, with a greater focus on income beyond the target date. The fund is designed to take the participant through retirement. Under normal market conditions, the fund primarily invests its assets in underlying funds using an allocation strategy designed for investors expected to retire around the year listed in the fund name. The expected year in which participants plan to retire and no longer make contributions is referred to as the target date. The portfolio is managed to provide potential growth and income opportunity even in the years after retirement. The most conservative mix occurs about 20 years after the target date when the portfolio has a 75% fixed income and 25% equity allocation. This portfolio allocates its assets among underlying funds according to an asset allocation strategy that becomes increasingly conservative over time. The portfolio's asset mix increases its allocation to fixed income funds and reduces its allocation to stock funds as it nears its target date. Automatic reallocation helps maintain an age-appropriate investment mix up to, and throughout, retirement.

Note 4 – Tax Status

The Plan document was a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Certified Investment Information

The following information related to investments was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock USA, qualified institution:

- Investments reflected on the accompanying statements of net assets available for benefits as of February 28, 2025 and August 31, 2024.
- Net appreciation in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the period September 1, 2024 through February 28, 2025 and for the year ended August 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of August 31, 2024.

Note 6 – Party-In-Interest Transactions

All Plan investments are managed by John Hancock Asset Management. John Hancock USA is the custodian of the Plan and is an affiliate of John Hancock Asset Management and, therefore, transactions with these entities qualify as exempt party-in-interest transactions. Fees paid by the Plan to John Hancock USA or John Hancock Asset Management are primarily charged directly against the fund's investment performance; thus, they are not separately disclosed in the accompanying financial statements.

Note 7 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company remitted the deferral amounts in each respective fiscal year. The contributions of lost earnings and excise taxes were corrected during the period ended February 28, 2025.
