### **Opinion**

We have audited the accompanying financial statements of Construction Teamsters Security Fund for Southern California (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of benefit obligations as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of March 31, 2025 and 2024, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Construction Teamsters Security Fund for Southern California (the "Plan") is a multiemployer welfare benefit plan providing medical, vision, prescription drug and dental benefits for eligible participants and their dependents. The Plan also provides life insurance, accidental death and dismemberment and weekly disability benefits with lesser amounts of life insurance for dependents. Medical and prescription drug benefits are provided to retirees who meet enrollment requirements and their eligible dependents. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code (the "Code").

FOR A FULL DESCRIPTION OF THE PLAN, PARTICIPANTS SHOULD REFER TO THE PLAN DOCUMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements have been prepared using the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**C. Cash and Cash Equivalents**

Cash and cash equivalents include checking and a money market mutual fund.

**D. Employer Contributions**

Contributions received subsequent to the end of the fiscal year for March and prior months' hours worked have been accrued. No allowance is provided for uncollectible accounts.

Under the terms of the Collective Bargaining Agreement, employers contribute to the Plan at the following rates:

**E. Investment Valuation and Income Recognition**

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on the trade-date basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting guidance on measuring fair value establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions market participants would use in pricing the asset or liability. The following tables represent the Plan's hierarchy for its financial assets measured at fair value on a recurring basis as of March 31:

Level 1 investments consist of U.S. Treasury notes, mutual funds and exchange traded funds valued based on quoted prices in an active market. Level 2 investments consist of government debt securities and corporate bonds and notes valued based on prices currently available for comparable securities with similar yields, duration and credit quality.

**NOTE 4 - TAX-EXEMPT STATUS**

No provision for income tax is made. The trust established under the Plan is exempt from federal income tax pursuant to Section 501(c)(9) of the Code and from state franchise tax pursuant to California Revenue and Taxation Code Section 23701i. The Board of Trustees believes the Plan is currently designed and is being operated in compliance with the applicable regulations. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - ELIGIBILITY FOR ACTIVE PARTICIPANTS**

Eligibility continues for each month a participant is credited with a minimum of 100 hours of service. Hours in excess of the minimum monthly service requirement are credited to a participant's reserve hour bank, upon which a participant may draw during months when the minimum hours requirement is not met. The reserve hour bank provides a maximum reserve of 600 hours.

The estimated future benefits based on participants' accumulated eligibility reflects the total reserves for all active participants and the estimated funds required to cover them.

**NOTE 7 - CONCENTRATIONS, RISKS AND UNCERTAINTIES**

The Plan maintains its cash in bank accounts with Federal Deposit Insurance Corporation ("FDIC") insurance up to \$250,000 per bank. Deposits may at times exceed the federally insured limit. The Board of Trustees mitigates this risk by placing the Plan's bank accounts with a financial institution the Board believes is credit worthy.

Plan investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in values of investments in the near term could materially affect the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

Benefit obligations are based on certain assumptions pertaining to interest rates, health care trend inflation and demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 8 - RESERVE FOR LIFE INSURANCE BENEFITS FOR DISABLED PARTICIPANTS**

The Plan provides a life insurance benefit to age 62 for participants who incur a total and permanent disability subsequent to August 2, 1979. Participants who became totally and permanently disabled prior to this time are entitled to whole life coverage. The Plan maintained a reserve of \$157,500 and \$165,000, respectively, at March 31, 2025 and in 2024, to fund benefits for participants entitled to whole life coverage under the Plan.

**NOTE 9 - RELATED FUNDS**

The Construction Teamsters for Southern California Trust Funds maintain an account to pay joint administrative costs. Allocations of joint administrative expenses to the Plan, Construction Teamsters Training and Upgrading Fund for Southern California, Construction Teamsters Vacation-Holiday-Sick Trust, Construction Teamsters Contract Compliance Fund for Southern California and Construction Teamsters Apprenticeship Fund for Southern California (the "Trust Funds") are based on percentages periodically agreed upon by the Boards of Trustees. The Plan reimburses the joint account monthly for its share of joint administrative expenses.

**NOTE 10 - POSTRETIREMENT BENEFIT OBLIGATIONS**

Accounting standards require that defined benefit health and welfare plans report postretirement benefits for retired participants including beneficiaries and covered dependents, active and terminated participants who are fully eligible to receive postretirement benefits, and active participants not yet fully eligible for postretirement benefits.

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to March 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation was determined by actuaries for 2025 and 2024 and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used for 2025 (2024), were: (a) Discount Rate: 5.30% (5.05%) per annum, (b) Mortality: the Pri-2012 Total Dataset Amount-Weighted Healthy Annuitant Table, adjusted, (c) Retirement Age: 100% assumed to retire at age 70, (d) Marital Status: husbands assumed to be three years older than wives and 60% of members assumed to be married at retirement, (e) health cost trend: based on the Getzen Model, and (f) other assumptions and methods for retirement rates, mix of type of retiree coverage, trend rates and per capita cost assumptions.

Increasing the discount rate from 5.05% to 5.30% increased the post-retirement benefit obligations by approximately \$1,187,000.

**NOTE 10 - POSTRETIREMENT BENEFIT OBLIGATIONS (Continued)**

The health care cost-trend rate have a significant effect on the postretirement benefit obligations. A 1% increase in the health care cost-trend rate would increase the net postretirement benefit obligation as of March 31, 2025 and 2024 by approximately \$2,914,883 and \$2,617,289, respectively.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

**NOTE 11 - ADMINISTRATIVE FEES**

The Plan paid Zenith American Solutions, Inc. a monthly fee of \$95,980 for administrative and tabulating services.

**NOTE 12 - PLAN TERMINATION**

Although there has been no expressed intent to do so, the Plan may be terminated in accordance with the provisions of ERISA and related regulations. In the event of termination, the balance in the Plan, if any, shall be exhausted by continuing the benefits so long as the cash in the Plan will permit after the payment of all expenses of operating and/or winding up the Plan. Benefits shall be continued for those eligible employees whose names appear on the eligibility list of the Plan for the last month preceding termination of the Trust Agreement. The benefits that shall be continued shall be those provided by the insurance policies, and/or other plan in force as of the last day of the last month prior to the termination of the Trust Agreement. The administration of such benefits shall be under the supervision of the Board of Trustees acting as of such date and shall be in accordance with the terms and provisions of the Trust Agreement.
