Opinion

NOTES TO FINANCIAL STATEMENTS
MARCH 31, 2025 AND 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The Construction Teamsters Vacation-Holiday-Sick Trust (the "Fund") was formed in 1965. The Fund receives contributions from employers and distributes them to the participants in a yearly payout. Contributions for work months September 1 to August 31 are distributed on December 1. The Fund is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code (the "Code").

FOR A FULL DESCRIPTION OF THE PLAN, PARTICIPANTS SHOULD REFER TO THE PLAN DOCUMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

C. Employer Contributions

Employer contributions are made on behalf of covered members as provided under collective bargaining and reported on the accrual basis. Contributions received subsequent to the end of the fiscal year for March and prior months' hours worked have been accrued. No allowance is provided for estimated uncollectible accounts.

D. Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - TAX-EXEMPT STATUS

No provision for income tax is made. The trust established under the Fund is exempt from federal income tax pursuant to Section 501(c)(9) of the Internal Revenue Code and from state franchise tax pursuant to California Revenue and Taxation Code Section 23701i. The plan administrator and its tax counsel believe the Fund is designed, operated and qualifies under the applicable requirements of the Code and related state statutes and that the trust, which forms a part of the Fund, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - UNALLOCATED VACATION FUNDS

Employer contributions in which the contractor does not specify which employees the contributions are made are recorded by the Fund as unallocated vacation funds payable. These contributions, if left unclaimed after two years, are added to the Fund's net assets and used to pay administrative expenses.

NOTE 5 - DUE TO RELATED FUNDS

The Construction Teamsters for Southern California Trust Funds maintain a joint bank account, which pays for all joint administrative expenses. Allocations of the joint administrative expenses to the Fund, Construction Teamsters Security Fund for Southern California, Construction Teamsters Training and Upgrading Fund for Southern California, Construction Teamsters Contract Compliance Fund for Southern California and Construction Teamsters Apprenticeship Fund for Southern California (the "Trust Funds") are based on allocation percentages periodically agreed upon by the Boards of Trustees. Each month the joint account reimburses the joint administrative expenses incurred by these Trust Funds accordingly.

NOTE 6 - FUND TERMINATION

Although there has been no expressed intent to do so, the Fund may be terminated in accordance with the provisions of ERISA and related regulations. In the event of termination, the balance in the Fund, if any, shall be exhausted by continuing the benefits so long as the cash in the Fund will permit after the payment of all expenses of operating and/or winding up the Fund. Benefits shall be continued for those eligible employees whose names appear on the eligibility list of the Fund for the last month preceding termination of the Trust Agreement. The benefits that shall be continued shall be those provided by the Fund in force as of the last day of the last month prior to the termination of the Trust Agreement, and the administration of such benefits shall be under the supervision of the trustees acting as of such date and shall be in accordance with the terms and provisions of the Trust Agreement.

NOTE 7 - ADMINISTRATIVE FEES

The Fund paid Zenith American Solutions, Inc. a monthly administrative service fee of \$10,706 for the years ended March 31, 2025 and 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Fund maintains its cash in interest bearing and non-interest bearing checking accounts with Federal Deposit Insurance Corporation ("FDIC") insurance up to \$250,000 per bank. Deposits may at times exceed the federally insured limit. The Board of Trustees mitigates this risk by placing the Fund's cash accounts with a financial institution the Board of Trustees believes is credit worthy.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through January 13, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
