### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Virginia Garcia Memorial Health Center Tax Sheltered Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended March 31, 2025 and 2024, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

**1. Plan Description**

The following description of Virginia Garcia Memorial Health Center Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan was established September 1, 1993, and most recently restated effective March 1, 2020. The Plan is a defined contribution retirement plan covering all eligible employees of Virginia Garcia Memorial Health Center (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The custodian of the Plan is Charles Schwab Trust Bank (the custodian) and the record-keeper is the Standard Insurance Company (Standard). All participant account balances are held by the custodian. The participant directs the investment of all contributions and earnings thereon and may change their investment directive at any time.

**Eligibility** - All permissible employees of the Plan Sponsor, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. Participation in the Plan begins as soon as administratively feasible on or after the participant's date of hire. Employees who have completed one year of service become participants in the Plan for purposes of receiving employer contributions.

**Contributions** - Each year, participants may make elective salary deferral contributions to the Plan, subject to statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan Sponsor matches participant contributions up to 4 percent of compensation per Plan year. The Plan Sponsor makes an additional contribution of 1 percent to all eligible employees.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching and/or additional contributions and Plan earnings. Deducted from each participant's account are any distributions made to the participant and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant directs the investment of all contributions and earnings thereon, and may change their investment directive at any time.

**Vesting** - Participants are immediately vested in their contributions, the Plan Sponsor's contributions, and actual earnings thereon.

**1. Description of Plan - Continued**

**Notes Receivable from Participants** - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50 percent of their account balance. Only one loan is permitted to be outstanding at a time, and only one loan can be approved for a participant in a 12-month period. Loan terms cannot extend beyond five years from the date of the loan unless the loan is used to acquire the principal residence of the participant. Loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates. Outstanding loans currently bear interest at various rates ranging from 3.25 to 8.50 percent with maturity dates through August 2042. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - Upon attaining normal retirement age of 65 (or with a pre-retirement distribution after age 59½), termination of service, death, or disability, a participant or beneficiary may elect to leave the balance of the account if greater than \$7,000; roll the balance over to another qualified plan or IRA account; receive a lump-sum distribution of the entire vested account balance; or receive installment payments equal to the participant's vested account balance over a period of not more than the participant's assumed life expectancy. In addition, hardship distributions are permitted if certain criteria are met. A participant may withdraw any part of his or her account resulting from rollover contributions, limited to twice per 12-month period.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies - Continued**

**Investment Valuation and Income Recognition** - Investments in shares of registered investment companies are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies using information provided by the custodians. See *Note 4* for discussion of fair value measurements.

Investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for the Plan's investment in a fully benefit responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Investments in the Standard Stable Asset A are considered fully benefit-responsive. See *Note 5* for further discussion of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administration expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 31, 2025 and 2024. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant to be in default, the receivable balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits paid to participants are recorded when paid. At March 31, 2025 and 2024, there were no benefits processed and approved for payment, but not paid.

**Plan Expenses** - Certain expenses of Plan administration were paid directly by the Plan Sponsor and are excluded from these financial statements. Certain other fees related to the administration of the Plan are paid by the Plan and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

**Subsequent Events** - Management has evaluated subsequent events through January 15, 2026, the date the financial statements were available to be issued.

Effective on September 1, 2025, the Plan was amended to add two types of distributions - domestic abuse victim and qualified birth and adoption - and mandatory distributions for separated employees with balances of \$5,000 or less, and to remove the option of survivor annuity distribution as an available type of distribution.

**3. Certified Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including cash, investments, and notes receivable from participants held at March 31, 2025 and 2024, and net change in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, whom management has determined to be a qualified institution.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability. No Level 2 inputs were available to the Plan.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. No Level 3 inputs were available to the Plan.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at March 31, 2025 and 2024.

**4. Fair Value Measurements - Continued**

The following is a description of the valuation methodology used for assets measured at fair value on a recurring basis:

*Registered investment companies* - Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

**5. Guaranteed Investment Contract (Unaudited)**

The Plan's investments held in the Standard Stable Asset A consist of a fully benefit-responsive guaranteed investment contract with the Standard Insurance Company. The Standard Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

The Plan can elect to end its participation in the contract at any time. If the Plan elects to end participation, the Plan will receive the lesser of the guaranteed contract value or market value; if the market value is less than the contract, the Plan may have the option of transferring its investment to a fixed rate, fixed maturity, general account contract of the Standard Insurance Company, in which case the Plan's guaranteed value would be maintained.

**6. Transactions with Parties in Interest**

The Plan sponsor and administrator pays certain administrative costs, including accounting, legal, and consulting fees, on behalf of the Plan.

The custodian of the Plan manages certain Plan investments. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments.

Participants in the Plan are permitted to borrow funds from their vested balance as described in *Note 1*. These transactions qualify as party-in-interest transactions. Notes receivable from participants and the related interest earned are described in *Notes 1 and 2*.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to ERISA provisions. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

**8. Income Tax Status**

The Plan is using a 403(b) volume submitter document and is relying on the volume submitter's opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017. The letter states the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is qualified, and the related trust is tax-exempt. Although the Plan has been amended since receiving the opinion letter, the volume submitter sponsor and the Plan Administrator believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near-term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
