Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### NOTE 1: DESCRIPTION OF PLAN

The following description of The Mast General Store, Inc. 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** – The Plan is a pre-approved savings plan (restated February 1, 2023) covering all employees of Mast General Store, Inc. (Company), who have one year of service with 1,000 service hours and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Each year, participants may contribute up to the statutory limit of annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make discretionary matching contributions for participants who complete 1,000 hours of service and are at least age 21 or older. During 2025 and 2024, the Company contributed an amount equal to 50% of each participant's eligible contributions up to 3% of annual compensation. In addition, the Company may make discretionary profit-sharing contributions. No profit-sharing contributions were made for 2025 and 2024.

**Participant accounts** – Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are immediately vested in their elective contributions plus actual earnings thereon. A participant becomes 100% vested in the Company's contribution portion of the accounts upon death, disability, or attainment of normal retirement age. A participant also becomes vested in the Company's contribution portion of their accounts in accordance with the following vesting schedule:

If a participant terminates employment before their vested interest is 100%, the non-vested portion is forfeited. The forfeited amount is then used to offset the Plan's expenses or employer matching contributions.

***Payment of benefits*** – If a participant ceases to be an employee of the Plan and his or her account balance is less than \$1,000, the entire vested account balance will be payable to the participant or his or her beneficiaries in a single lump-sum payment. Balances greater than \$1,000, but less than \$5,000 are to be rolled over to an individual retirement account, as designated by the Plan, absent an election by the participant. Terminated participant balances in excess of \$5,000 may remain in the Plan until such time the participant elects to receive a distribution. In-service distributions of a participant's vested account balance are allowed for hardships or once the participant reaches age 59.5.

***Notes receivable from participants*** – Participants may borrow from their accounts, a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates of 3.25%-8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

If the participant terminates employment, the loan is immediately due. A loan is considered to be in default if a participant fails to make all or any part of a required payment by the end of the calendar quarter following the quarter in which such payment is due. Outstanding loan balances in default will be treated as outstanding for the purposes of determining any future loan amounts. In the event of default, the outstanding loan balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

### NOTE 2: SUMMARY OF ACCOUNTING POLICIES

***Forfeited accounts*** – At March 31, 2025 and 2024, forfeited non-vested accounts totaled \$0 and \$59, respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. In 2025 and 2024, forfeitures of \$3,483 and \$11,740, respectively, were used to reduce Plan administrative fees. In 2025 and 2024, forfeitures of \$9,741 and \$10,726, respectively, were used to reduce employer contributions paid into the plan.

***Participant investment account options*** – Investment account options available include various funds. Each participant has the option of directing the Company’s contribution to any of the investment accounts and may change the allocation daily.

***Basis of accounting*** – The financial statements of the plan are prepared on the accrual basis of accounting.

***Investment valuation and income recognition*** – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Use of estimates*** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Payment of benefits*** – Benefit payments to participants are recorded upon distribution.

***Notes receivable from participants*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is reported on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

***Expenses*** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from

*Expenses (continued)* – participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Subsequent events* – The plan has evaluated subsequent events through January 14, 2026, the date the financial statements were available to be issued.

**NOTE 3: CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at March 31, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended March 31, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (the trustees of the Plan).

**NOTE 4: PARTY-IN INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association, or relatives of such persons. Certain plan investments are shares of investments managed by Principal, the trustee of the Plan and, therefore, these transactions qualify as party-in interest transactions.

The Plan incurs expenses related to general administration and record keeping. The plan sponsor pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.

**NOTE 5: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **NOTE 6: TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the prototype document adopted by the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not been amended since receiving this letter.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of March 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE 7: SEPARATED PARTICIPANTS**

At March 31, 2025 and 2024, \$1,195,593 and \$1,311,277 of the net assets available for benefits are for those participants who have separated from active service with the Plan Sponsor, respectively.

### **NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### **NOTE 9: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ASC 820, Fair Value Measurements, establishes a framework for measuring fair value and expands disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets and liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025.

*Mutual funds* Valued at the daily closing price reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded

*Pooled separate accounts* Valued at the reported unit value held by the plan at year end, which is derived from the market value of the underlying investments. Net asset value of separate accounts is not publicly disclosed.

**NOTE 10: INVESTMENT CONTRACTS WITH PRINCIPAL**

In 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company (Principal) totaling \$4,909,389 for 2025 and \$4,278,892 for 2024. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will not be less than 1% or greater than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or the Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable or occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.
