Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of March 31, 2025 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the International Brotherhood of Electrical Workers District No. 9 Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document and the Summary Plan Description for a more complete description of the Plan's provisions.

A. General

The Plan is a money purchase defined contribution pension plan. Pension contributions are made to the Plan pursuant to the terms of collective bargaining agreements between various International Brotherhood of Electrical Workers (IBEW) local unions within the IBEW 9th District as one party and employers under contract with the IBEW and other employers that are signatory to participation agreements with the Plan. Certain IBEW local unions and apprenticeship and training trust funds contribute to the Plan on behalf of their employees pursuant to the terms of participation agreements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

- (a) Inception Date – March 1, 1968
- (b) Board of Trustees – Trustees are bonded and serve without compensation except for reimbursed meeting expenses.
- (c) Fidelity Bond – Travelers Casualty & Surety Company Policy No. 106510548, Term: July 1, 2022 to July 1, 2025 – Coverage Amount: \$1,000,000.

B. Participant Accounts

Each Participant's account is credited with an allocation of the employer's contributions and Plan earnings. A Participant's account is reduced by general administration, recordkeeping, investment management fees and commission charges. Commission charges reduce the investment returns by a fraction of a percentage and these charges are not reflected on the Participant's account. The Participant statement only indicates the net return and the benefit to which a Participant is entitled as the benefit that can be provided from the Participant's account. Effective December 1, 2021, the participant fee decreased from \$55 per year to \$48 per year. An additional administrative expense is annually deducted from each Participant's account equal to 0.05% of their account balance, which remained unchanged in 2025 and 2024. 1/12th of the fees are deducted monthly. Assessed fees for the years ended March 31, 2025 and 2024 total approximately \$1,289,000 and \$1,572,000 respectively.

Participant accounts are credited with actual earnings on the underlying investments and charged for Plan withdrawals and administration expenses. Administration expenses include charges for legal fees, employer compliance audits, plan audit, contract administrator, fidelity bond and fiduciary liability insurance and other general administrative expenses.

In accordance with the Plan Document, deceased participants or beneficiary's unclaimed participant accounts are removed from the participant accounts and held in a forfeiture account until the participant account is claimed. The balance of the forfeiture account was approximately \$400 and \$40,900 as of March 31, 2025 and 2024, respectively.

C. Payment of Benefits

The Participant may receive retirement benefits in one or a combination of the following forms:

C. Payment of Benefits (Continued)

- (a) Lifetime annuity payable over the life expectancy of the Participant.
- (b) Installments over a stated period of time - 5, 10, 15 or 20 years - or the life of the annuitant, if later.
- (c) A single sum payment or distribution.
- (d) A qualified joint and survivor annuity with the annuitant limited to the Participant and surviving spouse.
- (e) A flexible income option based on the Participant's life expectancy with any remaining balance upon death of the Participant payable to the Participant's beneficiary. The retired Participant maintains control of his or her account or accounts under the flexible income option.

D. Contributions

Employers contribute a pre-determined amount monthly to the Plan, pursuant to their collective bargaining and participation agreements for employees covered by these agreements. The Plan does not accept contributions from Participants, except for amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers). Minimum funding requirements have been met.

E. Reciprocal Payments

Contributions collected from employers, on behalf of employees that are participants in other electrical pension plans, are paid to the applicable pension plan under the terms of the IBEW Reciprocity Agreement.

The Plan also receives reciprocity payments from other pension plans on behalf of Plan participants working for employers under the terms of the IBEW Reciprocity Agreement. Reciprocity pension contributions receivable is included with contributions receivable from employers in the statements of net assets available for benefits.

F. Vesting

Participants are immediately vested at 100% for all contributions, rollovers and earnings.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Board of Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

C. Investment Valuation and Income Recognition (Continued)

Unrealized appreciation or depreciation in the fair value of investments is reported as net unrealized appreciation of investments. Investment income, realized gains and losses on sale of investments, and other investment income and expenses are reported on the accrual basis.

The Plan has a policy to structure its financial assets to be available as its general expenditures, liabilities and other obligations come due.

D. Employer Contributions

Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the period. Employer contributions receivable is estimated based on contributions received subsequent to the end of the period. No allowance is provided for uncollectible accounts.

E. Payroll Compliance Program

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

F. Payment of Benefits

Benefits are recorded when paid.

G. Subsequent Events

The Board of Trustees has evaluated subsequent events, January 8, 2026, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.

NOTE 3 - INFORMATION CERTIFIED BY THE CUSTODIAN

The Board of Trustees has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at March 31, 2025 and 2024 and investment income for the years then ended that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Board of Trustees and certified as complete and accurate by the Principal Trust Company, the custodian of the Plan.

NOTE 4 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is invested in an investment contract with the Principal Life Insurance Company (Principal). Principal maintains the contributions in guaranteed interest accounts. The accounts are credited with earnings on the underlying investments and charged for Participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed interest contracts are a Flexible Investment Annuity Group Contract (FIA) for defined contribution plans that offer a guaranteed

interest amount that provides a guaranteed interest rate for a specified period of time as determined, or allowed, by the Plan. The rate credited is the rate in effect on the day when each deposit is directed to the account. To simplify reporting to plan participants, all rates credited during the 12-month "deposit year" are averaged into a single composite rate. The Plan chose the 12-month period for deposit year, which is the same as the Plan year. Expenses and guarantee periods are based on deposit years.

The guaranteed interest contracts promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the guaranteed interest contracts are considered not fully benefit responsive. Fair market value is the amount participants would receive if they were to withdraw or transfer funds within the Plan prior to their maturity. Fair market value represents contract value adjusted to reflect current market interest rates, but only to the extent such market rates exceed crediting rates.

NOTE 5 - INCOME TAX STATUS

The trust was established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(a) of the Internal Revenue Code (the "Code") and accordingly, the trust's net investment income is exempt from federal income taxes. The Plan obtained its latest determination letter on May 29, 2015, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Board of Trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although the Board of Trustees has not expressed any intent to do so, the Board of Trustees has the right to terminate the Plan at any time subject to the provisions of ERISA.

NOTE 7 - RISKS AND UNCERTAINTIES

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan maintains cash balances in repurchase agreement sweep funds in Wells Fargo Bank. Such balances are not insured by the Federal Deposit Insurance Corporation (FDIC). The Plan has not incurred any losses on the uninsured balances.

NOTE 8 - RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by the custodians; therefore, these transactions qualify as party-in-interest transactions.

The Plan utilizes an ERISA Budget account maintained by the custodian to pay administrative expenses. The balance of the ERISA Budget account included in Plan assets as of March 31, 2025 and 2024 were approximately \$1,783,000 and \$1,775,000, respectively.

NOTE 9 - ERISA EXPENSE ACCOUNT

The Plan's ERISA Expense Account is used to hold participant account fees, offset by plan expenses paid out of this account. ERISA Expense Account (cash basis) income and expenses for the year ended March 31, 2025 are as follows:
