Independent Auditor's Report

To the Trustees and Participants of
Labor Alliance Managed Trust Fund:

Opinion

We have audited the financial statements of Labor Alliance Managed Trust Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and benefit obligations and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits as of March 31, 2025 and 2024, and the changes in net assets available for benefits and benefit obligations and changes in benefit obligations for the years then ended of Labor Alliance Managed Trust Fund in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Notes to Financial Statements

March 31, 2025 and 2024

1. Description of Plan

The following description of Labor Alliance Managed Trust Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer plan that was established under the terms of an Agreement and Declaration of Trust dated March 1, 1995, between certain employers and various unions affiliated with the International Brotherhood of Teamsters. The Plan was restated effective January 1, 2018. To be eligible, an employee must be working for a participating employer who is subject to the collective bargaining agreement ("CBA") or for a participating employer subject to a trustee approved participation agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board consisting of equal representation from the participating employers and various unions.

Eligibility

Generally, a participant is eligible on the first day of the month following the month in which he or she works the required hours or is actively employed and the employer makes the required contributions to the Plan.

Benefits

Benefits of the Plan include medical, dental, life, accidental death and dismemberment, chiropractic, prescription drug, and vision care.

Participants may elect medical coverage through Kaiser Foundation Health Plan, United Healthcare, or Sistemas Medicos Nacionales.

Participants may elect dental coverage through United Concordia, United Healthcare, or Liberty Dental.

Life insurance and accidental death and dismemberment benefits are provided through a group insurance contract with Prudential Life Insurance Company of America.

The Plan has contracted with PhysMetrics to provide chiropractic benefits through an administrative services contract. On a monthly basis, the Plan pays for any claims submitted by participants. An administrative fee is paid to PhysMetrics for administrative services provided.

Vision benefits are provided through contracts with Vision Service Plan.

Continuation of healthcare benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation act ("COBRA"), has been adopted by the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Labor Alliance Managed Trust Fund Notes to Financial Statements March 31, 2025 and 2024

Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of benefit obligations.

Operating Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net investment income.

Benefit Obligations

Premiums payable and accumulated eligibility credits were calculated based upon the estimated premiums due for March and prior coverage and for coverage based upon work performed through March 31.

The Plan provides benefits to retirees for the current month's coverage upon receipt of payment of the full contribution amount. The Plan has no postretirement benefit obligations because the Plan does not subsidize benefits for retirees, and no promise has been made that retiree benefits will be provided beyond the current month and for the current month only when a full contribution has been received by the Plan.

Employer Contributions and Related Receivables

The Plan's policy is to recognize contributions based on the latest executed CBA on an individual employer basis. Contributions from participating employers are based on a rate per month for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received. Management of the Plan evaluates participating employer contributions receivable periodically for potential uncollectible amounts based on factors related to specific employers or groups of participants' ability to pay and current and future economic trends and conditions. As of March 31, 2025 and 2024, no allowance for credit losses was deemed necessary.

Retiree and Participant Contributions

Retiree and participant contributions are recorded in the month collected and include amounts remitted directly by retirees and participants for coverage months during the years ended March 31, 2025 and 2024.

Subsequent Events

Subsequent events were evaluated through January 6, 2026, the date the financial statements were available to be issued.

3. Funding Policy

The Plan is financed by employer and retiree contributions and from participants electing COBRA coverage. The monthly contribution rates are established by the Trustees based upon recommendations by the Plan's consultant.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at March 31, 2025 and 2024.

Short-term investments: The fair value of short-term investments is based on cost, which approximates fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Related-Party and Party-In-Interest Transactions

Employer contributions for both the Plan and Labor Alliance Savings Trust Fund (the "Savings Trust"), an affiliated plan, are deposited together in a lockbox bank account sponsored by the Plan. The amount due to the Savings Trust is calculated and transferred monthly.

The Plan is jointly administered with the Savings Trust. Certain joint expenses are paid by the Plan, and a portion is reimbursed by the Savings Trust. During the years ended March 31, 2025 and 2024, the Plan received \$33,974 and \$28,976, respectively, from the Savings Trust.

6. Priorities Upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Trustees by a letter dated September 29, 1995, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has evaluated the tax positions taken by the Plan and concluded that, as of March 31, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing and regulatory jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan maintains its cash at one financial institution. The balance is insured by the Federal Deposit Insurance Corporation for up to \$250,000. Cash balances may at times exceed the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition.
