Opinion

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Labor Alliance Savings Trust Fund's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Labor Alliance Savings Trust Fund's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Labor Alliance Savings Trust Fund's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Labor Alliance Savings Trust Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is administered by the Board of Trustees of Labor Alliance Savings Trust Fund for the purpose of providing supplemental retirement savings to individual eligible participants. The Plan was established under the terms of an Agreement and Declaration of Trust dated March 1, 1995, between certain employers and certain local unions affiliated with the International Brotherhood of Teamsters. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retire Income Security Act of 1974 ("ERISA"), as amended.

The Plan is a supplemental retirement savings program in conjunction with Labor Alliance Managed Trust Fund (the "Managed Trust"). Participants who provide adequate proof of alternative medical insurance may waive their right to participate in the medical portion of the Managed Trust and a portion of the employer medical contributions are directed to the savings plan.

Investment Options

Plan participants may direct their plan account balance into participant-directed investment options. Participants can invest in various mutual funds and a collective investment trust. Participants' future contributions will also be directed into these accounts. Participants may change their investment options on a daily basis. If participants do not make investment elections, contributions to the Plan are allocated based on the Plan's qualified default investment alternative set forth by the Trustees of the Plan. Participants should refer to the Summary Plan Description for more information.

Participant Accounts

Participant accounts are credited with contributions made on their behalf and earnings on the investments in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

The savings contributions is 100% vested and, therefore, there will be no forfeitures.

Payment of Benefits

A participant may receive the total value of their account only upon retirement (generally when the participant attains age 55), death, disability, termination of employment, or as otherwise described in the plan document.

Unallocated Accounts and Participant-Directed Investments

All investments are participant directed. The Plan also maintains a separate non-participant-directed cash balance, including other receivables and payables, which totaled \$54,574 and \$70,350 as of March 31, 2025 and 2024, respectively, and is used to provide liquidity to pay administrative expenses and act as a reserve for unusual expenses.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Employer Contributions and Related Receivables

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement ("CBA") on an individual employer basis. Contributions from participating employers are based on a monthly rate for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received. Management of the Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on factors related to specific employers' or groups of participants' ability to pay, and current and future economic trends and conditions. As of March 31, 2025 and 2024, no allowance for credit losses was deemed necessary.

Subsequent Events

Subsequent events were evaluated through January 6, 2026, the date the financial statements were available to be issued.

3. Risks and Uncertainties

The Plan invests in mutual funds and a collective investment trust. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at March 31, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The Great Gray Collective Investment Trust II ("Great Gray Trust") is a common collective trust that invests in fully benefit-responsive investment contracts. The fair value of the Great Gray Trust has been estimated by the insurance company using the NAV of the investments as a practical expedient. The Great Gray Trust invests in Metropolitan Life Insurance Company fully benefit-responsive insurance contracts. This investment is a direct filing entity with the Department of Labor; therefore, information regarding the investment strategy is not disclosed. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a 60-day redemption notice to liquidate its entire share in the Great Gray Trust. The Plan will receive the lesser of the guaranteed value or the market value when terminating this investment as an option in the Plan.

5. Related-Party and Party In Interest Transactions

Employer contributions for both this Plan and the managed Trust, an affiliated plan, are deposited together in a lockbox bank account sponsored by the Managed Trust. Employer contributions due to the Plan are calculated and transferred monthly. The Plan is jointly administered with the Managed Trust. Certain joint expenses are paid by the Managed Trust, and a portion is reimbursed by the Plan. During the years ended March 31, 2025 and 2024, the Plan reimbursed the Managed Trust \$33,974 and \$28,976, respectively.

6. Priorities Upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, the right to discontinue the Plan is reserved to the Trustees. Termination shall not permit any part of the Plan assets to be used for, or diverted to, purposes other than the exclusive benefit of the participants and beneficiaries of the Plan. In the event of termination or partial termination, each affected participant shall receive a total distribution of their account in accordance with the plan document.

7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Trustees by a letter dated November 19, 2015, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has evaluated the tax positions taken by the Plan and concluded that, as of March 31, 2025, and 2024, there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine audits by taxing and regulatory jurisdictions; however, there are currently no audits for any tax periods in progress.
