Opinion

We have audited the financial statements of California Correctional Peace Officers Association Benefit Trust Fund Welfare Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974, which comprise the statements of net assets available for benefits and benefit obligations as of March 31, 2025 and 2024; and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended; and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of California Correctional Peace Officers Association Benefit Trust Fund Welfare Benefit Plan as of March 31, 2025 and 2024, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The accompanying financial statements of California Correctional Peace Officers Association Benefit Trust Fund Welfare Benefit Plan (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions, and Income Recognition

General - Investments are carried at fair value, which is determined, presented, and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods: In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan's investment classes are presented below:

Mutual Funds - The fair value of mutual funds is based on quoted market prices in active markets (Level 1).

Valuation Methods, Consistency: The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition: Purchases and sales of securities are recorded on a trade-date basis. Dividend and interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Property and Equipment

Property and equipment are stated at cost. Depreciation is computed on the straight-line basis over estimated useful lives. Furniture and equipment are depreciated over five to seven years, computers and software are depreciated over three to five years, and building and improvements are depreciated up to 30 years.

Defined Benefit Pension Plan

The Plan accounts for its pension liabilities in accordance with FASB ASC 715, *Compensation - Retirement Benefits*. FASB ASC 715 requires employers to (a) recognize the overfunded or underfunded status of a single-employer defined benefit post-retirement plan as an asset or liability in its statements of net assets available for benefits and to recognize changes in that funded status in the year in which the changes occur, and (b) measure the funded status of a plan as of the date of its year-end statements.

Benefit Obligations

Premiums payable were calculated based upon the estimated premiums due for March and prior coverage. Claims payable and incurred but not reported were calculated on the basis of claims incurred through March 31, in accordance with eligibility provisions and estimated based upon statistical lag analysis studies.

Participant Contributions

Contributions reported in the financial statements relate to participants who are on the payroll as of the first day of each month through March 1. These contributions provide coverage for participants to the last day of the month in which they are reported.

In addition, active and retired participants, who are members of the California Correctional Peace Officers Association ("CCPOA"), may elect to make voluntary contributions by payroll deductions for supplementary dental, vision and hearing aid, life, and family legal coverage. The effective date for voluntary benefits is generally upon receipt of premium and the participant's eligibility for coverage.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investments. Such investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Leases

The Plan categorizes leases with contractual terms longer than twelve months as either operating or finance. Finance leases are generally those leases that allow us to substantially or pay for the entire asset over its estimated life. All other leases are categorized as operating leases. Leases with contractual terms of 12 months or less are not recorded on the statements of net assets available for benefits. The Plan had no finance leases during the years ended March 31, 2025 and 2024.

2. DESCRIPTION OF THE PLAN

General

The Plan was established on April 12, 1987, for the purpose of providing benefits under the terms of an agreement between the Board of Directors of the CCPOA and the Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Eligibility

The benefit programs are generally available to the following groups of individuals and their eligible dependents:

- a) Full-time permanent employees and permanent intermittent employees of the State of California Bargaining Unit 6 who are members in good standing of CCPOA;
- b) Employees of CCPOA;
- c) Employees of CCPOA Benefit Trust Fund; and
- d) Members in good standing of the Retiree Chapter of CCPOA.

Generally, a participant is initially eligible to receive benefits on the first day of the calendar month immediately following the date payroll deduction commences.

Benefits

All actively employed Bargaining Unit 6 State of California employees who are, in part, members of CCPOA are eligible for family legal benefits. Retirees who are members in good standing of the retiree chapter of CCPOA are also eligible for coverage. Participants elect their benefit coverage and pay any premium amount in excess of the employer contributions. The coverage continues on the first day of each month.

Claim payments and insurance premium payments are recorded when paid. These payments are recorded as insurance premiums and self-funded benefits paid in the accompanying statements of changes in net assets available for benefits.

Service Fees

The Plan provides various administrative services for various insurance providers used in this and other related CCPOA plans. The Plan has contracts with each of these insurance providers to receive compensation for these services.

Participants should refer to the Summary Plan Description and Plan Document for more complete information.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets may be allocated among participants and beneficiaries in the manner determined by the Board of Trustees and in accordance with applicable law or transferred to a plan operated by an Internal Revenue Code Section 501(9)(c) trust providing similar benefits. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The voluntary employees' beneficiary association ("VEBA") trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service ("IRS") dated February 24, 1986, stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code ("IRC"). The VEBA trust has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan continues to operate in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of March 31, 2025 and 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. CONCENTRATION OF CASH

The Plan maintains its cash at one financial institution. The balance is insured by the Federal Deposit Insurance Corporation for up to \$250,000. Cash balances may at times exceed the insured deposit limits. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations and cash flows.

6. FUNDING POLICY

The Plan is financed primarily by participant contributions on a monthly basis by payroll deduction.

8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan shares common governance with related organizations, including California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan (the "Supplemental Plan"), California Correctional Peace Officers Association Disability Plan (the "Disability Plan"), California Correctional Peace Officers Association Legal Defense Fund (the "Legal Plan"), and California Correctional Peace Officers Association Medical Plan (the "Medical Plan").

The Plan pays general and administrative ("G&A") expenses on behalf of the other related CCPOA plans. The other related plans reimburse the Plan an estimated amount monthly. The Plan performs an annual allocation based upon the actual time the Plan employees spend on behalf of the other related CCPOA plans. During the years ended March 31, 2025 and 2024, the other related CCPOA plans owed the Plan \$429,868, and \$327,222, respectively. During the years ended March 31, 2025 and 2024, the other related CCPOA plans reimbursed the Plan administrative expenses totaling \$5,881,162 and \$5,454,195, respectively.

The Plan is also reimbursed by the California Correctional Peace Officers Association Legal Defense Fund (the "Legal Defense Fund") for legal administrative expenses on behalf of the Legal Defense Fund. The total amount received by the Plan from the Legal Defense Fund totaled \$449,626 and \$314,349 for the years ended March 31, 2025 and 2024, respectively.

The Plan provides administrative services with respect to the self-funded medical benefits of the California Correctional Peace Officers Association Benefit Trust Fund Medical Plan ("Medical Plan"). Funds are received by the Medical Plan based on a contract with Blue Shield at \$3 per participant per month. The Medical Plan reimburses the Plan monthly with these monies, and the amounts are reflected in service fee revenue totaling \$461,100 and \$470,223 for the years ended March 31, 2025 and 2024, respectively.

The Plan provides administrative services with respect to family legal plan insured benefits of the California Correctional Peace Officers Association Benefit Trust Fund Supplemental Benefit Plan (the "Supplemental Plan"). The Supplemental Plan reimburses the Plan at a rate of \$0.20 per participant per month, and the amounts are reflected in service fee revenue totaling \$70,416 and \$70,958 for the years ended March 31, 2025 and 2024, respectively.

9. PENSION PLAN CONTRIBUTIONS

401(k) Savings Plan

The Plan contributes 6% of Plan employees' gross salaries into a 401(k) savings plan. During the years ended March 31, 2025 and 2024, the Plan contributed \$192,681 and \$185,126, respectively.

Defined Benefit Plan

During the year ended March 31, 2004, the Plan began contributing to a defined benefit pension plan (the "Pension Plan") on behalf of all employees under contractual agreements. During the years ended March 31, 2025 and 2024, the Plan contributed \$1,406,565 and \$1,406,144, respectively, to the Pension Plan.

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service that participants have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated participants or their beneficiaries, (b) beneficiaries or participants who have died, and (c) active participants or their beneficiaries.

The actuarial present value of accumulated benefits is determined by the Plan's actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest), and the probability of payment by means of reductions such as for death, disability, withdrawal, or retirement, between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation performed by the actuary at March 31, 2025 and 2024, the most recent valuation, were (a) rate of compensation increase (assumed at 3% per annum); (b) investment return (assumed at 6% per annum); and (c) discount rate at 5.40% and 5.10% per annum as of March 31, 2025 and 2024, respectively. The foregoing actuarial assumptions were based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024.

Money market deposit accounts are valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds are deemed to be actively traded.

Exchange-traded funds are valued at fair value based on the NAV of units held in the funds. The NAV is based on the observable market prices of the underlying investments within the fund, less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of the fair value and is the basis used by the fund for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
