We have performed an audit of the financial statements of Gala Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2021 financial statements).

December 31, 2021

Note 1. Plan Description

The following description of the Gala Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of GALA North America Inc. (the “Company”) who are at least twenty-one years of age. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2021, the Plan document was restated to change the Plan name from Korona Candles 401(k) Plan to Gala Group 401(k) Plan.

Contributions

Each year, participants may contribute up to 100 percent of their annual compensation as pretax or Roth deferrals, as defined by the Plan document, subject to *Internal Revenue Code (IRC)* limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company makes a required safe harbor matching contribution of 100% of eligible compensation deferred, as defined by the Plan, up to 3% and 50% on deferrals between 3% and 5%. The Company may make profit sharing contributions at its discretion. Employees are eligible for profit sharing contributions once they have attained one year of service with a minimum of 1,000 hours. For the Plan year ended December 31, 2021, no profit sharing contributions were made. Contributions are subject to certain limitations.

Effective September 1, 2020, the Plan document was amended to remove the twelve-month service requirement for participant contributions. Effective January 1, 2021, the Plan document was restated to replace a discretionary employer match formula with the safe harbor basic formula described above.

Participant accounts

Each participant’s account is credited with the participant’s contributions, the Company matching contributions, allocations of the Company’s discretionary profit sharing contributions, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion, plus actual earnings thereon, is based on years of service, as defined. A participant is fully vested after six years of credited service.

Payment of benefits

Upon termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump sum amount. In-service withdrawals are available upon demonstration of financial hardship or after participants reach 59 ½ years of age.

Forfeitures

At December 31, 2021 and 2020, forfeited non-vested accounts totaled \$6,055 and \$7,006, respectively. These accounts may be used to pay administrative expenses or reduce Company contributions. During 2021, forfeitures of \$5,374 were used to pay administrative expenses. During 2021, no forfeitures were used to reduce Company contributions.

Administrative costs

The Plan's administrative expenses are paid by either the Plan Participant or the Company on a discretionary basis.

Note 2. Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Valuation of investments and revenue recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a full discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3. Fair Value Measurements

The Plan's mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Note 4. Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan investments were managed by Ascensus Trust Company, Trustee, during the year ended December 31, 2021, and therefore, these transactions are considered to be related party transactions. Fees paid by the Plan to the Trustee for investment management and record-keeping services for the year ended December 31, 2021 were \$6,493.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Tax Status

Effective January 1, 2021, the Plan adopted a nonstandardized pre-approved profit sharing plan sponsored by Ascensus, LLC which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. The Plan has been restated since receiving the determination letter. However, the Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the *IRC* and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2021, there are no uncertain positions taken or expected to be taken by the Plan that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8. Subsequent Events

Subsequent events have been evaluated through December 19, 2025, the date the financial statements were available to be issued.

During March 2022, a partial plan termination occurred due to layoffs within the Dublin, Virginia facility of the Plan Sponsor. Accordingly, the unvested amounts in participants’ accounts who have terminated employment with the Company as a result of the layoffs during 2022 became fully vested.

Effective March 31, 2024, the Plan document was restated in accordance with regulatory updates.

Effective April 6, 2024, all facilities in the United States closed due to financial difficulties of the Plan Sponsor. Accordingly, the unvested amounts in participants’ accounts who have terminated employment with the Company as a result of the shutdown during 2024 should have become fully vested. Vested amounts remain in participants’ accounts, and the Plan has not yet been terminated.

Effective June 30, 2025, the Plan Sponsor formally resolved to liquidate GALA North America Inc. in 2025.
