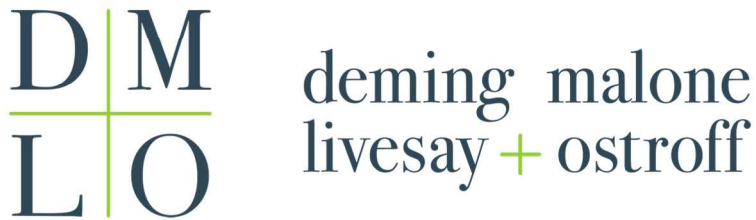

## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of voestalpine Roll Forming Corporation 401(k) Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of voestalpine Roll Forming Corporation 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. **NOTES TO FINANCIAL STATEMENTS**

**Note 1. Plan Description**

The following description of the voestalpine Roll Forming Corporation 401(k) Savings Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General:**

The Plan is a defined contribution plan covering substantially all employees of RFC LLC, RFC-Sharon LLC, voestalpine USA LLC, and voestalpine Automotive Components Cartersville LLC (Employers).

An employee's initial eligibility period in order to make contributions to the Plan and receive employer matching contributions is the first day of the month following 60-days of employment with no minimum hours of service requirement. An employee's initial eligibility period in order to receive employer elective contributions is the consecutive twelve-month period, commencing on the date the employee first performs an hour of service in the year he/she completes 1,000 hours of service. An employee who has completed their eligibility period and attained age 18 shall become a participant as of the following: for employer matching contributions – the first day of the month coinciding with or next following the date on which the employee meets the eligibility requirements; for employer elective contributions – the January 1 or July 1 immediately following the completion of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:**

The Plan is funded by both discretionary employer and participant contributions. Participants may contribute up to 100 percent of pre-tax annual compensation as defined in the Plan. Effective January 1, 2022, all eligible employees (including those hired prior to January 1, 2008) who were not deferring an amount to the Plan, were automatically enrolled at 3% of compensation, unless the employee elected otherwise. The initial automatic deferral amount increases by 1% per year up to a maximum elective deferral of 6% of compensation.

Participants are also eligible to make Roth deferral contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

## NOTES TO FINANCIAL STATEMENTS

Effective January 1, 2022, the Plan converted to a safe harbor plan. The employer matching contribution equals 100% of a participant's contributions that do not exceed 1% of participant compensation, plus 50% of the participant's contributions exceeding 1% but not 6% of the participant's compensation.

In addition, the Employers may make discretionary contributions to the Plan from their net profits for the year. This contribution is allocated to individual participant accounts using calculations based on each participant's compensation relative to the total compensation of all participants. There were no discretionary contributions from net profits for the years ended December 31, 2024 and 2023.

### **Participant accounts:**

Each participant's account is credited with the participant's contributions and employers' matching contribution, as well as allocations of the employers' elective contribution from net profits and plan earnings. Allocations are based on participant earnings, compensation, or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Payment of benefits:**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or periodic monthly, quarterly or annual installments over a fixed period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

### **Vesting:**

Participants are immediately vested in all employee voluntary contributions and transition benefit contributions paid in 2005 to 2009 plus actual earnings thereon. Participants are also immediately vested in employer matching contributions made in years prior to and including 2021. Effective January 1, 2022, participants are 100% vested in employer safe harbor matching contributions after two years of service. Vesting in the employer discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service according to the following schedule:

## NOTES TO FINANCIAL STATEMENTS

### **Forfeited accounts:**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,761 and \$6,004, respectively. Forfeited amounts are used to reduce future employer matching contributions. In 2024 and 2023, \$113,949 and \$125,781 were used to reduce employer contributions, respectively.

### **Note 2. Summary of Significant Accounting Policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

#### **Basis of accounting:**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment valuation and income recognition:**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investments advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions:**

Contributions from Plan participants and matching contributions from the Employers are recorded in the year in which the employee contributions are withheld from compensation.

## NOTES TO FINANCIAL STATEMENTS

### **Payment of benefits:**

Benefits are recorded when paid.

### **Expenses:**

Certain expenses of maintaining the Plan are paid directly by the Employers and are excluded from these financial statements. The Employers pay directly any other administrative expenses related to the Plan's operations.

### **Subsequent events:**

The Plan has evaluated subsequent events through August 11, 2025, which is the date the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active or inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTES TO FINANCIAL STATEMENTS

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Assets have been valued using a market approach. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds – valued at the daily closing price as reported by the fund.

Common/collective trust funds – valued at the net asset value (NAV) of units held by the Plan at year end. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTES TO FINANCIAL STATEMENTS

### **Investments measured using net asset value per share practical expedient:**

The common/collective trust fund has no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' net asset value. The NAV is updated daily. The common/collective trust fund has an investment objective to maximize current income while maintaining principal.

### **Note 5. Income Tax Status**

The Plan is a prototype plan offered by ADP, LLC. The ADP, LLC prototype plan obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service (IRS) stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the participants would become 100 percent vested in their employer contributions.

### **Note 7. Related Party and Party in Interest Transactions**

Certain plan investments are units of a common/collective trust fund managed by Reliance Trust Company. Reliance Trust Company is the trustee and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid to the record-keeper and investment advisor totaled \$163,468 and \$179,183 during 2024 and 2023, respectively.

Certain administrative functions are performed by officers or employees of the Employers. No officer or employee receives compensation from the Plan.

## NOTES TO FINANCIAL STATEMENTS

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
