## INDEPENDENT AUDITORS' REPORT

To the Trustees of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Trinity Academy 401(k) Plan, an employee benefits plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years ended June 30, 2025 and 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

June 30, 2025 and 2024

1. DESCRIPTION OF PLAN

The following description of the Trinity Academy (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General.** The Plan is a defined contribution plan. Employees who are at least 20 years old can elect to become active participants in the Plan upon hire. Three percent of an eligible employee’s compensation will be automatically withheld and contributed to the plan as an elective deferral if the employee does not make an affirmative deferral election. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may make voluntary contributions to the Plan from 1% to 100% of their compensation up to the maximum allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct investment of their accounts into various investment options offered by the Plan. The Company has the option to contribute a discretionary amount of matching contributions to the Plan. Additional amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations.

**Participant Accounts.** Each participant’s account is credited with the participant’s contribution, an allocation of the Company’s contribution, Plan earnings and are charged with an allocation of administrative expenses. Allocations are based on participant contributions, compensation, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are immediately vested in their contributions and the Company’s safe harbor contributions plus actual earnings thereon.

**Payment of Benefits.** Upon termination of service, death, disability or retirement a participant may receive a lump-sum payment. However, if the participant’s vested interest in his or her account does not exceed \$5,000, a lump sum distribution will be made. If the participant’s vested interest in his or her account is greater than \$1,000, but does not exceed \$5,000, an automatic distribution can be made as a direct rollover to an individual retirement plan.

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Payment of Benefits**

Benefits are recorded when paid.

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which is recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

The Plan's Voya Fixed Account is held in a benefit-responsive guaranteed investment contract. The fair value of this investment is determined by contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

The Plan's investments in pooled separate accounts are stated at fair value. The Value of each pooled separate account is determined at the close of each business day based on market value. The value of the Account is expressed in "units". The "unit Value" is the dollar value of one unit and is determined at the close of each business day by dividing the value of the entire Account by the total number of units in the Account. See Note 7 for discussion of fair value measurements.

Contributions to the Account increase the number of units. Withdrawals from the Account decrease the number of units. The increase or decrease in number of units is determined by dividing the amount of the contribution or withdrawal by the unit value for the day the transaction is made. The value of the customer's account on any date is determined by multiplying the number of units held by the unit value at the close of the business day.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. ADMINISTRATION OF PLAN

Certain administrative functions are performed by employees of the Company. No employee receives compensation from the Plan. Some administrative expenses for the Plan are paid directly by the Company.

4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan paid recordkeeping fees to the plan custodian of \$815 and \$1,480 for the years ended June 30, 2025 and 2024, respectively. The Plan has various service providers and these providers are considered parties in interest.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan's investments are held in a bank-administered trust fund. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Voya Retirement Insurance and Annuity Company the custodian.

**7. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (FASB) pronouncement, Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

At June 30, 2025 and 2024, all the Plan's investments were in custodian pooled separate accounts except for the Voya Fixed Account which was held in an investment contract. As required by ASC 820, the Plan's investments except the investment contract were valued using Level 2, which refers to quoted prices for similar assets or liabilities in active or non-active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**8. INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY**

The Plan entered into a benefit-responsive guaranteed investment contract with Voya totaling \$4,228 and \$4,165 in 2025 and 2024, respectively. Voya maintains participant contributions in the Voya Fixed Account, which is a part of the general account of Voya. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

9. TAX STATUS

The Plan has adopted the prototype plan of Compensation Benefit Planning, Inc. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

11. SUBSEQUENT EVENTS

Management has evaluated all subsequent events since June 30, 2025 through December 24, 2025, the date of the independent auditor's report. There have been no subsequent events that would require changes to the accompanying financial statements or disclosures therein.
