#### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Krispy Krunchy Foods LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

##### ***General***

Effective Month January 1, 2021, Krispy Krunchy Foods LLC (the "Company" or "Plan Sponsor") established the Plan as a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

##### ***Plan Administration***

The Plan engages Vanguard Group Inc. who subcontracts recordkeeping services to Ascensus Group, Inc. and trustee services to Ascensus Trust Company ("Trustee").

##### ***Eligibility***

All employees of the Company, except for leased employees, are eligible to participate in the Plan after attaining 21 years of age and completing six consecutive months of eligible service beginning on the participant's date of hire. Entry into the plan occurs on the first day of the month when the participant meets the age and service requirements.

##### ***Contributions***

Each year, participants may contribute up to 100% of their eligible compensation, as defined by the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. Participants may make pre-tax and Roth contributions to the Plan, subject to limits as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified defined contribution and defined benefit plans. The Plan provides for a safe harbor Company contribution of 100% of the first 3% of elective deferrals and an additional 50% match of the next 2% of elective deferrals. The Plan also provides for a discretionary profit-sharing Company contribution. During the year ended December 31, 2024, the Company did not make discretionary profit-sharing Company contributions to Plan participants.

##### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions and Plan earnings. Participant accounts are charged with withdrawals, Plan losses and allocations of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants are immediately vested in their contributions and safe harbor Company contributions, plus actual earnings or losses thereon. Vesting in the discretionary profit-sharing contribution portion of their account is based on years of continuous service and is as follows:

0% when less than one year,  
33% after one year,  
66% after two years, and  
100% after 3 years.

***Payment of Benefits***

Upon termination of service, retirement, death or total permanent disability, a participant may elect to receive a distribution of their entire accumulated account balance, subject to the terms of the funding vehicles. Distribution options include lump-sum payments and partial payments. The Plan allows in-service withdrawals upon attainment of age 59½ and normal retirement age, and in certain circumstances, hardship withdrawals are permitted. Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

***Use of Estimates***

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investments Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator and the Trustee determine the Plan's valuation policies utilizing information provided by the investment managers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to participant accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**NOTE 3 - CERTIFIED INFORMATION**

The Plan Administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, as of and for the year ended December 31, 2024, Ascensus LLC, an authorized representative and agent of Ascensus Trust Company and Newport Trust Company, LLC, has certified the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

US GAAP establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 - TAX STATUS**

The Plan utilizes a non-standardized pre-approved profit-sharing plan with cash or deferred arrangement (CODA) plan document which received its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PARTY-IN-INTERST TRANSACTIONS**

The Plan's investments were invested in funds managed by Vanguard Fiduciary Trust Company.

Vanguard Fiduciary Trust Company is an affiliate of the Vanguard Group, Inc. ("Vanguard"). Vanguard provides certain administrative services to the Plan pursuant to a service agreement between the Company and Vanguard. Vanguard, through Vanguard Retirement Plan Services, has retained Ascensus LLC as a subcontractor to provide the administrative services under the service agreement on behalf of Vanguard. Vanguard receives revenue from the mutual fund service providers for services Ascensus provides to the funds. This revenue is used to offset certain amounts to Ascensus for its administrative services to the Plan.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions to the Plan at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and risks pertaining to overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participants' account balances.

**NOTE 9 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events through January 12, 2026, the date the financial statements were available to be issued, and they are not aware of any subsequent events which would require recognition or disclosure in the financial statements.
