## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the REVERENCE FOR LIFE & CONCERN FOR PEOPLE, INC. ("the Organization") 401(k) PROFIT SHARING PLAN ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of the Organization, who have one year of service and have completed at least 1,000 hours of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Organization's Board of Directors oversees governance of the Plan's investment offerings, monitors investment performance, and reports to the Organization's Board of Directors.

#### **Contributions**

Each year, participants may make voluntary salary deferral contributions up to 100% of pretax annual compensation, subject to the dollar limits determined by the Internal Revenue Service. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance contract as investment options for participants. The Organization contributes 100% of the first 3% base compensation that a participant contributes to the Plan. After two years of qualified service, the Organization may make a discretionary employer contribution, which would be allocated in the same ratio as each participant's compensation bears to the total compensation of all participants.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in the Organization's matching and discretionary contributions plus actual earnings thereon.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Notes Receivable from Participants**

The Plan does not make loans to participants or beneficiaries.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant with a vested balance exceeding \$5,000 may elect to receive payment in a lump sum or in installments over a reasonable period of time. For balances not exceeding \$5,000, a participant will receive the value of the account in a lump-sum distribution.

**Forfeited Accounts**

At June 30, 2025, forfeited non-vested accounts totaled \$4,057. These accounts will be used to pay plan expenses and reduce employer contributions. Forfeited non-vested accounts were used to reduced employer contributions by \$0 for the year ended June 30, 2025.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the modified cash basis of accounting. Under the modified cash basis of accounting, contributions and related assets, including contributions receivable, are recognized when they are received rather than earned. Certain expenses and related liabilities, including liabilities for corrective distributions are recognized when paid rather than when the obligation is incurred. Also, assets are valued at fair market value rather than being valued based upon cash paid or received for purchases and sales, respectively. This differs from the cash basis of accounting and from accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investments because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2025 contributions. For the year ended June 30, 2025, there was \$0 distributed for excess contributions.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Organization and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Date of Management's Review of Subsequent Events**

Subsequent events were evaluated through December 22, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at June 30, 2025.

**Level 1 Fair Value Measurements**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

**Level 2 Fair Value Measurements**

The fair value of corporate bonds and U.S. government securities are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Gains and losses included in changes in net assets available for benefits for the year ended June 30, 2025, are reported in net appreciation(depreciation) in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended June 30, 2025, there were no transfers of investments into or out of Level 3.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a traditional fully benefit-responsive guaranteed investment contract with an insurance company. The insurance company maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits – modified cash basis at contract value. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at June 30, 2025 was \$23,098. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis.

The average yield earned by the Fund for the year ended June 30, 2025 was 1.45%. The actual interest rate credited to participants in the Fund for the year ended June 30, 2025 was 1.45%.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (a) amendments to the plan documents, (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan Participants are probable of occurring.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The guaranteed investment contract does not permit the insurance company to terminate the agreement to the prior scheduled maturity date.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service has determined and informed the Organization by a letter dated June 30, 2020, the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities, however there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$19,012 to Empower Annuity Insurance Company of America, an affiliate of the Plan for certain recordkeeping and administrative services for the year ended June 30, 2025.

**NOTE 9 - PARTY-IN-INTEREST TRANSACTIONS(CONTINUED)**

Empower Retirement is the custodian of the Plan and certain Plan Investments are annuity contracts owned by Great-West Life & Annuity Insurance Company or are shares of mutual funds. Therefore, these transactions qualify as party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 - CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule including all investments and notes receivable from participants held at June 30, 2025, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants from the year ended June 30, 2025 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America (the trustee of the Plan).
