Opinion

We have audited the financial statements of the Lewis Brothers Bakeries, Inc. Employee Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits arising from cash transactions as of March 31, 2025 and 2024, and the related statements of changes in net assets available for benefits arising from cash transactions for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits arising from cash transactions of the Plan as of March 31, 2025 and 2024, and the changes in net assets available for benefits arising from cash transactions for the years then ended in accordance with the cash basis of accounting described in Note 2.

Basis for Opinion

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the Lewis Brothers Bakeries, Inc. Employee Benefit Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established August 1, 1984. The Plan is a welfare benefit plan formed to provide benefits to eligible employees and employees' dependents of Lewis Brothers Bakeries, Inc. and affiliated employers (the Plan Sponsor). These benefits include hospitalization, health and surgical benefits, life and dental.

The Plan's assets are held in a trust established to receive plan contributions and disburse funds in payment of eligible benefit claims and other plan expenses. The trust is a voluntary employees' beneficiary association described in Section 501(c)(9) of the Internal Revenue Code of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974.

Contributions

The Plan is funded through employer contributions to accounts held at the Old National Bank of Evansville, Indiana. Contributions are made periodically at a level the Plan's trustees deem adequate to provide for payments of benefit claims and plan expenses. Investment assets are shown at fair market value. The Plan also receives reimbursements from current employees for cafeteria plan coverage and from former employees as reimbursement for COBRA health coverage.

Stop-Loss Insurance Arrangement

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits for individual participant claims over \$350,000.

Plan Tax Status

The Trust established under the Plan to hold the Plan's assets is intended to qualify, pursuant to Internal Revenue Code (IRS) Section 501(c)(9), and accordingly, the Trust's net investment income is exempt from income taxes. The plan sponsor believes the trust continues to qualify and operate in accordance with the applicable provision of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

As a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for unrelated business taxable income for the years ending March 31, 2025 or 2024.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Plan Termination

Although it has not expressed an intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, any assets remaining after satisfaction of claims, liabilities and reasonable administrative fees shall be applied by the trustees to a successor health plan.

New Act

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. Secure Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2033. The most significant changes impacting the existing plan provisions include an indirect benefit for participants by making it easier for employers to transfer surplus pension funds into retiree health accounts via changes to IRC Section 420, the Act helps ensure the long-term funding stability of promised retiree medical and life insurance benefits. SECURE Act 2.0 amendments must be adopted by December 31, 2026 for calendar year plans. Plan documents are to be updated in accordance with the provisions of SECURE Act 2.0.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements are prepared on the cash basis method of accounting. This basis differs from generally accepted accounting principles (GAAP) in the United States of America primarily because it does not accrue unpaid expenses or unreceived income.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash

The Plan considers all highly liquid investments with a maturity of three months or less when purchased to be cash. Cash includes demand deposit accounts recorded at cost, which approximates fair value.

Investments

The Plan's investments are reported at fair value, as determined by the Old National Wealth Management of Evansville, Indiana. The investments of the Plan are held by a bank-administered trust fund. As of March 31, 2025 and 2024, the book value and market value of the plan investments held were the same. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

Insurance Premiums

Premiums paid are recorded as payment to insurance carriers in the accompanying statement of changes in net assets available for benefits arising from cash transactions. Premiums paid by the Plan for stop-loss insurance are included in payments to insurance companies in the accompanying statement of changes in net assets available for benefits arising from cash transactions. There were no stop-loss refunds for the years ended March 31, 2025 and 2024.

Benefit Obligations

In accordance with FASB ASC 965, *Plan Accounting – Health and Welfare Benefit Plans*, the present value of benefit obligations represents the estimated future cost of health and welfare benefits attributed to participant service rendered through the end of the Plan’s fiscal year. These obligations include incurred but not reported (IBNR) claims, which are estimated using the claims lag method, as well as premiums and claims billed but not paid as of Plan year-end. The Plan relies on historical claims data organized by the date services were incurred versus the date claims were paid to determine completion factors. The resulting estimates are adjusted for current period changes in participant headcount and anticipated healthcare cost trends to reflect the VEBA’s ultimate liability. As allowed by FASB ASC 965, the present value is reported in Note 5 and not Statement of Net Assets Available for Benefits – Cash Basis and Statement of Changes in Net Assets – Cash Basis.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits – cash basis as administration fees and other expenses. All other administrative expenses, such as professional fees, are paid by the Plan Sponsor on behalf of the Plan.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted process for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The estimated fair value amounts have been determined by the Plan using available market information and appropriate valuation methodologies. Considerable judgment is necessary to interpret market data to develop the estimates of fair value, and, accordingly, the estimates are not necessarily indicative of the amounts that the Plan could realize in a current market exchange.

NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

NOTE 7: CONCENTRATION OF CREDIT RISK

The Plan maintains cash at a local financial institution. Balances in the bank are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 at each institution. As of March 31, 2025 the Plan's cash did not exceed the FDIC insured limit. The Plan has not experienced any losses on its cash for balances exceeding the FDIC limit for the years ended March 31, 2025 and 2024.

NOTE 8: FIDELITY BOND

Trustees of the Lewis Brothers Bakeries, Inc. Employee Benefit Plan are covered under a fidelity bond in the amount of \$500,000.

NOTE 9: SUBSEQUENT EVENTS

The Plan administrator has evaluated subsequent events through January 15, 2026, the date the financial statements were available to be issued. The Plan administrator has not identified any events that require disclosure in these financial statements.
