Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules, schedule of assets (held at end of year) and schedule of delinquent participant contributions, as of and for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following brief description of the Gaines and Company, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for informational purposes only. Participants should refer to the Plan adoption agreement for more complete information.

1. General

The Plan is a defined contribution multiple employer retirement plan covering substantially all employees of Gaines and Company, Inc., Gaines Construction, LLC and F&L Company. The three employers are collectively the Sponsor. Employees become eligible if they are at least 21 years of age and after they complete 6 months of service, at which time they are eligible to make elective deferral contributions and to receive employer discretionary matching contributions. Participants may enter the Plan on the first day of the quarter following meeting the age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The Sponsor's management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the plan administrator.

2. Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover) and may make Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision in which all eligible employees will be enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated target date fund until changed by the participant.

The Sponsor may elect to make discretionary matching contributions in a percentage determined by the Sponsor on an annual basis. The Sponsor elected to make a discretionary matching contribution of 50% of participant deferrals up to a maximum of 5% of eligible compensation for the year ending December 31, 2024. The discretionary matching contributions are invested in the same investment options and allocation percentages as the participant-directed contributions.

Additional discretionary profit-sharing amounts may be contributed at the option of the Sponsor's boards of directors. For the year ended December 31, 2024, the Sponsor made a \$573,311 discretionary profit-sharing contribution to the Plan. All contributions to the plan are subject to certain IRS limitations.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and Sponsor matching and profit sharing contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is based on the participant's vested account.

NOTE A – DESCRIPTION OF PLAN – Continued

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution portion and discretionary contribution of their accounts plus actual earnings thereon is based on years of service. Participants are 20% vested after two years of service and vesting increases 20% for each additional year of service until fully vested after six years of service.

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by a pledge and assignment of 50% of the vested balance in the participant's account and bear interest at 5.25% - 10.50%, which is commensurate with market rates offered by lending institutions for similar loans. Principal and interest is paid ratably by the participants through payroll deductions.

6. Payment of Benefits

When a participant retires, dies, becomes disabled or otherwise terminates employment, the value of the participant's vested interest in the participant's account will be paid to the participant or the participant's estate or beneficiary. Hardship withdrawals are permitted by the Plan.

7. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$63,984 and \$56,346, respectively. Forfeitures occurring during a Plan year shall be used to reduce Sponsor contributions, the remaining forfeitures shall first be used to pay administrative expenses under the Plan. For the year ended December 31, 2024, Sponsor contributions were reduced by \$40,154 for forfeitures.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

4. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and custodian and third party administrator. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Contributions

Contributions from plan participants, discretionary profit-sharing contributions and match from the employer are recorded in the year in which the employee contributions are withheld from compensation.

6. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding expense deduction. The Plan distributed the 2024 and 2023 excess contributions payable prior to April 15, 2025, and April 15, 2024, respectively.

7. Payment of Benefits

Benefits are recorded when paid.

8. Administration Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

9. Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

NOTE C – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information provided to the plan administrator and has been prepared and certified as complete and accurate by Reliance Trust Company (Reliance), the Plan's trustee as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE D – FAIR VALUE OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or are corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market funds and mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE F – TAX STATUS

The IRS issued a volume submitter profit sharing plan opinion letter to ADP, LLC dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since the effective date of the determination letter, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP Inc. (ADP) is the trustee and recordkeeper, as defined. The Plan paid record keeping fees to ADP totaling \$49,363 during the year ended December 31, 2024. Greenspring Advisors, LLC (Greenspring) provides investment advisory services to the Plan and received \$34,102 from the Plan for advisory services during the year ended December 31, 2024. The Plan paid audit fees of \$19,400 to the auditor, Gorfine, Schiller & Gardyn, P.A. during the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.
