This letter is being attached to provide an explanation for the late filing of Form 5500-SF for the above-mentioned entity.

During the 2025 calendar year, the above company moved the administration and actuarial services to different TPA's. In the transition, the firm responsible for the 2024 tax filing(s) was not clear and due to this misunderstanding, the incoming TPA assumed that the predecessor firm would file all the necessary forms for 2024 which unfortunately was not the case.

Upon discovering this oversight, the above firm immediately made all necessary tax filings to bring the company in compliance with the IRS tax deadlines.

Based on prior years' review and experience beginning in 2006, taxpayer has made and deposited on a timely basis all retirement contribution amounts as required by the Department of Labor and as such filed all required form 5500-SF's on a timely basis as well. Taxpayer did not willfully withhold or neglect to make said tax filings and respectfully requests a waiver of late filing penalties.
