NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Zaro's Family Bakery 401(k) Plan (the "Plan"), sponsored by Gen Four Holding Group LLC (the "Company"), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all non-union employees of the Company and its controlled entities (Zaro Bake Shop, Inc. and Grand Central Joint Venture) who have attained the age of 18 and completed 360 hours of service in a 90 day period. Eligible employees may enter the plan on the first business day of each Plan quarter. Employees eligible to enter the plan are also eligible for the Company match upon commencement of participation. The Plan was established by the Company as of October 1, 1999. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - The Company makes a discretionary matching contribution equal to 100 percent of an employee's contribution up to 7 percent of the employee's compensation.

Additionally, eligible participants who elect to participate can make pre-tax contributions to the Plan in an amount up to 100 percent of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total participant contributions are subject to limitations imposed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined contributions plans (rollover).

Participant Accounts - Each eligible participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of (b) Plan earnings and is charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - The Plan provides that participants shall be fully vested in their account balances at all times. Employer matching contributions are subject to a graded vesting schedule in which the participant is fully vested after 5 years of service or immediately upon disability or death.

Forfeitures - Participants who terminate employment but have not become fully vested forfeit the unvested balances in their accounts. Forfeitures can be used for paying plan expenses and/or offsetting employer contributions. The balance of the forfeiture account as of December 31, 2024 and 2023 is \$0 and \$1,184, respectively. During the plan year ended December 31, 2024, \$1,184 of forfeitures were transferred to OpenPEP.

Payment of Benefits - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment termination, or qualifying for a "Hardship Distribution" as defined in the Plan. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment or an installment basis. For accounts with less than \$5,000, the Company can pay the participant in a lump sum at any time after the participant leaves the Company.

Hardship Withdrawals - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

Investment Options - Upon enrollment in the Plan, a participant may elect a number of various investment options consisting mainly of pooled separate accounts. All investment transactions are participant directed. As such, participants may make transfers among investment funds at their discretion in whole percentages. In addition, participants may elect to change their investment options daily.

Notes Receivables from Participants - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum payment term for any loan is five years. The minimum loan is \$1,000. A participant may have no more than one loan outstanding at a time. The loans bear interest at rates commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. The loans are collateralized by the balance in the participant's account.

Plan Expenses - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. Investment related expenses are included in net depreciation of fair value of investments. The Company pays administrative expenses which are excluded from these financial statements. Certain participant loan costs are charged to participant's individual accounts. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

Disclosure of Subsequent Events - Plan management has evaluated subsequent events through January 6, 2026, the date the financial statements were available to be issued. Management is not aware of any events subsequent to the Statement of Net Assets Available for Benefits date which would require additional adjustment to, or disclosure in, the accompanying financial statements, except as disclosed in Note 9.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

NOTE 4 - INVESTMENTS MEASURED AT NAV USING THE PRACTICAL EXPEDIENT

The Plan's pooled separate accounts are measured at NAV as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

Investments measured at NAV, which represents investments at fair value, were \$194,920 and \$1,373,829 at December 31, 2024 and 2023, respectively. Participants can redeem their investments in pooled separate accounts daily without notice. There are no unfunded commitments.

As the plan invests in pooled separate accounts for which there is no Form 5500 filed as a direct filing entity, the Plan must provide the following description of significant investment strategies:

- Stable value- Seeks to preserve capital by investing in benefit responsive contracts offered by insurance companies and banks.
- Target funds- Seeks to provide capital appreciation and current income with an asset allocation designed for those planning to retire and leave the workforce within a few years of the target date.
- Lifestyle- Seeks long-term growth of capital by primarily investing in equity securities and fixed income securities with allocations differing based on the profile of the fund (i.e. growth).
- Bonds- Seeks to provide high level of current income with potential for capital appreciation.
- Mid cap- Seeks to provide long-term growth of capital by primarily investing in companies with mid-market capitalizations.
- Large cap- Seeks to provide long-term growth of capital by primarily investing in companies with large market capitalizations.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 8 – PLAN TRANSFER

In February 2024, \$1,071,805 of plan assets, including notes receivables from participants, were transferred to OpenPEP.

NOTE 9 - SUBSEQUENT EVENT

Subsequent to December 31, 2024, the remaining plan assets from John Hancock Life Insurance Company of New York were transferred to Open PEP.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Zaro's Family Bakery 401(k) Plan (the "Plan"), sponsored by Gen Four Holding Group LLC (the "Company"), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all non-union employees of the Company and its controlled entities (Zaro Bake Shop, Inc. and Grand Central Joint Venture) who have attained the age of 18 and completed 360 hours of service in a 90 day period. Eligible employees may enter the plan on the first business day of each Plan quarter. Employees eligible to enter the plan are also eligible for the Company match upon commencement of participation. The Plan was established by the Company as of October 1, 1999. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - The Company makes a discretionary matching contribution equal to 100 percent of an employee's contribution up to 7 percent of the employee's compensation.

Additionally, eligible participants who elect to participate can make pre-tax contributions to the Plan in an amount up to 100 percent of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total participant contributions are subject to limitations imposed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined contributions plans (rollover).

Participant Accounts - Each eligible participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of (b) Plan earnings and is charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - The Plan provides that participants shall be fully vested in their account balances at all times. Employer matching contributions are subject to a graded vesting schedule in which the participant is fully vested after 5 years of service or immediately upon disability or death.

Forfeitures - Participants who terminate employment but have not become fully vested forfeit the unvested balances in their accounts. Forfeitures can be used for paying plan expenses and/or offsetting employer contributions. The balance of the forfeiture account as of December 31, 2024 and 2023 is \$0 and \$1,184, respectively. During the plan year ended December 31, 2024, \$1,184 of forfeitures were transferred to OpenPEP.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment termination, or qualifying for a "Hardship Distribution" as defined in the Plan. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment or an installment basis. For accounts with less than \$5,000, the Company can pay the participant in a lump sum at any time after the participant leaves the Company.

Hardship Withdrawals - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified within the Plan.

Investment Options - Upon enrollment in the Plan, a participant may elect a number of various investment options consisting mainly of pooled separate accounts. All investment transactions are participant directed. As such, participants may make transfers among investment funds at their discretion in whole percentages. In addition, participants may elect to change their investment options daily.

Notes Receivables from Participants - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The maximum payment term for any loan is five years. The minimum loan is \$1,000. A participant may have no more than one loan outstanding at a time. The loans bear interest at rates commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions. The loans are collateralized by the balance in the participant's account.

Plan Expenses - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. Investment related expenses are included in net depreciation of fair value of investments. The Company pays administrative expenses which are excluded from these financial statements. Certain participant loan costs are charged to participant's individual accounts. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits - Benefits are recorded when paid.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

Disclosure of Subsequent Events - Plan management has evaluated subsequent events through January 6, 2026, the date the financial statements were available to be issued. Management is not aware of any events subsequent to the Statement of Net Assets Available for Benefits date which would require additional adjustment to, or disclosure in, the accompanying financial statements, except as disclosed in Note 9.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company of New York ("John Hancock"), the Custodian for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by John Hancock:

NOTE 4 - INVESTMENTS MEASURED AT NAV USING THE PRACTICAL EXPEDIENT

The Plan's pooled separate accounts are measured at NAV as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

Investments measured at NAV, which represents investments at fair value, were \$194,920 and \$1,373,829 at December 31, 2024 and 2023, respectively. Participants can redeem their investments in pooled separate accounts daily without notice. There are no unfunded commitments.

As the plan invests in pooled separate accounts for which there is no Form 5500 filed as a direct filing entity, the Plan must provide the following description of significant investment strategies:

- Stable value- Seeks to preserve capital by investing in benefit responsive contracts offered by insurance companies and banks.
- Target funds- Seeks to provide capital appreciation and current income with an asset allocation designed for those planning to retire and leave the workforce within a few years of the target date.
- Lifestyle- Seeks long-term growth of capital by primarily investing in equity securities and fixed income securities with allocations differing based on the profile of the fund (i.e. growth).
- Bonds- Seeks to provide high level of current income with potential for capital appreciation.
- Mid cap- Seeks to provide long-term growth of capital by primarily investing in companies with mid-market capitalizations.
- Large cap- Seeks to provide long-term growth of capital by primarily investing in companies with large market capitalizations.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, there were transactions involving the investment of Plan assets in accounts maintained by John Hancock, a party-in-interest, as defined under Section 3(14) of ERISA.

NOTE 6 - TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7 - TAX STATUS

The Plan sponsor has adopted a standardized prototype plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 8 – PLAN TRANSFER

In February 2024, \$1,071,805 of plan assets, including notes receivables from participants, were transferred to OpenPEP.

NOTE 9 - SUBSEQUENT EVENT

Subsequent to December 31, 2024, the remaining plan assets from John Hancock Life Insurance Company of New York were transferred to Open PEP.
