## (1) Description Of The Plan

The following brief description of the Myriad Fleet, LLC 401 (k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

### General

The Plan is a defined contribution benefit plan in which substantially all employees of the Myriad Fleet, LLC 401(k) (the "Employer") are eligible to participate after completing one month of service and attaining the age of 18. For this purpose, you will be credited for each month during which you perform one hour of serve. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

### Contributions

Each participant will be automatically enrolled into the Plan unless the employee elects to opt out of the automatic enrollment to reduce his or her compensation and have such amounts contributed to the Plan as pre-tax contributions. Such contributions are excluded from a participant's taxable compensation in accordance with the provisions of Section 401(k) of the Internal Revenue Code (IRC).

Each year, the Employer will determine the amount of the discretionary percentage. During 2024 and 2023, the Employer matching contributions made was equal to 100% of the employee's salary deferrals not to exceed 4%. The Employer may make a discretionary profit sharing contribution. The profit sharing contribution will be "allocated" or divided among Participants eligible to share in the contribution for the Plan year. There were no profit sharing contributions made during the years ended December 31, 2024 and 2023.

The IRC imposes certain restrictions on the amount of annual additions to an individual participants accounts, as well as an aggregate limit on contributions and requires compliance with certain nondiscrimination tests. The annual limit on a participant's before-tax contributions was \$23,000 and \$22,500 for 2024 and 2023.

Plan participants who are age 50 or more by the close of the Plan year, may elect to make catch-up elective deferrals up to \$7,500 for 2024 and 2023. These elective deferrals are for eligible participants whose elective deferrals have been restricted by either a statutory ceiling or by a plan limit.

The Plan also allows rollover contributions, within IRS parameters, of part or all of a "qualified total distribution" received by a participant from a qualified plan of a previous employer.

## Participant Accounts

Separate accounts are maintained for each participant and are credited with the participant's contributions, employer matching, and rollover contributions, if any, including the allocations of earnings and losses to these accounts. Participants direct the investment of their accounts by electing the percentages they wish to allocate between investment alternatives. Participants can change their investment allocations at their discretion by communicating directly with the Plan custodian via the internet.

## Notes Receivable From Participants

Participants may borrow from their fund up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The minimum loan amount is \$500. Each loan is secured by the participant's vested interest and is made from that participant's account. Loans must be repaid within five years unless the loan is for the purchase of a primary residence for the participant, in which even it may be repaid over a period of time that may not exceed thirty years. Interest rate is determined at the time of the loan application. All loans are repaid from payroll withholding installments.

## Vesting

Participants are always 100% vested in contributions they make and any earnings thereon.

Participants also became fully vested in all of their accounts in the event of retirement after age 65, upon death or disability or if the Plan was terminated.

Employer matching contributions are fully vested after completing one year of service with at least 1,000 hours of service during a 12-month period beginning on your first day of employment and any anniversary of your employment date.

**Payment Of Benefits**

At the time of a participant's retirement or termination of employment because of disability or termination of employment for reasons other than retirement, death or disability, a participant is entitled to receive a lump sum payment of the full amount of his or her before-tax contribution accounts plus the vested portion of his or her matching accounts.

A participant may choose either a distribution with the mandatory 20% withholding for tax or a rollover distribution for the full amount to another qualified plan. If the total benefit is \$5,000 or less, it may be automatically distributed to the participant.

Under certain conditions defined in the Plan, participants may be granted hardship withdrawals from vested account balances by the Plan administrator. Such premature withdrawals may result in the participant having to pay a 10% excise tax in addition to the regular income taxes on amounts withdrawn.

**Death Benefits**

If an active employee dies, the participant becomes fully vested. The participant's account balances are paid in a lump sum to the beneficiary.

**Administration And Expenses**

Fees for the investment managers and certain record keeping, administrative, and custodian fees are paid out of assets of the Plan. Employer personnel perform various administrative services. The expenses incurred by the Employer are not significant and are not included in the accompanying financial statements.

(2) **Summary Of Accounting Policies**

**Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use Of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Contributions Receivable

Participant contributions receivable arise from participant contributions that are withheld from employee's salary, but have yet to be remitted to the Plan by the Employer. Employer contributions receivable arise from matching or discretionary contributions that are to be remitted to the Plan by the Company for wages that have been previously paid to employees.

As of December 31, 2024, there were no contributions receivable. As of December 31, 2023, all contributions receivable were considered fully collectible, therefore, there was no provision for credit losses.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

### Investment Valuation And Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

### Fair Value Measurements

The Plan follows *Fair Value Measurements* accounting standard, which among other things requires enhanced disclosures about investments that are measured and reported at fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at their price. The mutual funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Payment Of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants as of December 31, 2024 and 2023, totaled \$12,779 and \$21,040, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability. The Plan distributed for 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024.

Subsequent Events

The Plan has performed an evaluation of subsequent events through October 1, 2025, which is the date the financial statements were available to be issued, and has considered any relevant matters in the preparation of the financial statements and footnotes.

(3) **Financial Data Certified By The Investment Company Administered Trust Fund**

The plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA as of and for the years ended December 31, 2024 and 2023. Accordingly, as permitted under such election, Reliance Trust Company (“Reliance”), the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024. The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(5) **Investment Contracts With Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract with Invesco, which is a common collective trust. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented on the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Invesco, represent contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023, was \$11,003 and \$10,037, respectively. The average yield was 2.67% and 2.47% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the Plan's ability to transact at contract value with Invesco. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or other required prohibited transactions exemption under ERISA.

Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan's administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The contract does not permit Invesco to terminate the agreement prior to the scheduled maturity date.

(6) **Forfeited Nonvested Amounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$78 and \$10, respectively. Forfeitures utilized during the year ended December 31, 2024 and 2023, amounted to \$13,424 and \$17,049, respectively. Future forfeited nonvested accounts may be used to reduce future matching contributions.

(7) **Plan Termination**

Although the Employer intends to continue the Plan and to make discretionary contributions, the Employer reserves the right to terminate the Plan at any time, and its continuance is not guaranteed. The Employer also has reserved the right to amend or otherwise modify the Plan, or to discontinue any further contributions or payments under the Plan, by a resolution of its Board. In the event of a termination of the Plan or discontinuance of contributions, the account of each affected participant shall become non-forfeitable.

(8) **Income Tax Status**

The Plan is an adoption of a regional prototype plan, under Automatic Data Processing “ADP”, (the third party administrator of the Plan), which has received a notification letter from the Key District Director having jurisdiction with the Plan. The Internal Revenue Service permits the employer to rely on the notification letter. Therefore, the employer will not submit the Plan to the Internal Revenue Service for an advance determination as to whether the Plan meets the qualification requirements of section 401 of the Internal Revenue Code of 1986 with respect to the Plan’s initial qualification.

The prototype plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC.

The Plan follows *Accounting for Uncertainty in Income Taxes* accounting standard which requires the Plan to determine whether a tax position (and the related tax benefit) is more likely than not to be sustained upon examination by the applicable taxing authority, based solely on the technical merits of the position. The tax benefit to be recognized is measured as the largest amount of benefit that is greater than fifty percent likely of being realized upon settlement, presuming that the tax position is examined by the appropriate taxing authority that has full knowledge of all relevant information. During the years ended December 31, 2024 and 2023, the Plan evaluated its tax positions to determine the existence of uncertainties, and did not note any matters that would require recognition or which may have an affect on its tax status.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan is no longer subject to U.S. federal tax audits on its Form 5500 by taxing authorities for years ending prior to December 31, 2021. The years subsequent to this year contain matters that could be subject to differing interpretations of applicable tax laws and regulations. Although the outcome of tax audits is uncertain, the Plan believes no issues would arise.

(9) **Party-In-Interest Transactions**

Plan investments are managed by various ADP Broker-Dealers. During the years ending December 31, 2024 and 2023, fees paid by the Plan to Preferred ADP Broker-Dealers, for investment management services were included as a reduction of the return on each fund and additional management fees range from .0015 to .0050 of the average daily assets. ADP, Inc. and Reliance Trust Company who are the custodians as defined by the Plan were paid \$6,746 and \$6,574 during the year ended December 31, 2024 and 2023, respectively, for custodial and record keeping services. These transactions qualify as party-in-interest transactions.

These transactions qualify as party-in-interest transaction and are exempt from the prohibited transaction rules of ERISA.

(10) **Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in the U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.
