To Whom It May Concern,

On behalf of Advanced Edge, Inc., I submit this statement under the Delinquent Filer Voluntary Compliance (DFVC) Program to request abatement of penalties for the late filing of Form 5500 for the 2024 plan year for the Advanced Edge Inc 401K Plan.

Advanced Edge, Inc. has consistently acted in good faith to comply with all ERISA and Internal Revenue Code requirements. We retained ADP as our payroll provider and third-party plan administrator to manage all plan administration, compliance oversight, and required filings.

For prior years, ADP provided reminders, which we addressed timely. For 2024, however, we received no communications or reminders regarding Form 5500. We only became aware of the missed filing upon reviewing the ADP portal while responding to a separate year-end compliance test notice.

Had we been notified, we would have promptly ensured submission. The delay resulted from reasonable reliance on a qualified third-party administrator and an administrative oversight outside of our control, not willful neglect.

Upon discovery, we immediately took corrective action and are implementing additional internal procedures to verify future filings independently.

Based on our good-faith compliance history, prompt corrective action, reasonable reliance, and the absence of willful neglect, we respectfully request the IRS recognize reasonable cause under the DFVC Program and waive all penalties associated with the 2024 Form 5500 late filing.
