## **Independent Auditor's Report**

To the Plan Administrator  
C.S.I. Insurance Plan and Trust Fund

### **Opinion**

We have audited the financial statements of C.S.I. Insurance Plan and Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of August 31, 2025 and 2024 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of August 31, 2025 and 2024 and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Note 1 - Plan Description

The following description of C.S.I. Insurance Plan and Trust Fund (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established for the employees of Christian Schools International (CSI) and any Christian School society that is a member of CSI. The Plan provides life, accident, hospital, medical, dental, surgical, vision, COBRA, and short-term and long-term disability benefits for eligible members and their dependents specified in the Plan. The Plan has fully insured contracts with various insurance carriers.

Effective September 1, 2019, the Plan and trust were amended and restated to structure the Plan as a group insurance arrangement, where each of the participating schools will be a plan sponsor of its own plan arrangements.

#### **Premium Contributions**

Premiums received by the Plan are based on rates established annually and are based on the level of coverage selected by an individual.

#### **Adoption Reimbursements**

The Plan includes an adoption reimbursement with its benefit options, which provides for reimbursement to members up to \$5,000 per adoption for qualifying expenses.

### Note 2 - Summary of Significant Accounting Policies

#### **Basis of Accounting**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value.

All investments are valued based on quoted market prices, with the exception of the interest-bearing cash, which is valued at outstanding balance. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### **Advance Billings and Unearned Premiums**

Advance billings and unearned premiums represent amounts billed or prepaid and not earned at year end.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Commissions and Reimbursements***

Commission and reimbursement income represents amounts received from insurance carriers. Revenue is recognized when received from the carrier.

***Risks and Uncertainties***

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including January 6, 2026, which is the date the financial statements were available to be issued.

**Note 3 - Administrative Expenses**

Administrative expenses include administrative fees of \$135,385 and \$369,136 in 2025 and 2024, respectively, which were paid to the Coordinated Administrative Services Fund of the C.S.I. Employee Benefit Plans for administrative and other services. Administrative fees of \$394,250 in 2025 were paid to CEB Services for administrative and other services.

**Note 4 - Priorities upon Termination**

Although the Plan is intended to be permanent, the trustees of the Plan, with the concurrence of the board of directors of CSI, reserve the right to terminate the Plan.

In the event of plan termination, the remaining assets shall be applied in the following order of priority:

- (a) Payment of administrative costs and expenses incurred prior to the effective date of termination
- (b) Payment of necessary fees and expenses connected with termination
- (c) Payment for benefits under the Plan that occurred prior to the date of termination

In the event the assets of the Plan are insufficient to satisfy all of the liabilities enumerated, the funds shall be applied in the order specified above to each category of payments. Any excess funds remaining after termination of the Plan shall be applied to provide additional benefits, directly or through insurance, as determined by the trustees, in a manner consistent with the requirements of Section 501(c)(9) of the Internal Revenue Code (IRC) and applicable regulations.

**Note 5 - Tax Status**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the IRC, and, accordingly, the trust's net investment income generally is exempt from income taxes. There is no determination program for health and welfare plans; however, the trust received a tax-exempt letter from the Internal Revenue Service dated July 19, 1989. The Plan believes that the trust operates in accordance with applicable provisions of the IRC.

**Note 6 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Note 6 - Fair Value Measurements (Continued)**

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
