### Note 1: Description of Plan

The following description of the voestalpine High Performance Metals Retirement Plan (the "Plan"), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all eligible employees of voestalpine High Performance Metals Corp. and any of its affiliated companies (collectively the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Employees of the Company (other than employees covered by a collective bargaining agreement which does not provide for their participation, non-resident aliens, residents of Puerto Rico, and leased employees) are eligible to participate in the Plan on the first day of the month following the completion of six months of service, as defined by the Plan.

#### Participant Contributions

Each year, participants may contribute up to 85% of their annual compensation, as defined by the Plan, as either pre-tax contributions or Roth after-tax contributions, subject to maximum deferral limitations established by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants will have their deferral rate increased annually by 1% until a deferral rate of 6% is reached, unless elected otherwise.

#### Company Contributions

The Plan provides for the Company to make safe-harbor matching contributions to eligible participants each pay period. The Company contributes 100% of the first 3% of eligible compensation plus 50% of the next 3% of eligible compensation that a participant contributes to the Plan. During the year ended December 31, 2024, the Company made safe harbor contributions of \$1,799,503 to the Plan.

### **Note 1: Description of Plan** (Continued)

#### **Company Contributions** (Continued)

The Plan also provides for the Company to make a discretionary matching contribution to eligible employees, as defined by the Plan, equal to a percentage of the participant's contributions. Furthermore, the Plan provides for the Company to make a discretionary profit-sharing contribution to eligible employees, as defined by the Plan, who have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year. Allocation of the discretionary profit-sharing contribution, if any, to participant accounts will be based on a ratio of the participant's compensation as a percentage of the total compensation for all eligible participants. For the year ended December 31, 2024, the Company made no discretionary matching contributions or discretionary profit-sharing contributions to the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company safe-harbor matching and discretionary match contributions, and allocations of (a) the Company's discretionary profit sharing contribution, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Participants are 100% vested in Company safe harbor matching and discretionary matching contributions after two years of service, as defined by the Plan, and vest in additional Company discretionary profit-sharing contributions at a rate of 20% per year beginning with the second year of service. Participants become fully vested in the Company discretionary profit-sharing contributions after six years of service.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime rate plus 1.5%. Interest rates on loans outstanding at December 31, 2024 ranged from 4.25% to 10.00%. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the participant's loan is for the purchase of a principal residence which can be repaid over a period not to exceed 15 years. Participants may not have more than one outstanding loan at any given time.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial payments or installments over a period of time not exceeding the greater of twenty years, the life expectancy of the participant, or the joint life expectancy of the participant and his/her beneficiary. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$106,748 and \$89,613, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the Plan document. Also, during the year ended December 31, 2024, administrative expenses were reduced by \$43,132 from forfeited nonvested accounts.

#### **SECURE Act 2.0**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net investment income.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Trust Company LLC, the Trustee of the Plan.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of the relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value are described below:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds* - Valued using net asset value (NAV) as provided by the issuer of the fund as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the fund at year end.

### Note 5: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

### Note 6: Tax Status

The Company has adopted a non-standardized pre-approved Plan sponsored by John Hancock Retirement Plan Services, LLC. The Internal Revenue Service has determined and informed the Company by a determination letter that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

### Note 7: Related Party and Party-in-Interest Transactions

The Plan pays certain expenses related to plan recordkeeping and investment advisory services. These transactions qualify as party-in-interest transactions. Fees incurred and paid to John Hancock Trust Company, LLC, the Trustee of the Plan, and the various service providers, including investment expenses, were \$205,833 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9: Prohibited Transactions**

Under DOL Reg. 2510.3-102(b), the Company is required to remit the employee contributions to the Plan at the earliest date such amounts can be reasonably segregated from the Company's general assets, but no later than the fifteenth business day of the month following the date that participant contributions are withheld by the Company. As reported on Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain contributions for a payroll during the Plan year ended December 31, 2024, totaling \$12,845, were remitted outside the 15-day requirement. This transaction constitutes a prohibited transaction as defined by ERISA. The Company remitted these contributions during 2024 and the Company intends to remit lost earnings to participant accounts during the Plan year ending December 31, 2025.
