Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Madison-Haywood Developmental Services, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Madison-Haywood Developmental Services, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

June 30, 2025 and 2024

NOTE 1 – PLAN DESCRIPTION

The following brief description of the Madison-Haywood Developmental Services, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement or Summary Plan Description (SPD) for a more complete description of the Plan's provisions.

A. General

The Plan is a contributory, defined contribution 403(b) plan available to qualifying employees of Madison-Haywood Developmental Services, Inc. (the Company). The Company is the plan administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Those provisions require universal availability; therefore, participation is not subject to minimum age, hours, or years of service requirement. Participants must have attained age 21 and one year of service to participate in employer matching contributions.

B. Contributions

Each year, participants may contribute any amount, up to the legal limit, of their pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows for Roth contributions. The Company may match the respective participant's contributions. The match is invested in various investment options as contributions to the Plan determined by its board of directors. The Company's discretionary contribution is allocated to each participant's account in the same ratio as each participant's compensation bears to the total of such compensation for all participants. No non-elective discretionary contribution was made for the years ended June 30, 2025 and 2024. Participants direct the investments of the contributions to their account to various investment plans offered by the Plan.

C. Participants' accounts

Each participant account is credited with the participant's contribution and allocation of the Company's contribution and plan earnings and charged with an allocation of administrative fees. Allocations are based on participant compensation, as defined by the Plan. The Plan provides benefits based solely upon the amount contributed to the participant's account and any income, expenses, gains and losses on investments, which may be allocated to such participant's account.

D. Vesting

Participants are vested immediately in their voluntary contributions and any income or loss thereon. Employer contributions vest to the participant in accordance with a schedule which is based upon years of service. Participants vest in employer matching contributions as follows:

E. Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 7.25 to 9.50 percent. Principal and interest is paid through payroll deduction.

F. Payment of Benefits

Upon termination of service, due to death, disability, retirement or separation, a participant will receive either a 50 percent qualified joint or survivor annuity if married, or a life annuity if unmarried, calculated using the value of the participant's vested interest in his or her account. The participant, with spouse's permission, may elect out of the annuity and receive either a lump-sum distribution or periodic payments. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

G. Forfeited Accounts

As of June 30, 2025 and 2024, there were no forfeited, non-vested accounts. Forfeitures are used to pay reasonable plan expenses first then allocate from all forfeitures as additional discretionary matching contributions. Forfeitures used were \$8,772 and \$4,185 for the years ended June 30, 2025 and 2024, respectively.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The value of the fixed accounts with Voya Retirement Insurance & Annuity Company and the annuity with Corebridge are valued at contract value which approximates fair market value.

D. Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

E. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

F. Payment of Benefits

Benefits are recorded when paid.

G. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

H. Subsequent Events

Subsequent events were evaluated through January 16, 2026, which is the date the financial statements were available to be issued.

NOTE 3 – CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of June 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by CoreBridge and Voya Retirement Insurance and Annuity Company, qualified institutions.

NOTE 4 – FAIR VALUE DISCLOSURES

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 and 2024.

Mutual funds: The mutual funds are valued based on the quoted market price of the underlying mutual funds.

Insurance contract: The fixed accounts are valued based on a formula in the contract with the credited rate being the significant other observable input. The fixed account is valued at the approximate amount that would have been paid if the contract had been terminated as of June 30, 2025 and 2024 and potential surrender charges and market value adjustments were applied as of such date.

Annuities: The annuities are reported at contract value. The contract value of the annuities equal the accumulated cash contributions, interest credited to the plan's contracts and transfers, if any, less any withdrawals and transfers, if any. The annuities are not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable. While transactions involved in the purchase / sales of individual annuity contracts are not observable in a public marketplace, contract value may provide a good approximation of fair value.

NOTE 5 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are administered by Voya Retirement Insurance and Annuity Company and Corebridge. Voya Retirement Insurance and Annuity Company and Corebridge are the Plan asset custodians. Therefore, these transactions qualify as party-in-interest transactions.

Administrative services to the plan provided by Corebridge and Voya (recordkeepers) and included in the statements of changes of net assets were \$8,709 and \$6,692 for the years ended June 30, 2025 and 2024, respectively.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

NOTE 7 – INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator believes the terms of the plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
