Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of SAGE Dining Services, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan 's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of June 30, 2025, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Description of Plan

The following description of the SAGE Dining Services, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General

The Plan was established on July 1, 1991. The Plan is a defined contribution plan covering substantially all of the employees of SAGE Dining Services, Inc. (the Company or the Plan Sponsor) who have completed one year of service and have attained the age 21. The Plan is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan. The Plan's Management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

Effective January 1, 2025, the Plan's assets are held in the custody of ADP Retirement Trust Services, LLC, who also serves as the Plan's Trustee. Previously, the Plan's assets were held in the custody of Reliance Trust Company, the prior trustee.

Administrative Expenses

The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Except as described in Note 6, administrative expenses are paid directly by the Plan Sponsor, as permitted by the Plan.

Participant Contributions

Participants may contribute a percentage of their eligible compensation, as defined in the Plan, on a pre-tax and Roth basis subject to statutory limitations of the IRC. Participants may also contribute amounts representing distributions from other qualified plans. In addition, participants 50 years of age or older before the end of the calendar year may elect to make a catch-up deferral contribution up to \$7,500. Participants may direct the investment of contributions into various investment options offered by the Plan.

Company Contributions

The Company makes a safe harbor matching contribution to the Plan, equal to 100% of the first 3% of salary deferrals plus 50% of the next 2% of salary deferrals, to all participants who were eligible to participate in the Plan during the Plan year. The safe harbor matching contribution for the year ended June 30, 2025 was \$2,313,470. The Company reserves the right to make a discretionary profit-sharing contribution in addition to the safe harbor matching contribution. A participant must be employed on the last day of the Plan year in order to share in the allocation of the Plan Sponsor discretionary contributions. No discretionary profit-sharing contributions were made for the year ended June 30, 2025.

Notes to Financial Statements

Vesting

Participants are immediately vested in their salary deferral and rollover contributions and safe harbor employer contributions, plus actual earnings thereon. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan.

For employer discretionary profit-sharing contributions, the vesting schedule is as follows:

Forfeited Accounts

At both June 30, 2025 and 2024, forfeited nonvested accounts totaled \$10 and \$31, respectively. These accounts will be used to reduce employer contributions. During the year ended June 30, 2025, forfeitures totaling \$288 were used to reduce employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, related safe harbor matching contribution and allocations of (a) the Company's discretionary contribution (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in their account. The Plan allows for distributions upon termination of service, death, disability, or normal retirement age. A participant may elect to receive a lump sum payment, which includes the rollover of the value of their account into another qualified plan. In the event a participant terminates or retires and the participant's vested account balance is less than \$5,000, the balance will be rolled into an individual retirement account (IRA).

Notes to Financial Statements

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investments are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statement of changes in net asset available for benefits.

Note 3. Tax Status

The pre-approved plan adopted by the Plan obtained its latest opinion letter on October 6, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The pre-approved plan has been amended since receiving the opinion letter. The Plan has not received an opinion letter specific to the Plan itself, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and therefore, the Plan and related trust continue to be tax-exempt.

Notes to Financial Statements

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS and the Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA by delivering to the Trustee and Administrator written notice of such termination. In the event of the Plan's termination, participants will become fully vested in their accounts.

Note 5. Information Prepared and Certified by the Trustees

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation in fair value of the investments and dividends for the year ended June 30, 2025, was obtained or derived from information supplied to the Plan administrator. The Plan Administrator obtained a certification from ADP Retirement Trust Services, LLC, the current trustee, as of June 30, 2025, and for the period from January 1, 2025 to June 30, 2025, and Reliance Trust Company, the former trustee, as of June 30, 2024 and for the period from July 1, 2024 to December 31, 2024, that the information provided to the Plan Administrator is complete and accurate.

Note 6. Related Party and Parties-In-Interest Transactions

Certain Plan investments are managed by ADP Retirement Trust Services, LLC. Previously, these investments were managed by Reliance Trust Company. ADP Retirement Trust Services, LLC is the current trustee of the Plan and Reliance Trust Company was the prior trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

The custodians of the Plan receive revenue from registered investment companies and collective trust fund service providers for services the trustees provide to the funds. This revenue is used to offset certain amounts owed to the trustees for their administrative services.

If revenue received by the trustees from such registered investment companies and collective trust fund service providers exceeds the amount owed under the agreement, the trustees remit the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended June 30, 2025, there were no excess amounts. The Plan or Plan Sponsor may make a payment to the trustees for administrative expenses not covered by revenue sharing.

Third party administrator services are performed by ADP Retirement Services. Therefore, amounts paid to ADP Retirement Services by the Plan qualify as party-in-interest transactions.

Notes to Financial Statements

Investment advisory services were performed by OneDigital Investment Advisors LLC. Therefore, amounts paid to OneDigital Investment Advisors LLC qualify as party-in-interest transactions.

Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standards are described as follows:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024:

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Notes to Financial Statements

Collective Trust Fund: The fund is valued at the NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended June 30, 2025, there were no significant transfers in or out of different levels.
