NOTE A - DESCRIPTION OF PLAN

The following description of Wolfe & Travis Electric 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering a majority of all full-time employees of Wolfe & Travis Electric Company (the "Sponsor" or the "Company") who are age twenty-one or older and have completed one year of service. Employees are immediately eligible to enroll in the plan upon meeting the conditions on the entry date which is the first day of the year or the first day of the seventh month of the year. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation subject to IRS prescribed limits. Participants may also contribute amounts representing distributions from other qualified plans. The Sponsor may make discretionary contributions to the plan. The Sponsor has elected to contribute to the plan based on a prevailing wage arrangement contributing to the plan based on an hourly and hours worked. The Sponsor contributes the nonelective contributions on a weekly basis.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's nonelective contribution and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company nonelective contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants become 100% vested in the Company's discretionary contribution after six years of service.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer discretionary contributions to selected investment options. Participants may change their investment options at any time.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Administrative Costs

The Sponsor absorbs significant administrative costs of the plan.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

NOTE B - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments consist of separate account investments holding shares of registered investment companies which are stated at fair value. Quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures of contingent assets and liabilities at the date of the financial statements, and the reported revenue and expenses during the reporting period. Accordingly, actual results may differ from those estimates.

Forfeitures

During the year ended December 31, 2024 the Plan received \$12,712 from participant non-vested forfeitures which were used to reduce plan fees. As of both December 31, 2024 and 2023, the balance of the forfeited non-vested accounts totaled \$-0-.

NOTE C - INFORMATION CERTIFIED BY TRUSTEE

The pooled separate accounts were certified by Transamerica Trust Company, the plan custodian, as complete and allocate as of December 31, 2024 and the year then ended. As of December 31, 2024 the investments, at fair value totaled \$13,985,166.

NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE E - TAX STATUS

The Plan has adopted a prototype non-standardized 401(k) profit sharing plan agreement that was sponsored by the Plan's third-party administrator. Although the Plan has been amended since the prototype non-standardized 401(k) profit sharing plan determination letter was received the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, management believes the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). As of December 31, 2024, the Plan has not recognized any uncertain tax positions. The plan is subject to audits by taxing and compliance jurisdictions; however, there are currently no audits for tax periods in process. The plan is no longer subject to tax examination for years prior to 2020.

**NOTE F – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE G – GUARANTEED INTEREST CONTRACTS**

The Plan has an interest-earning investment option, backed by Transamerica Trust Company ("Transamerica"). Transamerica guarantees that interest will be credited at the higher of the rate guaranteed in the group annuity contract and the current rate declared by it. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attributable to the guaranteed investment contract. Contract value, as reported to the plan by AUL represents contributions made under the contract, plus earnings, less participants withdrawals and administrative expenses. Participants ordinarily direct the withdrawals or transfer of all or a portion of the investment at contract value. The crediting interest rates are reviewed on a quarterly basis for resetting. As of December 31, 2024 and 2023 the contract value was \$359,871 and \$394,717.

**NOTE H – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Codification 820-10 (FASB ASC 820-10), *Fair Value Measurements* (formerly FASB Statement No. 157), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE H – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Registered investment companies located in pooled separate accounts:* Value is based on quoted asset values of the shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth, by level within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023 (investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy table for such investments are intended to permit reconciliation of the fair value hierarchy to investments at fair value line item presented in the statements of net assets available for benefits.
