Independent Auditor's Report

To the Plan Trustees and Plan Administrator of
the Hurwitz Fine, P.C. 401(k) and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hurwitz Fine, P.C. 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hurwitz Fine, P.C. 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1. **Description of Plan**

The following description of the Hurwitz Fine, P.C. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a safe harbor defined contribution plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code. The Plan has adopted the Actuarial Consulting Services, Inc Non-Standardized Defined Contribution Pre-approved Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is Hurwitz Fine, P.C., and the trustee is Principal Trust Company (Principal).

Administration - Principal provides recordkeeping services. Actuarial Consulting Services, Inc. is the third-party administrator (TPA).

Participant Contributions - The Plan provides for participant pre-tax contributions of compensation or after-tax Roth contributions, as defined, up to the maximum annual limitation allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer Contributions - The Plan Sponsor will make safe harbor nonelective contributions equal to 3% of eligible compensation. The Plan Sponsor may make a discretionary profit-sharing contribution each plan year as determined by the Plan Sponsor's trustees. The Plan Sponsor made a discretionary profit-sharing contribution of \$210,097 in 2025 (\$222,547 - 2024).

Eligibility - Employees are eligible to make salary deferrals and after-tax Roth contributions after they have attained the age of 21 and completed three months of service. Employees are eligible for employer profit sharing and employer safe harbor nonelective contributions after they have attained the age of 21 and have completed one year of service and they must be employed on the last day of the plan year.

Contribution Direction - Participants direct their contributions and employer contributions into various investment options offered by the Plan. The Plan offers over 25 different investment options consisting of collective trust funds, registered investment companies, a self-directed brokerage account and a pooled separate account. Participants may change their investment allocation on a daily basis.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions and (b) the Plan's earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral contributions and employer safe harbor non elective contributions plus actual earnings thereon. Vesting in the Plan Sponsor's profit-sharing contribution is as follows:

Employees become 100% vested in their profit-sharing contributions upon death and total and permanent disability.

Note 1. **Description of Plan (Continued)**

Notes Receivable from Participants - Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants are limited to one outstanding loan at a time with no refinancing available. The loans, which must be repaid within five years (up to fifteen years if used to purchase a principal residence), are secured by an irrevocable pledge and assignment of fifty percent of the nonforfeitable balance in the participant's account and bear interest at a rate commensurate with commercial loans of the same type - prime plus 2%. Principal and interest are paid ratably through payroll deductions.

Forfeitures - At April 30, 2025 forfeited nonvested accounts totaled \$22,890 (\$8,054 - 2024). Forfeiture amounts are used to reduce employer contributions. The Plan Sponsor used forfeitures of \$19,753 to reduce the employer profit sharing contribution for the year ended April 30, 2025 (\$8,027 - 2024).

Payment of Benefits - Distributions will be made as soon as practical after a participant's normal retirement date, actual retirement date, upon experiencing financial hardship or in the case of in-service distributions, upon attaining the age of 59½. The normal retirement date is the date upon which a participant reaches age 65. The normal form of distribution at termination is a lump sum payment. Participants may receive their accumulated vested benefits held by the Plan's custodian upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age or death if their account balance exceeds \$5,000. If the participant elects to keep their vested interest in the Plan, the participant's account will continue to receive its share of earnings/losses and will be charged a portion of administrative expenses.

Note 2. **Summary of Significant Accounting Policies**

Basis of Accounting - The Plan prepares its financial statements on the accrual basis of accounting and presents the fair value of net assets available for benefits and changes in those net assets in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Collective trust funds and pooled separate accounts are valued at the net asset value (NAV) of units held by the Plan at year end (See Note 4). The NAV is based on the market value of its underlying investments and is not a quoted price in an active market.

Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 30, 2025 and 2024. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits payments to participants are recorded when paid.

Note 2. **Summary of Significant Accounting Policies (Continued)**

Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and contract administration fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events- These financial statements have not been updated for subsequent events occurring after January 14, 2026, which is the date these financial statements were available to be issued.

Note 3 **Group Annuity Contract**

The Plan has a group annuity contract with Principal. Under terms of the contract the Plan offers a pooled separate account fund and collective investment trust funds. Plan participants acquire investment units in the pooled separate account and collective investment trusts. The purchase price or redemption price of the units are determined daily by the trustee based on the current market values of the underlying assets of the funds.

Note 4. **Fair Value of Investments in Entities that Use Net Asset Value**

The following table summarizes investments measured at fair value based on net asset value (NAV's) per share as of April 30, 2025 and 2024, respectively which are not included in the fair value hierarchy described in note 5.

Note 5. **Fair Value Measurements**

Financial Accounting Standard Board (FASB) *Accounting Standards Codification 820, Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 5.

Fair Value Measurements (Continued)

- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methods used to measure fair value:

Registered investment companies. The fair value of registered investment companies is based on quoted prices in active markets. Registered investment companies are classified as a Level 1 investment.

Self-directed brokerage accounts. Primarily consist of stocks, exchange traded funds, bonds, municipal bonds, registered investment companies, certificates of deposit and treasury securities and are valued based on readily determinable market prices. Self-directed brokerage accounts are classified as a Level 1 investment.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. **Party-In-Interest Transactions**

Plan investments are managed by Principal, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest. Notes receivable from participants are considered party-in-interest.

As discussed in Note 2, the Plan paid certain expenses for administrative fees recognized by the Plan which are party-in-interest and amounted to \$50,097 for the plan year ended April 30, 2025 (\$39,908 – 2024).

Note 8. **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer profit sharing contributions.

Note 9. **Tax Status**

The Plan has adopted the Actuarial Consulting Services, Inc Non-Standardized Defined Contribution Pre-approved Plan. The prototype plan received a positive opinion letter from the IRS on June 30, 2020. The opinion relates only to the acceptability of the form of the Plan under the Internal Revenue Code. The Plan Administrator believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of April 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to Income tax examinations for years prior to 2022.

Note 10. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
