Year Ended December 31, 2024

1. Description of plan:

The following description of the Western Industrial Resources Corp Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in May of 2004, and has been amended several times since that date.

General:

The Plan covers substantially all employees of Western Industrial Resources Corporation, the Sponsor.

The Plan is a defined contribution retirement plan with 401(k) provisions consisting of a salary reduction arrangement. The Plan covers eligible employees of the Sponsor on the later of the date they first complete 30 days of service and have attained the age of nineteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Plan Sponsor elected to move the assets of the Plan from Matrix Trust Company to Empower Annuity Insurance Company of America effective November 18, 2024. All assets and liabilities associated with the Plan and participants' accounts were transferred as of that date.

Participants' contributions:

Under the 401(k) provisions of the Plan, the participants may elect to defer up to 100% of their pretax and/or post-tax (Roth) compensation, subject to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participants may elect to make catch-up contributions to the Plan. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

Employer contributions:

All employer contributions are completely at the employer's discretion, except for required corrective contributions (QNECs). Contributions are subject to statutory limitations. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions.

Participant accounts:

Each participant's account is credited with the participant's elective deferral, rollover, and employer contributions, plus actual earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the employer's discretionary contribution portion of the participants' accounts, plus actual earnings thereon, is based on years of credited service. Participants vest at 20% annually, beginning with the completion of their second year and are fully vested after six years of credited service, or upon the normal retirement date. The Plan defines a year of credited service to be a Plan year (January 1 through December 31) with the participant rendering at least 1,000 hours of service. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

Participants' loans:

The Plan allows for participants to obtain loans from the Plan. All loans require written spousal consent, cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less), and must be a minimum of \$1,000. The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a fifteen-year period. All loans will provide for the repayment of interest at a rate comparable to rates available at commercial lending institutions. The participant's individual account serves as collateral for the loan and, in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statements of net assets available for benefits as notes receivable from participants.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options inside the platform at any time.

Payment of benefits:

Upon termination of service due to death, disability, retirement or other reasons, participants with account balances over \$5,000 may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or delay withdrawal until the participant is required by law to receive minimum distributions. Participants with account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. Mandatory distributions under the Plan may be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions.

1. Description of plan (continued):

Forfeited accounts:

The Plan allocates participant forfeitures to reduce administrative costs and sponsor contributions. During 2024, \$18,058 of forfeitures was used to pay administrative costs.

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the portion of their elective deferral account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

2. Summary of significant accounting policies (continued):

Payments of benefits:

Benefits paid to participants are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent event:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through January 9, 2026, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor adopted a non-standardized pre-approved profit sharing plan with CODA, as published by CCH Incorporated DBA FTWilliam.com, who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The assets in the preceding tables were measured primarily using the market approach. Following is a description of the valuation methodologies used for assets measured at fair value:

Interest bearing cash: Consists of highly liquid instruments that generate interest income. The carrying value of interest bearing cash is its fair value.

Registered investment companies: Valued at the closing price reported in the active market on which the individual securities are traded.

Common/collective trusts: These funds are invested and reinvested primarily in fixed income securities, bond funds, and international stocks. The Plan also holds an investment in the Reliance Trust Company Stable Value Collective Investment Trust for MetLife Group Annuity Contract No. 25053, a guaranteed investment contract consisting primarily of bond separate accounts. The funds are valued at the net asset value of units of the trust. The net asset value of the funds' shares is determinable daily and includes adjustments for investment fees. The funds' daily net asset value is available at empower.com.

Pooled separate accounts: These accounts' are invested and reinvested primarily in mutual funds. Investments are valued using pricing data provided by outside valuation service providers. Each account is valued at its net asset value. The net asset value of the accounts' units is determined daily and includes adjustments for investment fees. The funds' daily value is available at empower.com.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments, and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the period of November 18, 2024 through December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Annuity Insurance Company of America (EAICA) and Empower Trust Company, LLC, qualified institutions.

Certain information related to investments disclosed in the accompanying financial statements, including interest-bearing cash and investments held at December 31, 2023, and net appreciation in fair value of investments, interest and dividends for the period of January 1, 2024 through November 18, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Matrix Trust Company, a qualified institution.

6. Investment contract with insurance company:

In 2024, the Plan entered a traditionally fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America totaling \$119,578 at December 31, 2024. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. Investment contract with insurance company (continued):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

7. Related party and party in interest transactions:

The Plan paid certain expenses to Matrix Trust Company, EAICA, and other service providers during 2024 related to Plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no such officer or employee receives compensation from the Plan.

As disclosed in the accompanying schedule, certain employee deferrals and participant loan repayments were not remitted to the Plan within the timeframe required by the Department of Labor. The Company will determine the amount of related lost earnings and remit the amounts to participants' accounts subsequent to year end.

8. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
