Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of *Whitfield School Retirement Savings Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024 and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2025 AND 2024

1. DESCRIPTION OF PLAN

The following description of the Whitfield School Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the Whitfield School (the “Employer”) in St. Louis, Missouri. The Plan was established by the Employer on July 1, 1988 for the exclusive benefit of its employees and beneficiaries and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan includes 403(b) accounts for employer and employee contributions and provides for participant-directed investment accounts through TIAA-CREF and the Charles Schwab Trust Bank (the “Plan Trustees”). The Plan was amended in January 2025, effective February 1, 2025, to allow participants to make installment and partial distributions. There were no effects to net assets of the Plan either individually or in the aggregate from the adoption of this amendment.

Eligibility

Employees who are eligible to participate can immediately defer a portion of their pay, and there is no minimum age or service requirement to participate in the Employer match. Student employees and employees who work fewer than 20 hours per week are not eligible to participate in the Plan.

Contributions

Eligible employees may make voluntary contributions to the Plan not to exceed annual statutory limits. Eligible employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500. Special 403(b) catch-up contributions are available to employees who have worked at least 15 years for the Employer. If an employee contributes to the Plan, the Employer may make a matching contribution, which is discretionary and determined annually. The Plan allows for rollover contributions from other retirement plans as well as Roth IRA deferrals. For the year ended June 30, 2025, the Employer made discretionary matching contributions of \$269,267.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s matching contributions, if any, and an allocation of the Plan’s earnings net of any Plan expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Income, gains and losses are determined and allocated separately based upon the investment options selected by the Participant. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant’s account.

Vesting

Participants are immediately 100% vested in their voluntary and Employer contributions plus related earnings. Rollover and transfer contributions into the Plan are always 100% vested and nonforfeitable.

Forfeitures

Participant accounts are not subject to forfeitures since all Participants are 100% vested at all times.

Notes Receivable from Participants

A participant may borrow from the Plan through a loan from their account. Loans will be made on a uniform and non-discriminatory basis. The minimum total loan amount is \$1,000 up to a maximum of 50% of the participant's vested account balance or \$50,000. Payment terms are for a period not to exceed five years unless the purpose of the loan is to purchase a primary residence. The loans are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Participants may have multiple loans outstanding at any one time. Principal and interest is paid ratably through payroll deductions.

Administration

The Plan Administrator is the Employer.

Participant Hardship Withdrawals

Hardship withdrawals are permitted for medical expenses, purchases of a primary residence, tuition and education-related expenses, prevention of eviction from primary residence, funeral expenses and payments for the repair of your primary residence that would qualify for a casualty loss deduction. The Employer may expand the list of events that qualify as a hardship distribution if contributions that are received from the Employer are used to satisfy the hardship request. The withdrawals are taxable as ordinary income and, when made prior to age 59½, may be subject to a 10% IRS early withdrawal charge. Salary deferral contributions may be suspended for six months if there is a hardship distribution.

Payment of Benefits

The Plan provides for normal retirement to begin when the participant reaches the age of 59½. Early retirement is not allowed. The Plan provides for payment of benefits when a participant reaches 59½, incurs a hardship event, terminates their employment with the Employer, or becomes disabled as defined in the Plan.

On termination of service, if the total vested account balance does not exceed \$5,000, the participant's vested account balance may be distributed automatically in a lump sum. If the total vested account balance equals or exceeds \$5,000, participants may elect to receive an amount equal to the value of their vested account balance in any form permitted under the Plan document. The Plan was amended effective February 1, 2025 to allow participants to make installment and partial distributions

Investment Options

Upon enrollment in the Plan, a participant may direct Employer and employee contributions to any investment options available to Plan participants. Investment account options comprise various degrees of risk and return.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are already 100% vested in their employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The Plan follows the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statement of net assets available for benefits presents the contract value of the investment in the guaranteed interest contract, as permitted by FASB Accounting Standards Update (“ASU”) 2015-12, *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965) – (I) Fully Benefit-Responsive Investment Contracts*. The statement of changes in net assets available for benefits is also presented on a contract value basis.

Investment Valuation and Income Recognition

The Plan invests a portion of its investments with fully benefit-responsive guaranteed investment contracts with TIAA-CREF. TIAA-CREF maintains these investments in general accounts. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement. Benefit payments are made at contract value (no termination or surrender charges) for plan benefit events and investment transfers initiated by participants. Thus, this contract is considered benefit responsive and is reported in the financial statements at contract value, which approximates fair value.

Investments, other than the guaranteed interest contracts noted above, are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on their ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Net appreciation (depreciation) in fair value of investments includes realized and unrealized gains (losses).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Terminated participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from the financial statements of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Expenses related to various service providers of the plan may be paid out of Plan assets and amounted to \$70,877 for the year ended June 30, 2025.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated the impact on the financial statements, if any, of subsequent events through January 9, 2026, the date the financial statements were available to be issued.

3. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into fully benefit-responsive guaranteed investment contracts with TIAA CREF. TIAA-CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As stated in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by TIAA-CREF, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at June 30, 2025 and 2024 was \$1,926,579 and \$1,953,598, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. Key factors that could influence future crediting interest rates are changes in interest rates, and default or credit failures of the securities in the insurer's general assets. Past interest rates are not indicative of future interest rates.

Certain events limit the Plan's ability to transact at contract value with TIAA-CREF. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan did not have any investments meeting these valuation criteria.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Registered Investment Companies: Valued based on quoted market prices for identical assets available on an active market.

Pooled Separate Accounts: Valued based on quoted market prices for identical assets available on an active market.

Cash - Interest Bearing: Valued based on quoted market prices for identical assets available on an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value at the reporting date.

In accordance with the Financial Accounting Standards Board ("FASB") issued *Accounting Standards Update ("ASU") 2018-09 Amendments to Subtopic 962-325, Plan Accounting – Defined Contribution Plans – Investments – Other*, pooled separate accounts are deemed to have a readily determinable fair value and shall be reported as Level 1 investments as of June 30, 2025 and 2024.

5. INFORMATION PREPARED AND CERTIFIED BY TRUSTEES

The Plan Administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the plan (investment information) by the Charles Schwab Trust Bank and the Teachers Insurance and Annuity Association of America and College Retirement Equities Fund ("TIAA CREF"). The Plan Trustees have certified to the completeness and accuracy of all investments and participant loans reflected in the accompanying statements of net assets available for plan benefits as of June 30, 2025 and 2024, the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of June 30, 2025, and the related investment and participant loan activity reflected in the statement of changes in net assets available for benefits for the year ended June 30, 2025.

6. TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the Internal Revenue Service under a determination letter dated March 31, 2017. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). While the Plan was amended in January 2025, the Plan Administrator believes these amendments do not impact the overall Plan's conformity with the Code.

7. RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Charles Schwab Trust Bank and TIAA CREF acting as the Plan Trustees and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services related to these two Trustees were deducted directly from participants accounts.

Certain Plan expenses were paid to EPIC Retirement Plan Services (“EPIC”) for recordkeeping services amounted to \$41,139 for the year ended June 30, 2025. EPIC is the Plan’s third-party administrator and therefore these transactions qualify as party-in-interest transactions. These fees were deducted directly from participants accounts.

Certain Plan expenses were paid to the Moneta Group, LLC (“Moneta”) for investment advisory services amounted to \$29,738 for the year ended June 30, 2025. Moneta is the Plan’s third-party investment advisor and therefore these transactions qualify as party-in-interest transactions. These fees were deducted directly from participants accounts.

A participant may borrow from the Plan through a loan from their account. The loans are secured by the balance in the participant’s account and bear interest at an agreed-upon percentage based on prevailing market rates. The existence of notes receivable from participants qualifies as party-in-interest transactions. The balance of notes receivable from participants as of June 30, 2025 and 2024 was \$12,897 and \$12,650, respectively, and interest earned from these notes amounted to \$1,065 for the year ended June 30, 2025.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
