Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the financial statements of Do & Co. New York Catering, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of Plan

The following description of the Do & Co. New York Catering, Inc. (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees directly employed by a controlled group of employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan. Voya Retirement Insurance and Annuity Company is the custodian of the Plan.

Employees are eligible to participate on January 1st or July 1st following completion of six months of service and are age 21 or older.

The controlled group members are:

- DO & CO New York Catering, Inc.
- DO & CO Chicago Catering, Inc.
- DO & CO Los Angeles, Inc.
- DO & CO Detroit, Inc.
- DO & CO Boston, Inc.
- DO & CO Miami Catering, Inc.

Contributions

Each year, participants may contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts from other qualified defined contribution plans.

The employer matches each eligible participant in an amount equal to 100% of the participant’s elective deferrals up to 3% of compensation.

The Plan gives the employer the discretion to decide whether to make additional contributions to the Plan and to determine the amount of any such contribution by the employer. No such contributions have been made to the Plan in 2024.

Participant Accounts

Each participant's account is credited with (a) participant's contributions, (b) employer’s matching contributions, and (c) allocations of Plan earnings, and (d) charged with an allocation of administrative expenses. Allocations are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balances.

Vesting

Participants are immediately vested in their salary deferral contributions and rollovers, plus earnings thereon. Participants are immediately vested in the employer’s matching and discretionary contributions.

Note 1. Description of Plan (continued)

Notes Receivable from Participants

Loans are treated as a participant directed investment. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participants' accounts and bear interest at the prime rate of interest charged by the current commercial bank of the employer as of the date of the loan plus 1.5 percent. All loans are required to be repaid within 5 years of the date of the loan or 20 years for the acquisition of principal residence. Loans to participants as of December 31, 2024 and 2023 bear interest at rates of 4.75% up to 10.00% per annum.

Payment of Benefits

Amounts in the participant's account are available for distribution upon retirement, death, disability, termination of employment, or hardship only in lump sum amount equal to the value of the participant's vested interest in the account. In-service distributions are allowed after attainment of normal retirement age at 65.

Forfeitures

The Plan had forfeitures related to employee contributions as a result of participant accounts not in active status and/or closed status at the time of remittance. Employee forfeitures are either credited to the participant upon having a fully active account or returned back to the participant through the Plan sponsor. Forfeitures of employer contributions as a result of excess deposits, are first used to reduce future employer matching contributions, and then to pay administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividends date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies (continued)

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Loan origination fees are charged to participants directly. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the controlled group members. Expenses that are paid by the controlled group members are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through December 15, 2025, the date which the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets and liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Accounts: Valued daily based on credited rates as reported by the fund. Any market value adjustment or contract surrender charge is based on formulas and schedules in the contract. The credited interest rate, account balance and formulas upon which payments may be based are observable through the contract. The primary objective of this investment option is the stability of principal.

Note 4. Related-Party Transactions and Party-in-Interest Transactions

Plan investments are held in funds managed by the Plan's custodian (Voya Retirement Insurance and Annuity Company). During the year ended December 31, 2024, the Plan paid \$1,825 and \$5,775 in administrative fees to its custodian and third-party administrator (Associated Pension Consultants, Inc.), respectively, for the handling of participant loans and distributions during the year ended December 31, 2024. These transactions qualify as allowable party-in-interest transactions under the provisions of ERISA.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6. Tax Status

The Plan adopted a volume-submitter plan sponsored by CCH Incorporated d/b/a ftwilliam.com. The volume-submitter plan received an opinion letter dated June 30, 2020 from the Internal Revenue Service (the "IRS"), stating the volume-submitter plan, as then designed, meets the requirements of the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
