Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Houston Ballet Foundation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information described in Note 4 to the financial statements is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Management's Responsibilities for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Information Required by ERISA

For information included in the supplemental information that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Plan Description

The following description of the Houston Ballet Foundation Retirement Plan (the “Plan”) provides only general information. Houston Ballet Foundation (the “Employer” or “Foundation”) is the Plan Sponsor. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 403(b) plan that provides retirement savings benefits to eligible employees of the Employer. The Plan, which commenced effective July 1, 1993, which was amended and restated effective July 1, 2022, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians

Variable Annuity Life Insurance Company (“VALIC”) and VALIC Trust Company Inc. (“VALIC Trust”) (the “Custodians”) serve as the Plan’s Custodians. VALIC is the wholly owned subsidiary of Corebridge Financial, Inc., whose ultimate parent is American International Group (“AIG”). AIG Retirement Services represents VALIC and its subsidiaries, including VALIC Retirement Services Company (“VRSCO”). VALIC is responsible for maintaining the Plan’s participant account balances and providing recordkeeping services to the Plan. Among other duties, the Custodians receive contributions, hold, and invest the fund assets in accordance with the directions of participants, and make distributions as directed by the Plan Administrator.

Eligibility

All employees, except employees who are nonresident aliens and receive no United States-source income, are eligible to make participant elective deferral contributions to the Plan on their first day of employment. All participants, except those employees who normally work less than 20 hours per week, and employees covered by a collective bargaining agreement (unless the terms of the collective bargaining agreement provide for participation in the Plan), also become eligible to receive Employer contributions. To receive Employer contributions, the employee must work 1,000 hours during the Plan year. The minimum service requirement does not apply to dancers that are covered under a collective bargaining agreement, participants who die during the Plan year, or participants that terminate employment after attaining normal retirement age.

Participant Contributions

Participants may elect to contribute on a before-tax basis up to 100% of eligible compensation as defined by the Plan and subject to the maximum deferral limit established annually by the IRC. Participants who have attained 50 years of age before the end of the Plan year are eligible to make catch-up contributions of up to the maximum deferral limit established annually by the IRC. Participants may contribute amounts representing distributions from other qualified benefit or defined contribution plans (“rollover”).

Employer Contributions

For employees that are members of certain collective bargaining agreements or other employee groups as specified in the Plan, the Employer may make discretionary contributions to eligible participants. Such contributions may vary by each eligible class and/or employee based on their employment contract or other arrangement. During the 2025 Plan year, the Employer made a discretionary contribution equal to 5% of eligible employees’ compensation except for the dancer class of employees. The Employer also made a discretionary contribution equal to 7% of dancers’ eligible compensation during the 2025 Plan year.

Note 1 – Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, Employer's contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their pre-tax deferred contributions, rollover contributions, and any related income or loss. Employer contributions, other than for dancers, are 100% vested after two years of service. Dancers are immediately 100% vested in any Employer contributions. Former participants of the Houston Ballet Dancers Pension Plan and the Houston Ballet Orchestra Pension Plan are immediately 100% vested in Employer contributions. In addition, employees who are covered under a collective bargaining agreement and participate in the Plan will vest according to the terms of their respective collective bargaining agreements.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have one outstanding loan at a time. The loan must be repaid over a period of no longer than five years; however, if the loan is for the purchase of the participant's principal residence, the loan repayment period may be extended to up to 15 years. Loans are secured by the balance in the participant's account and bear interest at Prime plus 1%, as defined. Principal and interest are paid ratably directly by participants at least quarterly.

Plan Loans

Participants may borrow from VALIC using a portion of their Plan account as security for the loan. Plan loans are issued directly from the funds owned by VALIC, and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's VALIC account balance is reserved or held in collateral (the "Loan Collateral Fund") to cover the outstanding loan amount for the period of time the loan is outstanding. These loans are excluded from Plan assets. Principal and interest are paid ratably, directly by participants. For active loans, investments of at least 100% of the outstanding loan amount are reflected in the statements of net assets available for benefits and serve as collateral for the loan.

As of June 30, 2025 and 2024, the balance of these loans was \$50,037 and \$52,626, respectively. VALIC forecloses on defaulted loans when all restrictions are removed. As of June 30, 2025 and 2024, the Loan Collateral Fund was written down to its net realizable value of \$6,299 and \$9,954, respectively, in the Plan's statements of net assets available for benefits. There was one active Plan loan as of June 30, 2025. The loan interest rate is commensurate with local prevailing rates as determined periodically by VALIC. Principal and interest are paid ratably. The payments can be made monthly or quarterly, by check or Automated Clearing House ("ACH"), but not through payroll. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs.

Note 1 – Plan Description (continued)

Payment of Benefits

Benefits are generally distributed upon separation of service due to death, disability, termination of employment, or the attainment of normal retirement age. Distributions to a terminated employee with a vested account balance less than or equal to \$5,000 are made as a lump sum distribution as soon as administratively possible following the participant's separation of service. Alternatively, a participant may elect to receive a distribution in the form of a series of installments or annuity payments. The participant may elect whether to receive the distribution directly or to rollover the distribution into another retirement plan. Benefits may be rolled over to an Individual Retirement Account ("IRA") if the vested account balance is between \$1,000 and \$5,000.

A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½. Benefits will be paid in the form of a lump sum or in various types of annuities.

Forfeited Accounts

At June 30, 2025 and 2024, forfeited nonvested accounts each totaled \$0. Forfeitures are used to reduce future Employer contributions and to pay for Plan expenses. In 2025, approximately \$24,000 of forfeited nonvested accounts were used to pay Plan expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 – Fair Value Measurements (continued)

- **Variable Annuity Contracts, Separate Accounts** – The fair values of purchase units held in variable annuity contract subaccounts of VALIC Separate Account A are based on the NAV reported by VALIC as of the financial statement dates and recent transaction prices. The net asset values of the subaccounts are updated daily based upon the investment performance of the underlying mutual fund they invest in less a deduction for charges. VALIC Separate Account A, which is structured as a unit investment trust, is comprised of numerous subaccounts which each invest in a single mutual fund managed either by an affiliate of VALIC or by an independent third party. Participants direct certain investments to underlying “subaccounts” of VALIC Separate Account A available to them under the Plan. Each subaccount provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund’s net asset value per unit. There are no significant restrictions on participant redemptions or any unfunded commitments.

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

Note 5 – Group Annuity Contract with VALIC

The Plan’s investments consist of a deposit administration group annuity contract issued by VALIC. Within the group annuity contract, the Plan offers three fixed-interest options: Fixed-Interest Option, Fixed Account Plus, and Short-Term Fixed Account. The Plan’s Group Fixed Annuity options are invested in VALIC’s general portfolio. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. VALIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. This contract meets the fully benefit-responsive investment contract criteria and is thus reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value and there are no restrictions on when funds can be withdrawn.

The Fixed-Interest Option Account (“FIO”) will credit interest on a portfolio basis. On the portfolio basis, all amounts accumulated will be credited with the same rate of interest for the current period. The Fixed Account Plus Account (“FAP”) will credit interest periodically, but not less than annually, when interest rates are declared, and will be applied to amounts accumulated in separate time periods. The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments. If a participating Plan terminates participation in the fixed interest contracts, the lesser of the guaranteed value or the fair value will be received. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value.

Note 6 – Related Party and Party-in-Interest Transactions

Certain Plan investments are mutual funds managed by VALIC Trust, variable annuities and individual fixed annuity contracts issued by VALIC, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

The Plan has notes receivable from participants as of June 30, 2025 and 2024. Accordingly, these receivables and all related transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 8 – Tax Status

The Plan adopted the VALIC Retirement Services Company 403(b) prototype document for which the Internal Revenue Service (“IRS”) issued an opinion letter dated April 5, 2018, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
