Notes to Financial Statements

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Twist, Inc. Profit Sharing Plan and Trust (the "Plan") are prepared under the accrual basis of accounting using accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rates, market and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances reported in the statement of net assets available for benefits.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivables are reclassified as distributions based upon the Plan document. As of September 30, 2025 and 2024, no allowance for credit losses has been recorded.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Related Party Transactions / Expenses

Certain administrative functions are performed by the officers or employees of Twist, Inc. (the “Plan Sponsor” and “Company”). These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Plan Sponsor for the services of the employees to the Plan. All fees and expenses of the Plan, to the extent not paid by the Company, are paid by the Plan. Certain investment related expenses are included in the net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events subsequent to the balance sheet date through January 14, 2026, which is the date the financial statements were available to be issued.

NOTE 2 DESCRIPTION OF PLAN

The following description of the Plan is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution savings plan established by the Company. The Plan trustees oversee the governance of the Plan, including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. Empower Annuity Insurance Company of America and Empower Trust Company, LLC is the custodian, third-party administrator, and record keeper. LeafHouse Financial Advisors, LLC serves as a fiduciary investment advisor to the Plan under an ERISA 3(38) service agreement. Participation in the Plan is entirely voluntary. An eligible employee is any full-time employee of Twist, Inc. or Twist Aero, LLC who has attained age 21, completed one year of continuous service and is employed on the next entry date. The plan was amended on July 1, 2024, to apply elective service crediting for Tadd Spring Company, which was previously acquired by the Company. A year of service, for eligibility purposes, means a consecutive 12-month period in which the employee is credited with at least 1,000 hours of service. Eligibility to receive employer contributions coincides with the participation eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute pretax compensation, as defined in the Plan, subject to annual dollar limits established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,500 for 2025). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2025). The Plan currently offers various pooled separate accounts and a guaranteed investment contract as investment options for participants. The Company may, but is not required to, make discretionary matching contributions to the Plan. The Company made matching contributions for 50% of the first 10% of base compensation that each participant contributed to the plan in 2025. Additional discretionary amounts may be contributed at the option of the Plan Sponsor’s Board of Directors. There were no additional discretionary contributions to the Plan in 2025.

NOTE 2 DESCRIPTION OF PLAN (CONTINUED)

Rollover Contributions

Participants may rollover their taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant's Account

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants' vested interests in Plan Sponsor discretionary matching and nonelective contributions increase from 20% after the second year of service to 100% after the sixth year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their total vested account balance, not to exceed \$50,000. Transactions are treated as transfers between an investment fund and notes receivable. Notes receivable must be repaid within five years unless the purpose is to acquire, construct or reconstruct a principal residence. Each note is secured by 50% of the participants' vested account balance and bears a fixed rate of interest at the prime rate plus one percent. Interest rates range from 4.25% to 9.50%. Payments are made by automatic payroll deduction.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment with the Company, or termination of the Plan, the participant's account is distributed under several options. Participants may elect to receive their benefit in a lump sum, equal installments, or partial withdrawals.

In-service distributions are permissible for participants that have attained the age of 59½. Participants electing in-service distributions may elect to receive all or a portion of their vested benefits. Rollovers are also eligible for distribution at any time.

In conditions of "financial hardship", a participant may apply to the Plan administrator for approval to withdraw that portion of their account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Forfeitures

Forfeitures may be used to reduce the Plan Sponsor's future matching contributions, or the amount of any legally permitted expenses incurred in connection with the administration of the Plan which are not otherwise paid by the Plan Sponsor. No forfeitures used to reduce employer contributions or pay plan expenses in 2025. Forfeited nonvested account balances were \$3,959 and \$-0- at September 30, 2025 and 2024, respectively.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board *Accounting Standards Codification 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value:

Pooled separate accounts: Valued using quoted market prices of the underlying securities of the account, with adjustments for dividend rates and a management fee. The underlying mutual funds are deemed to be actively traded and are valued based on the closing price as reported by the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 6 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion from the Internal Revenue Service ("IRS") dated November 14, 2022, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS. Both the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related Plan was tax exempt as of the financial statement date.

NOTE 7 FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan entered into a fully benefit responsive investment contract ("FBRIC") with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

Under certain circumstances Empower may terminate the contract, causing a loss of interest adjustment that would limit the Plan's ability to transact at contract value. Those events include: 1) the contract holder adopts and amendment to the Plan or operates the Plan in a manner which is unacceptable to Empower; 2) the contract holder fails to comply with any provision continued in the contract; 3) the Plan fails to qualify or becomes disqualified under Internal Revenue Code 401(a), as amended; 4) the total amount of deposits received by Empower in the preceding twelve months is less than \$25,000; 5) the sum of all participant annuity account values falls below \$25,000; 6) the contract holder fails to make deposits which have been deducted from participant's paychecks within 30 days following the end of the month in which such deduction was made; 7) transfers to investment vehicles outside the group annuity contract exceed the limitations provided under the contract; 8) Empower may terminate the group annuity contract if the Plan Sponsor ceases doing business; or 9) this group annuity contract shall terminate if there are no remaining participant annuity accounts. The Plan administrator does not believe that the occurrence of any such event is probable.
