**To Whom It May Concern:**

This letter is submitted on behalf of **Salem Pulmonary Associates** (EIN: **93-1047960**) to explain the reasonable cause for the late filing of the Form 5500 for the plan year ending **December 31, 2024**.

The Form 5500 for this plan year was due on **October 31, 2024**, pursuant to a timely filed extension. The filing was not submitted by the extended due date due to internal staff turnover within the plan sponsor's organization. Specifically, responsibilities related to employee benefit plan administration were impacted during a transition in personnel, which resulted in the Form 5500 filing requirement being inadvertently overlooked. The specific action is that the person in charge took an unplanned FMLA leave that has been extended until 2026.

Upon discovery of this error, the newly responsible administrator acted promptly to complete and file the Form 5500 as soon as practicable. In addition, the plan sponsor is actively evaluating and engaging a qualified third-party administrator (TPA) firm to assist with ongoing compliance and to help ensure that all future filings are completed accurately and timely.

To the best of our knowledge, the plan has no history of compliance issues with respect to prior Form 5500 filings. The late filing was unintentional and attributable solely to the administrative disruption caused by staff turnover, not to willful neglect.

The plan sponsor takes its compliance obligations seriously and has taken corrective steps to prevent a recurrence of this issue. We respectfully request that this explanation be accepted as reasonable cause for the late filing.
