### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of BSW, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

## NOTES TO THE FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF THE PLAN

The following description of BSW, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General** The Plan is a defined contribution plan covering substantially all employees of BSW, Inc. (the Company) who have completed one (1) year of service and are age 20 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan was originally established as of April 1, 1979, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

**Contributions** Participants may elect to contribute to the Plan, in the form of pre-tax and Roth deferrals up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching contribution at a percentage of qualified compensation. The matching contribution percentage was 3% for the years ended June 30, 2025 and 2024. The Company made discretionary matching contributions of \$43,521 and \$44,444, for the years ended June 30, 2025 and 2024, respectively. Additionally, the Company may make discretionary profit sharing contributions. The Company did not make discretionary profit sharing contributions for the years ended June 30, 2025 and 2024.

**Participant Accounts** Each participant's account is credited with the participant's contributions, Company contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. The Company's allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** Participants are immediately vested in their contributions and earnings thereon. Discretionary matching contributions and discretionary profit sharing contributions are subject to vesting according to the number of years of service. A participant is 100% vested after six years of credited service. Participants are credited with one year of service for each plan year in which they worked at least 1,000 hours.

**Payment of Benefits** Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 73. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy.

For termination of service for reasons other than death, disability, or attainment of normal retirement age, separated participants may transfer the vested value of their account to another retirement investment vehicle, or may choose to leave vested benefits exceeding \$5,000 in the Plan until the later of April 1 of the year succeeding the year in which age 72 is attained or the participant retires, at which time participants are required to take annual minimum distributions. Participants with vested account balances not exceeding \$1,000 will receive a single lump-sum cash payment. At the discretion of the Plan administrator, vested account balances of separated participants of at least \$1,000 and not exceeding \$5,000 (including any rollover contributions), may be rolled over from the Plan without participant request into an Individual Retirement Account designated by the Plan administrator.

At June 30, 2025 and 2024, there were no amounts allocated to participants who elected to withdraw from the Plan, but have not yet been paid.

**Forfeitures** Forfeitures attributable to discretionary matching and discretionary profit sharing contributions may be used to reduce employer contributions and pay plan expenses. Forfeited nonvested account balances totaling \$-0- were used to reduce Plan expenses for the years ended June 30, 2025 and 2024. Forfeited nonvested account balances totaling \$26,551 and \$33,717 were applied to the Company contributions for the years ended June 30, 2025 and 2024, respectively. At June 30, 2025 and 2024, the remaining forfeited nonvested accounts totaled \$583 and \$15,055, respectively.

**Plan Termination** Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company contributions.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

**Fair Value Measurements** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 and 2024.

*Mutual Funds:* Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

See note 4 for the classification of these assets within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes Receivable From Participants** Loans are not permitted by the Plan.

**Payment of Benefits** Benefits are recorded when paid.

**Administrative Expenses** Certain operating expenses of the Plan are deducted from participant accounts, and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Evaluation of Subsequent Events** The Plan has evaluated subsequent events through December 15, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included in the statements of net assets available for benefits, and the investment income included in the statements of changes in net assets available for benefits as of and for the years ended June 30, 2025 and 2024, were not subject to auditing procedures and have been certified as complete and accurate by Empower Annuity Insurance Company of America (Empower). Empower is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

#### **5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

The Plan entered into an unallocated fixed deferred annuity contract with Empower. The contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount to be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. At June 30, 2025 and 2024, the total contract values were \$583 and \$15,055, respectively.

The guaranteed investment contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00% or more than 3.00%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date. The average yield earned was 1.45% and 1.40% at June 30, 2025 and 2024, respectively. The Plan's ability to receive amounts due is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following: (1) The Plan's failure to qualify under Section 401(a) of the IRC, or the failure of the trust to be tax exempt under Section 501(a) of the IRC; (2) Premature termination of the contracts; (3) Amendments to the Plan document, including complete or partial plan termination or merger with another plan; (4) Changes to the Plan's prohibition on competing investment options; or (5) Bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, or that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) Uncured violation of the Plan's investment guidelines; (2) Breach of material obligation under the contract; (3) Material misrepresentation; or (4) Material amendment to the agreements without the consent of the issuer.

#### **6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Empower. Empower is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an agreement between the Company and Empower. Empower receives revenue from mutual fund service providers for services provided to the funds. The revenue is used to offset certain amounts owed to Empower for administrative services to the Plan.

Administrative expenses, reflected in the financial statements, are predominantly recordkeeping fees paid to the custodian and third-party administrator fees paid to Big Sky Retirement and Allied Investment Advisors, who have no discretionary authority or responsibility to direct the investment of assets under the Plan, other than as specifically directed by participants or beneficiaries. The Plan paid administrative fees to Empower of \$9,157 and \$7,575, during the Plan years ended June 30, 2025 and 2024, respectively. The Plan paid management fees to Allied Investment Advisors of \$14,801 and \$11,777 during the Plan years ended June 30, 2025 and 2024, respectively. The Plan also paid third-party administration fees to Big Sky Retirement of \$2,210 and \$16,408 during the years ended June 30, 2025 and 2024, respectively.

#### **7. TAX STATUS**

The Plan has adopted a pre-approved non-standardized profit sharing plan established by Big Sky Retirement, Inc. The pre-approved plan obtained opinion letters on June 30, 2020, in which the Internal Revenue Service stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan, the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

#### **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

#### **10. PLAN AMENDMENTS**

Effective January 1, 2025, the Plan was amended to adjust the applicable age to determine the required minimum distributions to the following: age 70 ½ for participants born before July 1, 1949; age 72 for participants born on or after July 1, 1949, but before January 1, 1951; age 73 for participants born on or after January 1, 1951, but before January 1, 1960; and age 75 for participants who are born on or after January 1, 1960.

Effective January 1, 2025, the Plan was amended to increase catch-up contributions for certain eligible participants.

#### **11. SUBSEQUENT EVENT**

Effective January 1, 2026, the Plan was amended such that long-term part-time employees are ineligible to receive employer contributions.
