Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **Electron Energy Corporation 401(k) Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 7 to the financial statements, the Plan Sponsor was acquired by an unrelated party effective July 18, 2024. The Plan approved a plan of liquidation on July 18, 2024, and the Trustees have determined during the year ended August 31, 2024 that liquidation is imminent. As a result, the Plan presents the 2025 and 2024 financial statements on the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of **Electron Energy Corporation 401(k) Plan's** internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION of PLAN

The following brief description of the **Electron Energy Corporation 401(k) Plan** (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. Provisions regarding eligibility, contributions, vesting, notes receivable, and distributions described below pertain to the terms of the plan prior to the termination amendment described in Note 7.

General

The Plan is a defined contribution plan covering all eligible employees of Electron Energy Corporation (the Corporation). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan. In collaboration with the investment advisor, the Plan Administrator and the Plan's investment committee determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Plan Amendment

Effective July 18, 2024, the Plan Sponsor amended the Plan for termination. See Note 7 for further discussion of Plan termination.

Contributions

Each year, participants may contribute up to 100 percent of their annual compensation, as defined in the Plan Document. This contribution may be in the form of pre-tax or Roth contributions (salary deferral). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. After the second Plan year, automatically enrolled participants deferral rate increases to 4%, after the third Plan year, to a deferral rate of 5% of eligible compensation, and after the fourth Plan year to a deferral rate of 6% of eligible compensation.

The Corporation contributes a matching contribution of 30% of the first 5% of Plan compensation. This percentage is discretionary and determined annually by the Corporation. Compensation means total pay during the Plan year, but not exceeding \$345,000 and \$330,000 for the years ended 2025 and 2024, respectively. Participants also direct the investment of employer matching contributions. Participant contributions over 5% are not matched by the employer. Employer matching contributions for the years ended August 31, 2025 and 2024, were \$-0- and \$116,907, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

A record-keeping account is set up in each participant's name to show the value of a participant's retirement benefit. Each participant's account is credited with the participant's contributions, the Corporation discretionary matching contributions, and the participant's share of investment earnings. Subtractions from participant accounts include withdrawals made by the participant, the participant's share of investment losses, and Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION of PLAN (Continued)

Eligibility

An employee (other than an excluded employee) becomes a participant in the Plan once he/she has satisfied the eligibility requirements and reached the entry date for participation. An employee becomes an eligible participant in the Plan after 30 days from date of hire on the first day of the month that is coincident with or next following the eligibility date.

Vesting

Elective deferrals, rollover contributions, employer matching contributions, plus or minus any earnings or losses are 100% vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear interest equal to 2% above the prime rate. The interest rate will be fixed for the duration of the loan. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits

Normal Retirement - A participant's account is 100% vested and payable upon retirement at age 65.

Late Retirement - If a participant continues working after his/her normal retirement date, he/she will remain in the Plan as an active member. The participant's account is 100% vested and will become payable when he/she actually retires from active employment subject to minimum distribution rules at age 72 or later.

Death Benefits - If a participant dies while an active member of the Plan, his/her account is 100% vested and payable to the designated beneficiary. If the participant is married, his/her spouse will automatically be the beneficiary unless specified otherwise with the written consent of the spouse.

Disability Benefits - If a participant becomes disabled while an active participant in the Plan, his/her account is 100% vested and may be paid as soon as administratively possible.

Termination of Employment - Upon termination of employment, a participant will receive the vested interest in his/her account and may be paid as soon as administratively possible.

Payment Options - Upon attainment of age 59 1/2 (in-service distributions only), retirement, disability, death, or termination of employment, the participant may be paid as soon as administratively possible in a lump sum or partial payments. For required minimum distributions, the participant will receive installment payments in accordance with Code Section 401(a)(9). The Plan allows for involuntary cash-outs of amounts up to \$5,000.

Hardship Withdrawals - May be requested from the Plan in the event of financial hardship in the amount not to exceed the participant's 401(k) contribution and matching contributions. The amount of the hardship withdrawal may not exceed the amount of financial hardship after all other financial resources have been exhausted.

Forfeited Accounts

Forfeitures may be used to offset employer discretionary matching contribution obligations under the Plan or to pay for Plan administrative costs. At August 31, 2025 and 2024 (in liquidation), there were no forfeited accounts. In addition, no forfeitures were used to offset plan expenses for the years ended August 31, 2025 and 2024 (in liquidation).

NOTE 2 - SUMMARY of SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Plan Termination

On July 18, 2024, the Plan Sponsor was acquired by Dexter Magnetic Holdings, LLC. During the year ended August 31, 2025, the Plan distributed all of its funds at the request of participants. The Plan participants had several options with respect to their account balances, which include but are not limited to rolling their account balance into the Dexter Magnetic Holdings, LLC Plan, another qualified plan, taking their balance as a lump sum distribution, or rolled into an IRA. In accordance with accounting principles generally accepted in the United States of America (US GAAP), the accompanying statements of net assets available for benefits in liquidation as of August 31, 2025 and 2024, are presented using the liquidation basis. Under the liquidation basis of accounting, assets and liabilities are recorded at fair value and the Plan would accrue income and expenses that it would expect to earn or incur through the date of liquidation. The current US GAAP standards are contained in the Accounting Standards Codification (ASC) as set forth by the Financial Accounting Standards Board (FASB).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions regarding certain types of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from estimated amounts.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for its fully benefit-responsive investment contract, which is stated at contract value (which approximates fair value) (Note 5). Fair value is determined and certified by the Plan's custodians. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based upon the terms of the Plan Document for purposes of Form 5500 reporting. However, for purposes of the financial statements, for active participants who have not incurred a distributable event (employment termination, death, or disability) but have delinquent loans, the participant loan should remain outstanding until a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Contributions

Contributions from the Plan participants and the matching contributions from the Corporation are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

NOTE 3 - INFORMATION CERTIFIED by the CUSTODIANS (UNAUDITED)

The following is a summary of the Plan's investment information as of August 31, 2025 and 2024 (in liquidation), and for the years then ended, included in the Plan's financial statements that was prepared by, or derived from, information prepared by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan, and furnished to the Plan Management. The Plan Management has obtained certifications from the custodians that such information is complete and accurate.

NOTE 4 - FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset and liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2025 and 2024 (in liquidation).

Registered Investment Companies: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no assets values at fair value as of August 31, 2025 (in liquidation), due to the Plan termination. See Note 7 for further discussion of Plan termination.

NOTE 5 - GUARANTEED ANNUITY CONTRACT

The Plan is invested in a traditional fully benefit-responsive guaranteed annuity contract with the Empower Annuity Insurance Company of America who maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower Annuity Insurance Company of America. The guaranteed annuity contract holder is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium, long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The Plan Administrator does not believe that any events, including the Plan termination, would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. Due to Plan termination (see Note 7), contract is in process of being terminated.

NOTE 6 - RELATED PARTY and PARTY-in-INTEREST TRANSACTIONS

For the years ended August 31, 2025 and 2024 (in liquidation), certain Plan investments are in a guaranteed annuity contract managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian for the Plan assets and, therefore, these transactions qualify as allowable party-in-interest transactions. Administrative expenses paid to Empower Trust Company, LLC was \$-0- for both of the years ended August 31, 2025 and 2024 (in liquidation). Empower Trust Company, LLC also receives indirect compensation based on an agreed-upon formula.

As previously discussed, the Plan may issue notes receivable to participants that are secured by participant account balances. The value of the notes receivable outstanding were \$-0- and \$95,876 as of August 31, 2025 and 2024 (in liquidation), respectively. Interest income from notes receivable balances totaled \$320 and \$9,699 for the years ended August 31, 2025 and 2024 (in liquidation), respectively. All of these transactions qualify as allowable party-in-interest transactions.

NOTE 7 - TERMINATION of PLAN

Effective July 18, 2024, the Plan Sponsor amended the Plan to provide for its termination in accordance with the provisions of the Plan and applicable regulations. As part of the termination process, all participant account balances were distributed in full, either through direct distributions to participants or rollover to eligible retirement accounts, based on participant elections. In accordance with termination provisions of ERISA, all participants in the Plan at the time of termination became fully vested in their account balances. The termination process was conducted in compliance with the Employee Retirement Income Security Act of 1974 (ERISA) and relevant tax regulations, and all required notices and filings have been or will be submitted to the Internal Revenue Service (IRS) and the Department of Labor (DOL), as applicable.

NOTE 8 - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Plan which received an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Non-Standardized Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving this opinion letter. However, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore, believes that the Plan is qualified and tax-exempt.

US GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed tax positions taken by the Plan, and has concluded that as of August 31, 2025 and 2024 (in liquidation), there are no uncertain tax positions requiring recognition or disclosure.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS and UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
