Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mott Haven Academy Charter School 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Mott Haven Academy Charter School 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document or summary Plan description for a complete description of the Plan's provisions.

General

The Plan was adopted effective July 1, 2008, by Mott Haven Academy Charter School (the School, Plan Sponsor, or Employer) and was amended and restated effective July 1, 2014 for regulatory purposes and certain Plan changes. The Plan is a contributory defined contribution plan covering all eligible employees of the School. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Plan entered into a custody agreement with Voya Retirement Insurance and Annuity Company (Voya or the Trustee). Voya is the Plan's recordkeeper and Trustee. As the recordkeeper for the Plan, Voya is responsible for maintaining and updating individual participant account balances, as well as information regarding Plan contributions, withdrawals, and distributions. As the Trustee of the Plan, Voya is responsible for holding and investing Plan assets in accordance with the Plan document.

The primary objective of the Plan is to provide eligible employees of the School with the long-term accumulation of retirement savings through a combination of employee and matching Employer contributions and the potential earnings thereon.

Eligibility

All employees, except leased employees, are eligible to participate in the Plan on the date they are hired as an eligible employee, and participation is voluntary.

Contributions

Participants

Eligible employees can elect to contribute a percentage of their salary not to exceed certain limitations prescribed by the Internal Revenue Code (IRC). Income taxes on employee compensation contributed to the Plan are deferred subject to limitations as prescribed by the IRC. The Plan allows Roth contributions, which totaled \$15,806 for the year ended June 30, 2025, and were included as taxable income to employees that made such contributions. Catch-up contributions are also allowed.

Participants are also allowed to transfer amounts from certain other tax-qualified plans to the Plan (rollovers). Rollovers are included as participant contributions in the statement of changes in net assets available for benefits.

Employer Matching

Plan participants who are 21 years of age and have completed one year of service are eligible for an Employer matching contribution from the Plan Sponsor. The Plan Sponsor makes 401(k) Safe Harbor matching contributions. The School contributes 100% of the first 3% of the eligible participant's compensation contributed to the Plan and 50% of the next 2% of the eligible participant's compensation contributed to the Plan. For the year ended June 30, 2025, the Plan Sponsor contributed \$191,127.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions, as well as allocations of Plan (losses) earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in salary reduction contributions, rollovers, and the Plan Sponsor's matching contribution, plus actual earnings thereon.

Payment of Benefits

Participants make withdrawals from their accounts at age 59½ or prior to that age in the case of hardship. Upon retirement, death, disability, or termination of service, a participant or participant's beneficiary will receive the value of his or her account in the form of a lump-sum cash distribution. All vested balances less than \$7,000 may be automatically distributed as a lump sum at the discretion of the Plan Sponsor.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loans are secured by the participant's account and bear an interest rate at prime rate. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC. Also, each participant may not have more than one loan outstanding at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, recordkeeper, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan Sponsor, except for certain expenses that are charged to participant accounts, including loan and withdrawal fees. Certain investment expenses that are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended June 30, 2025, were paid by the Plan Sponsor and are excluded from these financial statements.

Contributions Receivable

The 401(k) Safe Harbor Employer matching contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect reported amounts of assets, liabilities, revenue, and expenses, as well as the disclosures of contingent assets and liabilities. These estimates include the fair value of investments. Actual results could differ from those estimates.

3. Risks and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of the investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Pooled Separate Accounts - Pooled separate accounts are valued at their accumulation unit value (AUV) as a practical expedient. The AUV is determined daily based on the net asset value (NAV) of shares of the underlying fund, and the separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

Guaranteed Annuity Contract - This asset is reported at fair value. The fair value equals accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals and fees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

5. Information Certified by Voya

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of June 30, 2025 and 2024, and net appreciation in fair value of investments, interest income from guaranteed annuity contract, and interest income on notes receivable from participants for the year ended June 30, 2025 was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

6. Party-in-Interest Transactions

Certain Plan investments are shares in a separate account managed by Voya, which qualify as party-in-interest transactions. The Plan issues loans to participants, which are secured by the vested balance of the participants' accounts, which qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included as a reduction in the net appreciation in fair value of investments.

7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

Notes to Financial Statements

8. Tax Status

The School has adopted a volume-submitter plan sponsored by The Retirement Plan Company, LLC, which received a favorable opinion letter, dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Prohibited Transactions

During the years ended June 30, 2024, 2023, and 2021, the Plan Sponsor did not remit employee salary deferral contributions totaling \$17,647, \$16,247, and \$150, respectively, in a timely manner as required by DOL regulations. The Plan sponsor self-corrected all late remittances for the years ended June 30, 2024, 2023 and 2021 during the year ended June 30, 2025 with contributions of lost earnings totaling \$122 in January and February 2025.

The School is responsible for any fines, excise taxes, and/or penalties or actions brought by the affected participants or regulatory authorities.

10. Subsequent Events

The Plan's management has performed subsequent event procedures through January 15, 2026, which is the date the financial statements were available to be issued, and there were no subsequent events requiring adjustment to the financial statements or disclosures.
