We respectfully request abatement of any late-filing (and other) penalties associated with the filing of the attached and above-referenced tax return for the TAMANINI REALTY LLC PROFIT SHARING PLAN.

The former accountant of our firm who had previously filed the tax returns promptly retired at the end of calendar year 2024 and died in April 2025 (see attached obituary).
