**Note A – Description of Plan**

The following description of The Elliott Companies (“the Company”) 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan covering all full-time employees of the Company who have completed one year of service and are age 21 or older. Plan entry dates are on the first day of the plan year quarter following the date that the plan’s eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions.* Each year, participants may contribute an amount up to 50% of pretax annual compensation as defined in the Plan subject to a dollar limitation of \$23,500 for plan years beginning in 2025. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into investment options offered by the Plan. The Plan offers various mutual fund portfolios as investment options for participants. The Plan sponsor is owned by an ESOP trust, therefore, employer matching contributions are no longer permitted.

*Prevailing Wage Requirements.* For service performed under a public contract subject to the Davis-Bacon Act or any other Federal, state or municipal prevailing wage law, the employer’s contribution will be determined each year according to each construction project and will be allocated on the basis of the hourly rate assigned to each construction project for only those employees covered by the contract.

*Participant Accounts.* Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions made for service performed under a public contract subject to the Davis-Bacon act are generally 100% vested when made.

*Participant Loans.* Participant loans are not available from this plan.

*Payment of Benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive either, (a) a lump-sum amount equal to the value of the participant's vested interest in his or her account, or (b) installments over a period not to exceed the participant's and/or beneficiary's assumed life expectancies. If the participant's vested benefit in the Plan does not exceed \$5,000, the benefit must be distributed in a single lump-sum payment. Hardship withdrawals are permitted for medical expenses, payment of tuition, the purchase of a principal residence, the prevention of eviction or mortgage foreclosure on a principal residence, burial or funeral expenses and expenses for the repair of damage to a participants' principal residence that would qualify for the casualty deduction under the Internal Revenue Code, subject to certain conditions. Benefits are recorded when paid.

*Forfeited Accounts.* These accounts may be used to offset Plan expenses as well as to reduce the amount of the employer's non-elective contributions.

**Note B – Summary of Significant Accounting Policies**

*Date of Management's Review.* Subsequent events were evaluated through January 16, 2026, which is the date the financial statements were available to be issued.

*Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Investment Valuation and Income Recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Operating Expenses.* Certain expenses of maintaining the Plan, which represent a significant portion of the costs of plan administration, are paid by the Company.

**Note C – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or Level 3 inputs were applicable to assets held by the Plan.

**Level 1 Fair Value Measurements**

The fair values of funds held in shares of registered investment companies (mutual funds) are based on quoted market prices of the shares held by the Plan at year-end. Mutual funds held by the Plan are registered with the Securities and Exchange Commission and are required to publish their daily net asset value. The mutual funds held by the Plan are deemed to be actively traded.

**Note E – Plan Termination**

Although it has not expressed any intent to do so, the company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note F – Tax Status**

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The years 2022 forward are open to examination by the Internal Revenue Service. The Plan has not received notice of intent to audit any open years.

**Note G – Party-In-Interest Transactions**

Certain Plan investments include shares of mutual funds managed by Community Trust and Investment Company which is the trustee as defined by the Plan. Community Trust and Investment Company also provides administrative, management and investment advisory services for the Plan, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the years ended June 30, 2025 and 2024 totaled \$46,860 and \$41,819 respectively. Additionally, accounting services are provided by Wallen, Puckett and Associates, PSC as independent auditors of the Plan's financial statements.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
