Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mumford & Miller 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

Note 1 - Description of the Plan

The following description of the Mumford & Miller 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution profit sharing plan covering all full-time employees of Mumford & Miller Concrete, Inc. (the Company) who have reached the age of eighteen, are not subject to collective bargaining and have completed one year of eligibility service, as defined. After an employee meets the eligibility requirements, entry dates are January 1st and July 1st. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2024 the Plan was amended to change the minimum age requirement to eighteen and vesting provisions related to certain employer contributions. Under these provisions, employees are now fully vested in the discretionary employer contributions.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, subject to the limitations under applicable provisions of the Internal Revenue Code. Participants may also designate all or a portion of their 401(k) elective deferral contributions as Roth elective deferral contributions instead of pre-tax elective deferral contributions. Roth elective deferral contributions do not reduce total taxable income and do not reduce current taxes. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make matching contributions to the Plan. For the year ended December 31, 2024, there were no Company matching contributions. The Plan is a Safe Harbor Plan in which the Company must contribute 3% of participant wages, as defined by the plan document. The Plan defines these contributions as traditional safe harbor contributions. The Company may also make discretionary employer contributions

to the Plan. For the year ended December 31, 2024, Management elected a discretionary employer contribution of at least 2% of participant wages, as defined, to the Plan. As such, the traditional safe harbor contribution totaled \$362,184 and the discretionary employer contribution totaled \$376,804 which will be transferred from the non-participant directed funds to the participant directed funds in 2025. The employer contributed \$739,811 to the plan during the year ended December 31, 2024. These employer contributions are held in a prefunded non-participant directed money market fund for future employer funding requirements. The Company did not use forfeitures to offset 2024 employer contributions. Employer contributions are Trustee directed until allocated to participants, which are then participant directed into various investment options offered by the Plan. The Plan currently offers various mutual funds.

Participant Accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Company's contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions as well as the Company's traditional safe harbor and discretionary employer contributions, plus actual earnings thereon. Any matching contributions made by the Company will be subject to a vesting schedule. A participant is 100% vested after six years of credited service.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Normal retirement age is 65. The Plan also allows hardship withdrawals if certain conditions described in the Plan document are met.

Note Receivable from Participant

Participants may borrow from their fund accounts for the purchase of a primary residence. Each eligible participant may have only one loan outstanding at any time.

The minimum loan amount is \$1,000, and the maximum loan amount is limited to the lesser of 50% of the participant's vested account balance or \$50,000. Each loan is secured by the participant's account balance and is recorded as a separate loan sub-account within the participant's account to track principal and interest. Interest rates are established at the Prime Rate plus 1% at the time of loan origination. The interest rate on the loan is 6.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through weekly payroll deductions and generally, loans must be repaid within fifteen years.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,517 and \$44,788, respectively. These amounts can be used to offset plan expenses, restore forfeited account balances of rehires or to reduce employer contributions. In 2024, \$23,394 of forfeited non-vested accounts were used to pay plan expenses.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Certain Plan investments represent parties-in-interest as defined by ERISA.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the note receivable from participant is charged directly to the participant account and is included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefit payments are recorded when paid.

Note Receivable from Participant

Note receivable from participant is measured at its unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan document.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through December 5, 2025, the date the financial statements were available to be issued.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or

- liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Value at cost, which approximates fair value.

Mutual Funds: Valued at quoted prices as reported on the active market in which the mutual funds are traded.

The Plan holds mutual funds and money market funds which are classified as Level 1 within the fair value hierarchy.

Note 5 - Non-participant Directed Investment

The Plan maintains a money market fund that is non-participant directed, which totals \$717,248 and \$702,354 and is included in net assets available for benefits at December 31, 2024 and 2023, respectively. Note 6 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Note 7 - Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated May 14, 2014, stating that the form of the pre-approved plan documents was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.
