Note 1 - Description of plan:

The following description of the Mancini Sleep World, Inc. (the “Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. *General* - The Plan is a defined contribution plan covering substantially all employees of the Sponsor, who have 30 days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally established as of July 1, 1996, and has been subsequently amended and restated. The Plan trustees are responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offerings and investment performance.
- b. *Contributions* - Each year, participants may contribute to the Plan, in the form of employee 401(k) salary deferral contributions (pre-tax 401(k) deferrals and, effective September 1, 2025, Roth 401(k) deferrals), up to the lesser of 90% of eligible compensation or the maximum amount allowable by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans, commonly referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for the Sponsor to make discretionary nonelective employer contributions. The Sponsor made no such contributions for the Plan years ended June 30, 2025 and 2024.
- c. *Automatic enrollment* - Employees eligible to participate in the Plan are automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment is 3% of eligible compensation on a pre-tax basis to be invested in specific pre-selected investment offerings based on a participant’s estimated time to retirement.
- d. *Participant accounts* - Each participant's account is credited with the participant’s contribution and discretionary Sponsor matching contributions as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of plan (continued):

- e. *Vesting* - Participants are immediately vested in their deferral contributions, rollover contributions, and qualified non-elective contributions, plus actual earnings thereon. Vesting in the Sponsor's contribution and the employee non-elective profit-sharing contribution portions of their accounts is based on years of continuous service, at a rate of 0% in year one and, after one year of service, increasing 20% annually until the participant is 100% vested after year six.
- f. *Notes receivable from participants* - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note receivable repayment terms generally may not exceed five years, except for loans used for a purchase of a primary residence. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined monthly, is set at 1% above the prime rate, as defined, and balances as of June 30, 2025, range from 4.25% - 9.50%. Principal and interest are paid ratably through monthly payroll deductions. Participants may only have two outstanding loans at a time.
- g. *Payment of benefits* - Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 59 ½. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the Internal Revenue Code ("IRC"). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy. If the value of the vested account balance does not exceed \$5,000, then a lump-sum distribution will be made automatically. Benefits paid to participants include corrective distributions which consist of contributions refunded to participants during the Plan year. Corrective distributions were approximately \$1,000 and \$4,000 for the Plan years ended June 30, 2025 and 2024.
- h. *Forfeited accounts* - Any forfeiture will be first used to reduce administrative expenses. Any remaining forfeitures are then used to reduce employer contributions. If a terminated participant returns to full-time employment within five years, the Sponsor reinstates the participant's account. For the Plan years ended June 30, 2025 and 2024 there were no forfeited nonvested accounts.

Note 2 - Summary of significant accounting policies:

Basis of accounting - The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Note 2 - Summary of significant accounting policies (continued):

Use of estimates - The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value, except for common/collective trusts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The common/collective trusts are not classified in the fair value hierarchy, however, as a practical expedient, the fair value is measured at Net Asset Value (“NAV”) per share of the underlying assets as traded in an exchange or active market. The 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed as they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits - Benefit payments to participants are recorded when paid. As of June 30, 2025 and 2024, there were no distributions approved that were not disbursed prior to year-end.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events - Subsequent events are evaluated through the date of the independent auditors' report, which is the date the financial statements were available to be issued and determined that no material subsequent events require an estimate to be recorded or disclosed as of the Plan year ended June 30, 2025.

Note 3 - Fair value:

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in techniques used for assets measured at fair value.

- *Mutual funds:* Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 - Fair value (continued):

- *Common/collective trusts:* The common trusts maintained by ADP Retirement Trust Services, LLC (“ADPRTS”) a party in interest, are pools of investments of which the Plan buys and sells units of participation that generally imitate established mutual funds. The underlying investments consist of common trusts which hold fixed income instruments as well as money market instruments. The Plan’s valuation estimates are based on the contract and market values of the underlying investments using the practical expedient. Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the common trust, ADPRTS reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities’ liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies of assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Certified investments:

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivables from participants for the Plan years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ADPRTS, the trustee of the Plan.

Note 5 - Party-in-interest transactions:

Certain Plan investments are units in mutual funds and common/collective trusts managed by ADPRTS. ADPRTS is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

ADPRTS provides certain administrative services to the Plan pursuant to an agreement between the Sponsor and ADPRTS. ADPRTS receives revenue from mutual fund service providers for services that ADPRTS provided to the funds. This revenue is used to offset certain amounts owed to ADPRTS for administrative services to the Plan.

Note 5 - Party-in-interest transactions (continued):

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by ADPRTS from such mutual fund service providers exceeds the amount owed under the agreement, ADPRTS remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or the Sponsor may make a payment to ADPRTS for administrative services not covered by revenue sharing.

Notes receivable from participants represent a portion of the Plan's receivables. These transactions also qualify as party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6 - Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 - Income tax status:

Effective August 1, 2022, the Plan adopted the non-standardized pre-approved profit sharing/money purchase/CODA plan established by Automatic Data Processing, Inc. ("ADP") in accordance with the IRS Cycle 3 restatement deadline. The pre-approved plan obtained an opinion letter on October 6, 2020, in which the IRS stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. The Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Through July 31, 2022, the Plan adopted the prototype, non-standardized profit-sharing plan established by ADP. The prototype plan obtained an opinion letter on April 12, 2014, in which the IRS stated that the form of the prototype plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has adopted amendments since adopting the prototype plan, the Plan administrator believes that the Plan was designed and operating in compliance with the applicable requirements of the IRC.

Note 7 - Income tax status (continued):

The Plan has adopted provisions under the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act"), the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE Act"), and the SECURE 2.0 Act of 2022 to comply with new laws or regulations and intends to formally amend the Plan to incorporate the provisions in accordance with applicable law and IRS guidance.

Note 8 - Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Reconciliation to Form 5500:

Certain amounts reported on Form 5500 differ from the financial statements due to classification differences. Stale check refunds of \$10,000 were reported as other income on Form 5500 but are presented as a reduction of benefit payments in the accompanying financial statements.
