**Detailed Explanation of Reasonable Cause**

The undersigned, the current Plan Administrator/Executor of the Estate of the deceased Plan Administrator, respectfully requests that the penalties associated with the delinquent filing of the Form 5500-SF for the plan year ending 10/31/2024 listed above be waived due to reasonable cause.

The delinquency was caused by circumstances beyond the control of the plan, specifically.  
**The unexpected death of the owner of the business and the sole Plan Administrator.**

**1. Identity of Deceased:**

**Name:** Fred S. Glick  
**Date of Death:** 4/22/2024

**2. Impact on Filing Capability:**

- The deceased owner, [*Fred S. Glick*], was the **Sole Proprietor/Principal Officer** of the sponsoring business and also the designated **Plan Administrator** for the Plan.
- The owner was the **only individual** responsible for and with knowledge of the required Form 5500 filing procedures, access to the necessary plan records, and the authority to electronically sign and submit the return.
- The due date for the Form 5500 (including extensions) was **August 15, 2025**. This date fell immediately following, or during the period when, the business operations were temporarily halted and the estate administration process was beginning.
- As a direct result of the death, there was an unavoidable period during which no individual was legally authorized or practically able to gather the necessary data, engage professional assistance, or file the required return.


**3. Corrective and Prudent Action:**

- The Executor of the Estate/Successor Plan Administrator, *Daniel Glick*, acted with ordinary business care and prudence to rectify the failure as soon as legally and practically possible.
- **Timeline of Corrective Action:**
  - 10/1/2024: Legal authority (Executor/Successor Administrator) was granted.
  - 12/1/2024: A Certified Public Accountant (CPA) or Third-Party Administrator (TPA) was immediately engaged to assess the plan's filing obligations.
  - 12/1/2025: All necessary documentation was gathered, and the delinquent Form 5500 was prepared.
- The Form 5500 for the plan year 2023 (PYE 10/31/2024) is now being submitted concurrently with this request for penalty relief, demonstrating a commitment to compliance once the administrative and legal hurdles following the owner's death were overcome.

We believe that the failure to file on time was due to reasonable cause and not willful neglect. We respectfully request a waiver of all applicable late-filing penalties.
