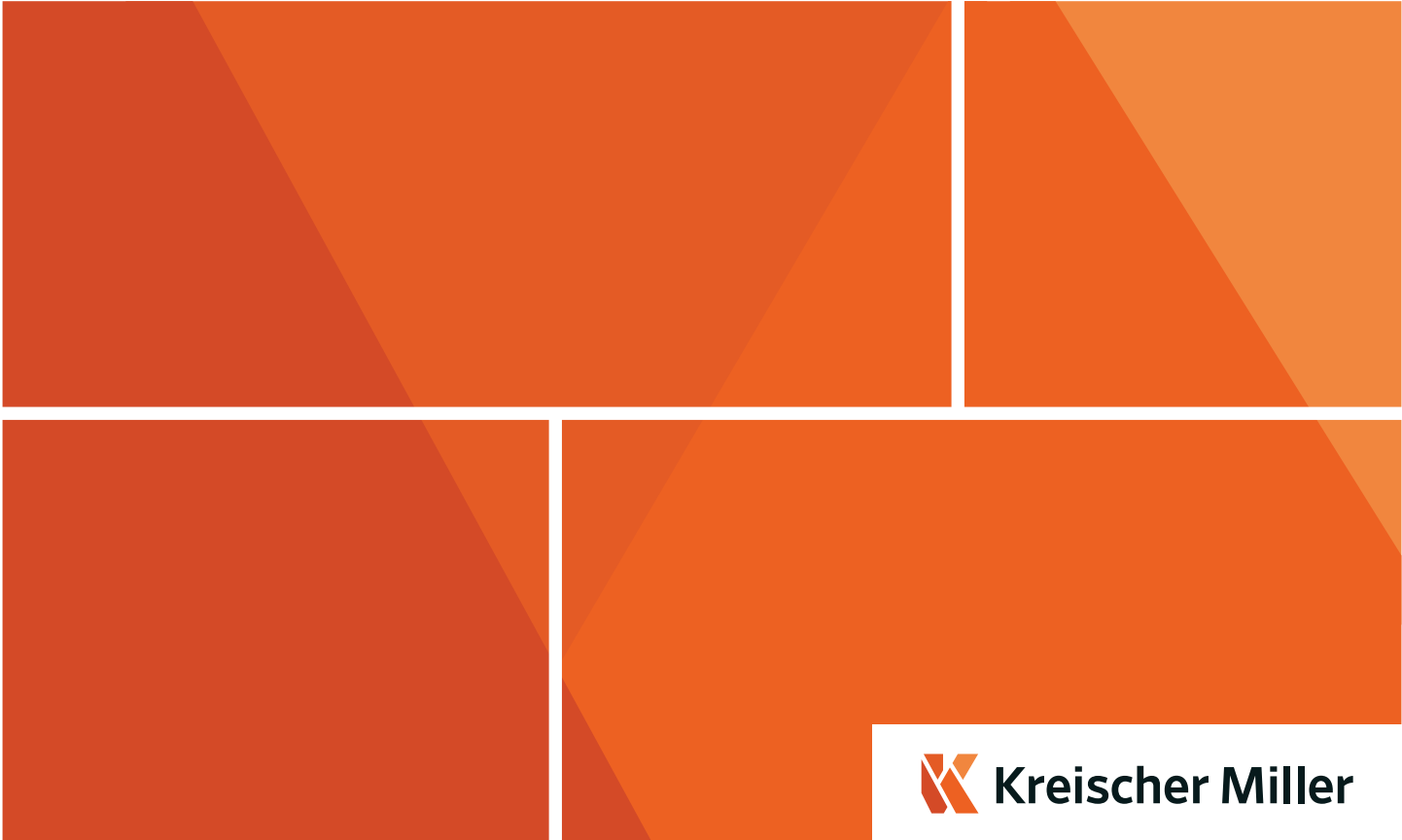

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of J.W. Pepper & Son, Inc. 401(k) Savings and Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

(1) Description of Plan

The following description of the J.W. Pepper & Son, Inc. 401(k) Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed 401(k) defined contribution plan covering substantially all employees of J.W. Pepper & Son, Inc. (the Company). Employees who are anticipated to be credited with 1,000 hours of service in a twelve-month period are eligible to participate in the Plan after six months of employment and age 21. Service with a predecessor employer who was acquired by the Company will be considered as service under the Plan for purposes of determining eligibility and vesting years of service with respect to certain employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees are responsible for oversight of the Plan.

Effective September 1, 2024, employees who are 21 and anticipated to reach 1,000 hours may begin deferring into the Plan on the first day of the month following their employment date and become eligible for other contributions on the first day of the next quarter after completing six months of service. Employees who are not anticipated to reach 1,000 hours may participate in the plan, for all contribution types, on the first day of the next quarter following attaining age 21 and completing a year of service, as defined.

Contributions

Each year, eligible participants may contribute up to 85% of their annual compensation to the Plan up to a maximum as set by law. All eligible employees will automatically be enrolled in the Plan and will have 2% withheld as an elective deferral upon entry to the Plan. Affected employees include all eligible employees hired on or after January 1, 2010, or who on the effective date had not made an affirmative election of non-participation in the Plan or were contributing less than 2%. Eligible participants may also make catch-up contributions up to a maximum as required by law. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants may also defer a portion of their compensation as an after-tax Roth contribution.

The Company may make a discretionary matching contribution to the Plan. Matching contributions are determined annually. In 2025, the discretionary matching contribution was 25% of participant contributions up to 7.5% of compensation. The Company may make an additional discretionary contribution. There were additional discretionary contributions made in 2025 and 2024 of \$300,000. In order to receive profit sharing contributions, participants must complete 1,000 hours of service and be employed at the end of the year unless employment ends due to retirement, death, or disability. The Company may also make Qualified Non-elective contributions.

Contributions, Continued

Effective September 1, 2024, participants who are first credited with an hour of service after August 1, 2025 that are automatically enrolled and do not affirmatively elect a deferral rate will have their deferral rate automatically escalated by 1% each year to a maximum rate of 5%.

Participant Accounts

Each participant's account is credited with the participant's elective deferral, the Company's matching contributions and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and in all Company contributions, plus the actual earnings (losses) thereon.

Notes Receivable from Participants

Loans are available to participants subject to plan administrator approval. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. Loans must be repaid with interest within five years unless the loan is used to buy, build, or substantially rehabilitate the borrower's principal residence. The Plan allows participants to have only three loans outstanding at a time and only two loans may be approved in the same plan year.

At June 30, 2025, interest rates on outstanding loans ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of employment, a participant is entitled to receive, as a lump sum payment, the entire amount of the vested interest in his or her account. Other forms of benefit payment may also be available. Participants may take certain in-service withdrawals including hardship withdrawals. The Plan also allows for automatic distributions to certain terminated participants whose vested account balances are less than \$7,000.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies using information provided by the third-party administrators and the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If the participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default based upon the terms of the Plan Document, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan Document. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through January 20, 2026, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end investments that are registered with the Securities and Exchange Commission. Registered investment companies are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a trust company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line item presented in the statements of net assets available for benefits.

There were no significant transfers among investment levels during the years ended June 30, 2025 and 2024.

(4) Investment Contracts

The Plan has an investment in the Morley Stable Value Fund, a collective investment trust fund (the Fund). The Fund invests primarily in stable value investment contracts with insurance companies, banks and other financial institutions. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive payments. Participants may generally redeem units on a daily basis at NAV. NAV represents contributions made to the Fund plus earnings less participant withdrawals.

Certain events may limit the ability of the Fund to transact at NAV. Such events may include, but are not limited to, Plan withdrawals requested without appropriate notice to the Fund or the Plan ceases to meet certain tax qualifications as well as certain market events. The plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at NAV with participants.

(5) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants held at June 30, 2025 and investments at fair value held at June 30, 2024, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution.

(6) Related Party and Party-In-Interest Transactions

Certain Plan investments are investments with Charles Schwab Trust Bank, the custodian of the Plan. Conrad M Siegel Inc. (Conrad) is the recordkeeper and MMA Securities LLC is the investment advisor of the Plan. Therefore, any transactions with the custodian, recordkeeper and investment advisor qualify as party-in-interest transactions. Additionally, loans to participants are also considered party-in-interest transactions. Total expenses to party-in-interests was \$38,714 for the year ended June 30, 2025. Fees incurred by the Plan for investment management services are included in net appreciation in the fair value of investments.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(8) Income Tax Status

The Plan uses a prototype document sponsored by Conrad. Conrad received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan's Trustees and the Plan's third-party administrator believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment instruments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment instruments, it is at least reasonably possible that changes in the values of investment instruments will occur in the near term and that such a change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
