INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of the
Bricklayers and Allied Craftworkers
Local No.1 PA/DE Annuity Plan

Opinion

We have audited the financial statements of the Bricklayers and Allied Craftworkers Local No.1 of PA/DE Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Bricklayers and Allied Craftworkers Local No.1 of PA/DE Annuity Plan as of April 30, 2025 and 2024, and changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

APRIL 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF PLAN

The following description of the Bricklayers and Allied Craftworkers Local No.1 of PA/DE Annuity Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan in the form of an Annuity Fund. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - The Plan is funded primarily by employer contributions at rates specified in the collective bargaining agreement. The contribution rates ranged from \$3.38 to \$13.23 per hour for the year ended April 30, 2025 and \$3.13 to \$12.73 per hour for the year ended April 30, 2024.

Participant Accounts - Each participant's account is adjusted for its allocation of: (1) investment earnings or losses, as defined; (2) employer contributions made for that account; and (3) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payment of Benefits - Upon termination of service, death, disability, early retirement, or normal retirement a participant may elect to receive either a lump sum amount or periodic monthly or annual installment benefits in accordance with the Plan's Trust documents.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The financial statements are prepared using the accrual basis of accounting.

Revenue Recognition - The Plan is funded by contributions from participating employers under the terms of collective bargaining agreements (CBA). Employer contributions are accounted for as exchange transactions. The contributions are due on a monthly basis. It is the policy of the Trustees to pursue monies due.

Contributions Receivable - Contributions due and not paid prior to the year-end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investments - Investments in mutual funds and short term investments are carried at fair value, which represents the net asset value of the funds as of the last business day of the year.

Participant Accounts - Each participant's account is credited with employer contributions and Plan earnings.

Payments of Benefits - Benefit payments to participants are recorded upon distribution.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 3. TAX STATUS

The Plan obtained its latest determination letter on November 22, 2013 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) of the Internal Revenue Code and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a).

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, tax years will remain open for three years; however, this may differ depending upon circumstances of the Plan.

NOTE 4. PRIORITIES UPON TERMINATION

In the event of the termination of the Agreement and Declaration of Trust, the Trustees shall apply the Plan to pay or to provide for the payment of any and all obligations of the Plan and shall distribute and apply any remaining surplus in such manner as will, in their opinion, best effectuate the purpose of the Plan, provided however, that no part of the corpus or income of said Plan shall be used for or diverted to purpose other than for the exclusive benefits of the employees of the employers or their eligible dependents, or the administrative expenses of the Plan or for other payments in accordance with the provision of the Plan. Under no circumstances shall any portion of the corpus or income of the Plan, directly or indirectly, revert to accrue to the benefit of any contributing employer or the Union.

NOTE 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 5. FAIR VALUE MEASUREMENTS (continued)

(A) In accordance with Subtopic 820-10, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statement of Net Assets Available for Benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period.

For the years ended April 30, 2025 and 2024 there were no transfers in or out of Levels 1, 2, or 3.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks such as economic, interest rate, market and sector risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

NOTE 7. RELATED PARTIES AND PARTIES IN INTEREST

The Plan shares Trustees and staff with a related entity, which include the Bricklayers benefit Plans (BBP). The staff are employees of BBP. Certain administrative expenses, such as payroll, benefits, taxes, rent and administrative expenses are paid by BBP. The Plan reimburses BBP for these expenses monthly through an administrative services agreement. The Plan paid to BBP \$249,395 and \$131,922 for its portion of this administrator fee for the years ended April 30, 2025 and 2024, respectively.

BBP collects delinquency contributions and interest for all the related entities and other funds during the year and then reconciles and makes payments to these funds. At April 30, 2025 and 2024, BBP had collected, processed, and paid out \$24,308 and \$67,044, respectively, to the Plan.

Certain plan investments are shares of mutual funds managed by Vanguard. Vanguard is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

The transactions above qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through December 12, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
