### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of the Seattle Country Day School Defined Contribution Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of August 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended August 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), my audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2025 and 2024, and for the year ended August 31, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In my opinion, based on my audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report —

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

I conducted my audits in accordance with auditing standards generally accepted in the United States of America (GAAS). My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of the Plan and to meet my other ethical responsibilities, in accordance with the relevant ethical requirements relating to my audits. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

**NOTE 1      DESCRIPTION OF PLAN**

The following description of the Seattle Country Day School Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of Plan provisions.

General

The Plan was created on September 1, 1988, and was most recently restated on June 1, 2020, with a retroactive effective date of September 1, 2014. The Plan is a 403(b)-plan covering substantially all employees of Seattle Country Day School (the School). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The School is the Plan's sponsor and serves as plan administrator. The Plan Trustees are responsible for oversight of the Plan, which includes determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the School's Board of Directors.

The Plan was amended, effective February 1, 2024, to allow for Plan loans. The Plan was also amended, effective October 1, 2024, to permit in-service distributions for those who are at least age 59.5 years old.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

Eligibility

Employees excluded from participating in the Plan include employees subject to a collective bargaining agreement, independent contractors, and employees who normally work less than 20 hours per week. Employees of the School are eligible to participate in a different 403(b) plan maintained by the School (the "Seattle Country Day School Tax Deferred Annuity Plan") as soon as administratively feasible on or after the employee's date of hire, which is deemed by Plan management and their ERISA counsel to satisfy the Universal Availability requirement of maintaining a 403(b) plan.

Employees of the School are eligible to participate in this Plan, unless excluded, according to the following stipulations:

- Employee elective deferrals – upon completion of 12 months of service, and if so elected, with a required 4 percent deferral;
- Employee mandatory 4 percent deferrals – upon completion of 2 years of service;
- Employer matching – upon reaching age 18 years old and completion of 12 months of service.

Contributions

Employee deferrals – Participants may elect to contribute pre-tax 4% of eligible compensation to the Plan, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. As noted above under Eligibility, Participants may elect to contribute 4 percent of their eligible compensation after being employed by the School for a period of 12 months and are then required to contribute 4 percent after being employed for a period of 2 years. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up. Participants may also roll over eligible amounts from other qualified plans.

Employer non-elective matching – The School provides a matching contribution equal to 175% of the mandatory employee contribution of 4% for each eligible employee with 10 years or less of service, and a matching contribution equal to 200% of the mandatory employee contribution of 4% for eligible employees with at least 10 years of service. The contribution is paid at each payroll.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's respective account is credited with the participant's contributions and School non-elective matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with withdrawals, and an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options at any time.

Vesting

Participants are immediately 100% vested in their deferral contributions, plus actual earnings thereon. A participant is immediately 100% vested in employer non-elective matching contributions.

Notes Receivable from Participants

Effective February 1, 2024, the Plan permits participants to borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participant's account. The loan interest rate is determined by the plan administrator. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years in accordance with Plan provisions. Participant notes are valued at their outstanding principal balance plus accrued and unpaid interest.

Payment of Benefits

On termination of service due to death, disability, retirement, or voluntary termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or an installment distribution. Effective October 1, 2024, in-service distributions are permitted for those who are at least 59.5 years of age.

Forfeitures

At August 31, 2025, and 2024, forfeited non-vested accounts totaled \$0 and \$0, respectively. Any balance available in these accounts may be used to pay administrative expenses of the Plan, or to reduce future School contributions to the Plan.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 31, 2025 and 2024.

Contributions

Contributions from participants are recorded as they are withheld from the participants' wages. Contributions from the School are recorded in the period in which the related participant contributions are due.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses that are paid by the School are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments

Subsequent Events

The Plan has performed an evaluation of subsequent events through January 16, 2026, which is the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• Quoted prices for similar assets or liabilities in active markets;</li><li>• Quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• Inputs other than quoted prices that are observable for the asset or liability;</li><li>• Inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2025 and 2024.

**Registered investment companies:**

These investments are registered investments ("mutual funds") held through a custodial account with the custodians. Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Non-fully benefit-responsive investment contracts:**

Participants who have elected the traditional annuity contracts have entered into contracts with TIAA, including those in the format of Retirement Annuities ("RA"). TIAA maintains contributions in the general account and participant accounts are credited with a guaranteed minimum rate of interest on the underlying investments and charged with participant withdrawals and any administrative expenses. Contracts buy a contractual or guaranteed amount of future benefits. RA contract account balances may only be withdrawn in 10 annual installments and therefore are not considered to be fully benefit responsive.

All traditional non-benefit responsive annuity contracts are included in the financial statements at fair value as reported by TIAA, which is consistent with management's determination of fair value using the income approach.

**NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)**

Variable annuity accounts:

The TIAA and CREF Variable Annuity Separate Accounts, are separate accounts of TIAA, an insurance company, and are registered with the SEC under the Securities Act of 1933 and the Securities Exchange Act of 1934. Investments in the TIAA and CREF separate accounts are stated at fair value as determined in accordance with the policies and procedures reviewed by the Investment Committee of TIAA. The value of the units held in the separate accounts is calculated using the net asset value per share of the underlying investments as a readily determinable fair value.

For the Real Estate Account, the underlying real estate holdings are valued principally utilizing external appraisals and involve significant judgment. Appraisals can be subjective in certain respects and rely on a variety of assumptions and conditions at the respective property or in the market in which the property is located, which may change materially after the appraisal is conducted.

The TIAA and CREF Variable Annuity Separate Accounts provide participants with a liquidity guarantee enabling the account to have funds available to meet participant redemption, transfers, or cash withdrawals. TIAA and CREF guarantee that participants can redeem their accumulated unit value determined after their transfer or cash withdrawal request is received in good order.

**NOTE 4 CERTIFIED INVESTMENTS INFORMATION**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at August 31, 2025 and 2024, and net appreciation in fair value of investments and interest and dividend income for the year ended August 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF (the custodians of the Plan), qualified institutions. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

**NOTE 5 PLAN TERMINATION**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants would remain 100% vested in any employer contributions.

**NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments consist of investments managed or sponsored by TIAA and CREF, the custodians of the Plan and therefore, these transactions qualify as exempt party-in-interest transactions.

Certain investment related fees are recorded net of investment gains and losses in the statement of changes in net assets available for benefits and qualify as exempt party-in-interest transactions. Direct administrative expenses paid by the Plan to TIAA and CREF and other service providers also qualify as exempt party-in-interest transactions.

Loans to participants also qualify as exempt party-in-interest transactions.

**NOTE 7      TAX STATUS**

The School has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 7, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document; however, the plan administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8      RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
