### **Scope and Nature of the ERISA Section 103(a)(3)(C)**

We have performed an audit of the accompanying financial statements of GCSS, Inc DBA Incommunity 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **NOTE A – DESCRIPTION OF THE PLAN**

The following description of the **GCSS, Inc. D/B/A InCommunity** (the **Organization**) **401(k) Plan** (the **Plan**) provides only general information. Participants should refer to the **Plan** document for a more complete description of the **Plan's** provisions.

**General**

The **Plan** is a defined contribution plan covering all full-time employees of the **Organization**, as defined in the **Plan** document, who are age twenty-one or older. The **Plan** is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year participants may contribute pretax eligible compensation up to the maximum allowed by the Internal Revenue Code (the IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the **Plan**. Employees are eligible for matching contributions after satisfying certain age and service requirements. The **Organization** contributes a match equal to 100% of the first 3% of compensation plus 50% of salary deferrals between 3% and 5% of participant compensation. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, allocation of the **Organization's** contribution and an allocation of the **Plan** earnings or losses. Each participant is charged with an allocation of investment expenses, administrative expenses, and fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the **Plan** document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, participants or their beneficiaries may elect to receive either a lump-sum amount equal to the value of the participants' vested interest in their accounts, or an amount in installments. For termination of service for other reasons, participants may receive the value of the vested interest in their accounts as lump-sum distributions. Distributions may also be taken by participants prior to termination of service in the event of financial hardship, as defined by the plan document. If a qualified domestic relations order is received by the **Plan** administrator, all or a portion of the participant's account balance may be used to satisfy the obligation.

**Forfeited Accounts**

During the years ended December 31, 2023 and 2022, additions to forfeited nonvested accounts including earnings totaled \$40 and \$813. These accounts may be used to reduce future employer contributions or pay plan expenses. During the years ended December 31, 2023 and 2022, forfeited nonvested accounts used to pay Plan expenses totaled \$0 and \$1,494, respectively. At December 31, 2023 and 2022, forfeited nonvested accounts totaled \$2,208 and \$2,168, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the **Plan** have been prepared using the modified cash basis of accounting, which is a basis of accounting other than generally accepted accounting principles. Accordingly, investment income is recognized when received, disbursements are recognized when made, and employer and participant contributions, if any, are accrued at year-end.

**Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires the **Plan** administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Accounting for Uncertainty in Income Taxes**

The **Plan** recognizes material amounts of uncertain tax positions as income tax expense. The **Plan** recognizes accrued interest and penalties associated with uncertain tax positions as part of deductions from net assets.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a timely transaction with an independent buyer in the principal market, or in the absence of a principal market, the most advantageous market for the asset or liability (see Note D). Money market funds and cash equivalents are valued at cost, which approximates fair value (see Note D).

**Payment of Benefits**

Benefit payments are recorded when paid by the **Plan**.

**Administrative Expenses**

Pursuant to provisions of the **Plan**, administrative expenses incurred in the administration of the **Plan** may be paid by the **Plan** or the **Company**. The administrative expenses paid from **Plan** assets either shared by all participants or charged directly to the account of the participant on whose behalf the expense was incurred. Currently, substantially all administrative expenses are paid by the **Plan**.

**Subsequent Events**

The **Plan** administrator has evaluated subsequent events that have occurred up through December 22, 2025, the date the financial statements were available to be issued. No material subsequent events have occurred since December 31, 2023 that required recognition or disclosure in the current period financial statements.

The **Plan** administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the **Plan's** independent auditors did not perform any auditing procedures with respect to the following information certified by Fidelity Management Trust Company (Fidelity) as complete and accurate, except for comparing such information with information included in the **Plan's** financial statements and supplemental schedule:

- Investments at fair value as shown in the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments, interest, and dividends as shown in the accompanying statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2023 and 2022.
- All investment-related information in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2023.

**NOTE D – FAIR VALUE MEASUREMENTS**

FASB ASC 820, Fair Value Measurement, provides the framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Following is a description of the valuation methodology used for investment assets measured at fair value.

*Mutual Funds:* The daily closing price as reported by the fund is used to estimate fair value. Mutual funds held by the **Plan** are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the **Plan** are deemed to be actively traded. A transfer into certain funds is not permitted if a prior transfer was made out of the same fund in the previous 30 days.

All of the **Plan's** investments at fair value are mutual funds and are classified within the fair value hierarchy in Level 1.

**NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The **Organization** serves as the trustee and the **Plan's** administrator.

Certain **Plan** investments were managed by **Fidelity**. **Fidelity** is the custodian as defined by the **Plan** and, therefore, these transactions qualify as party-in-interest transactions.

**NOTE F – PLAN TERMINATION**

Although they have not expressed any intent to do so, the **Companies** have the right under the **Plan** to discontinue its contributions at any time and to terminate the **Plan** subject to the provisions of ERISA. In the event of **Plan** termination, participants will become 100% vested in their accounts.

**NOTE G – TAX STATUS**

The Internal Revenue Service has determined and informed Fidelity, by a letter dated June 30, 2020, that the **Plan** and related trust are designed in accordance with applicable requirements of the IRC. Although the **Plan** has been amended since receiving the determination letter, the **Plan** administrator and the **Plan's** tax counsel believe that the **Plan** is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that that **Plan** is qualified, and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the **Plan's** financial statements.

For the years ended December 31, 2023 and 2022, the **Plan** administrator believes there were no material amounts of uncertain tax positions. Additionally, there were no amounts of interest or penalties recognized in the statements of net assets available for benefits (modified cash basis) as of December 31, 2023 and 2022 or the statements of changes in net assets available for benefits (modified cash basis) for the years then ended. Further, the year ended December 31, 2019 and all years subsequent remain subject to examination.

**NOTE H – RISKS AND UNCERTAINTIES**

The **Plan** invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**NOTE I – DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2023, the **Organization** failed to remit certain contributions to the **Plan** in a timely manner, according to Department of Labor regulations in the aggregate amount of \$124,838. Participant contributions totaling \$118,464 were remitted prior to December 31, 2023, with the remaining balance of \$6,374 submitted subsequent to year end,

During 2022, the **Organization** failed to remit certain contributions to the **Plan** in a timely manner, according to Department of Labor regulations in the aggregate amount of \$77,706. Participant contributions totaling \$59,138 were remitted prior to December 31, 2022, with the remaining balance of \$18,568 submitted subsequent to year end.
