## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
Key Capture Energy LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Key Capture Energy LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Reliance Trust Company, as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

**NOTE 1. DESCRIPTION OF PLAN**

The following description of the Key Capture Energy LLC 401(k) Plan (the Plan) provides general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering all eligible employees of the Key Capture Energy LLC (the Company). The Plan was established on December 1, 2006, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Each year participants may contribute the maximum amount allowed under the Internal Revenue Code (IRC) of pre-tax and Roth contributions. If a participant elects to contribute to the Plan, they may contribute from 1% up to 90% of their eligible compensation. Participants' contributions to the Plan are made by means of payroll deductions during each regular payroll period. Participants direct investments of their contributions into various investment options offered by the Plan. Employees may also choose to end their participation in the Plan at any time.

The Company may make discretionary and nonelective contributions. The Company provided a safe harbor matching contribution equal to 100% of your salary deferrals that do not exceed 4% of your contributions. Under a safe harbor plan, safe harbor 401(k) matching contributions are immediately 100% vested. There were no discretionary contributions for 2024.

Rollover contributions from other qualified plans and individual retirement accounts are allowed by the Plan.

**Participant accounts** - Each participant's account is credited with their own salary deferral contributions, their rollover contributions from other plans and the Company's contributions as well as investment earnings (losses) within the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are vested immediately in their deferred contributions and their rollover contributions plus actual earnings (losses) thereon, as well as the Company's contribution plus actual earnings (losses) thereon. Vesting in the Company's discretionary contributions portion and net earnings (losses) is based on years of continuous service. A participant is 100% vested after six years of credited service.

## **NOTE 1. DESCRIPTION OF PLAN (continued)**

**Notes Receivable from Participants** - Participants may receive loans of up to 50% of their vested account balances. Amounts may be borrowed between \$1,000 and \$50,000, utilizing the participant's remaining account balance as security for the loan. The interest rate for any loan is calculated at current interest rates at the time of the loan. Loans must be repaid through payroll deductions within five years unless the loan is used for the purchase of the participant's primary residence, in which case the loan may be repaid under an alternative time frame as determined by the plan administrator. Participants who do not repay their loans under certain circumstances, as defined in the Plan, will be deemed to have received a distribution for federal income tax purposes under the Plan. Principal and interest are paid ratably through weekly payroll deductions.

**Hardship Withdrawals** - In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service rules, participants are permitted to receive hardship withdrawals of a portion of their own elective deferrals.

**Payment of Benefits** - On separation of service due to death, disability, termination or normal retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments over a period of not more than your assumed life expectancy (or assumed life expectancies of you and your beneficiary) or partial withdrawals of at least \$500. In the event of a participant's death or disability before termination of employment and before distribution of benefits has begun, a participant will become 100% vested and the amount of the participant's account balance will be payable in a single lump-sum to the participant's beneficiary(ies).

Participants may withdraw their vested account balances once they reach age 59½. Participants may also withdraw their rollover contributions in the Plan at any time and at any age.

Other distribution methods under the Plan are available to beneficiaries depending on vested account balances.

**Forfeited Accounts** - There was \$33,842 of forfeited non-vested account balances that were used to reduce employer contributions and Plan expenses during 2024. At December 31, 2024, forfeited non-vested accounts totaled \$3,586.

**Investment Options** - Participants direct the investment of all contributions within their own accounts into various investment options consisting of various mutual funds and a common/collective trust account offered by the Plan.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States of America.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Use of Estimates** - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America (GAAP), requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. In the event a participant separates from employment while any loan is outstanding, the unpaid balance and any interest due thereon shall become due and payable by the end of the cure period.

**Payments of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Participants of the Plan are charged fees by the custodian for the processing of loans and distributions from the Plan. Investment related expenses are included in net change in fair value of investments.

Investment advisory fees, as well as other administrative expenses of the Plan, such as third party administrator fees and Plan audit fees, are paid by the employer.

**NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN**

**NOTE 4. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Reliance Trust Company is the investment custodian of the Plan as of December 31, 2024. As a provider of services to the Plan, Reliance Trust Company is considered a party-in-interest as defined under ERISA. Reliance Trust Company receives fees for their services from the employer.

Notes receivable from participants totaled \$17,188 at December 31, 2024 and interest income on notes receivable from participants totaled \$1,227 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6. TAX STATUS**

Management believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The Plan, as of December 31, 2018, has been re-stated under the Defined Contribution Pre-Approved Plan of the Plan's third-party administrator, Reliance Trust Company. Their latest determination letter for its preapproved plan is dated October 6, 2020, which the Company is relying on with respect to qualification of its Plan. Although the Plan has been amended since the effective date of the determination letter, the plan administrator believes the Plan is qualified and the related trust is tax-exempt based on the advice of Reliance Trust Company.

## **NOTE 6. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America, require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits. Given recent volatility in the financial markets, it is reasonably possible that investment values could de-cline in subsequent periods.

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## **NOTE 8. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 8. FAIR VALUE MEASUREMENTS (continued)**

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued using the NAV per share provided by the investment fund's trustee and is determined by the fair value of the underlying assets within the portfolio. NAV is used as a practical expedient to estimate fair value.

The Plan has evaluated subsequent events through January 7, 2026, which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
