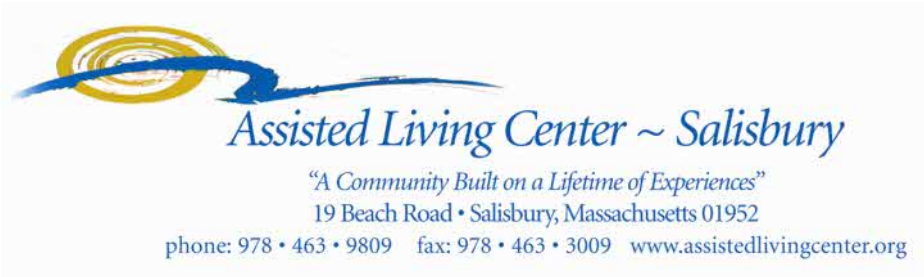

On 11.22.24 I reached out to ADP with concerns with my administration of my 401K. I could not log in to my account to see that Employees had been terminated properly off the system. I had never logged in the whole 18 months that we have had the 401K.

While doing this, I came across the 550 Filing alert for which I was unaware that I had needed to do. This year 2023 was our First year having the 401K, and I was under the impression through my sign-up process conversations that ADP took care of all of the filings, and it was simple for us to administrate this through their company.

I am finding out now that I sincerely misunderstood this. They at ADP have now explained to me that YES, they do the actual filing, but I also have some responsibilities leading into this before they can accommodate the filing.

We are a 30 bed non-profit Senior Assisted Living and we really cannot afford the penalties that my ignorance of this may have caused.

I am requesting an abatement of Fines and any Penalties that I may have accrued. I promise you that this will never be late again. I am aware of the responsibilities of our company's part in the 5500 filing and the deadline that I must meet moving forward.
