Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Omni Fed LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2024 (inception) through December 31, 2024 (the year then ended), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Omni Fed LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and for the year then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Omni Fed LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Omni Fed LLC (the Company). The Plan was created as a result of a spin-off from the Justworks Retirement Savings Plan (the former PEO Plan), a multiple-employer plan sponsored by Justworks Employment Group, LLC. The Plan effective date was January 1, 2014. The Plan had no activity prior to 2024.

Effective January 1, 2024, the Plan was restated and the Company adopted a prototype plan from Principal Financial Group, for the benefit of its eligible employees. The spin-off was completed in January 2024, and the account balances of eligible participants attributable to Omni Fed LLC were transferred from the former PEO Plan to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee and Company management periodically meet with the Plan's investment advisor to determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Company has the responsibility for remittance of participant and employer contributions, appointing an administrator to administer the Plan, and determining funds available for investment under the Plan. The Company pays for a portion of the administrative expenses for the Plan.

Eligibility Requirements

All employees are eligible to participate in the Plan except for nonresident aliens receiving no earned income and employees covered by a collective bargaining agreement. Employees are eligible to participate in the Plan on the first day of the month following their hire date, with a requirement of one month of service minimum to participate.

Contributions

Participants may elect to contribute a percentage or a fixed amount of their pre-tax annual compensation, as well as make Roth contributions, as defined in the Plan. The amount that may be contributed is limited by the Internal Revenue Code (IRC) applicable to the type of plan. The Plan does not provide for automatic enrollment. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Eligible participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, a participant directed brokerage account, and a guaranteed investment contract as investment options for participants.

For the year ended December 31, 2024, the Company made a non-QACA safe harbor matching contribution equal to 100 percent of participant deferrals up to 3 percent of eligible compensation, plus an additional 50 percent of participant deferrals greater than 3 percent but not more than 5 percent of eligible compensation. In addition, the Company may make discretionary profit-sharing contributions annually. No profit-sharing contribution was made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the participant. Allocations are based on participant earnings or individual account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon as well as the non-QACA safe harbor matching contribution. Other discretionary employer contributions are subject to the following vesting schedule:

All participants are also 100 percent vested if termination is due to disability, death or early retirement.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and do not require spousal consent. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive the value of the participant's vested interest in his or her account as a lump sum amount, or substantially equal annual or more frequent installments as designated by the participant or beneficiary.

Forfeited Accounts

Forfeitures may be used in accordance with Plan document. The forfeitures balance and activity as of and for the year ended December 31, 2024 was immaterial.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Financial Statement Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

As permitted by U.S. generally accepted accounting principles, the Plan uses net asset value (NAV) as a practical expedient to determine the fair value of certain investments, and these investments have not been classified in the fair value hierarchy.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's account and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant does not make loan repayments within 90 days after they are due, the loan is considered to be in default, the entire loan principal and interest becomes immediately due and payable, and the delinquent participant's note receivable is recorded as a benefit payment based on terms in the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor (DOL) or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses, including certain fees paid through revenue sharing arrangements, are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through December 18, 2025, the date the financial statements were available to be issued.

3. CERTIFIED FINANCIAL INFORMATION

Certain information related to investments disclosed in the accompanying financial statements as of December 31, 2024, the ERISA-required supplemental schedule of Form 5500 - Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company and the Delaware Charter Guarantee and Trust Company conducting business under the trade name Principal Trust Company, a member of the Principal Financial Group (collectively "Principal"), the custodian of the Plan. Notes receivable from participants and interest earned on notes receivable were certified by Principal Trust Company for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value focuses on the price that would be received to sell the asset or paid to transfer the liability regardless of whether an observable liquid market price existed (an exit price). The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – inputs to the valuation methodology are based upon unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, inputs other than quoted prices that are observable for the asset or liability, and market-corroborated inputs. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. Level 3 assets and liabilities measured at fair value are based on one or more of three valuation techniques (market, cost, or income approach). The market approach evaluates prices and other relevant information generated by market transactions involving identical or comparable assets or liabilities. The cost approach evaluates the amount that would be required to replace the service capacity of an asset (i.e., replacement cost). The income approach uses techniques that convert future amounts to a single present amount based on market expectations (including present value techniques, option-pricing models, and lattice models).

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value at December 31, 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. FAIR VALUE MEASUREMENTS (continued)

Self-directed brokerage account: Valued at the daily closing price as reported by the respective exchanges. Investments held within the Schwab Personal Choice Retirement Account (Schwab PCRA) consist entirely of publicly traded securities. Pricing and holding details are publicly available, and all securities are required to publish a daily NAV and transact at that price.

Pooled separate accounts: Valued daily at the NAV of the underlying investments at year end. NAV is used as a practical expedient to estimate fair value. The pooled separate accounts have various investment strategies. The funds seek to provide total return greater than or equal to comparable benchmark indices.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The fully benefit-responsive investment contract value as of December 31, 2024 is \$1,732,123.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a semi-annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material representation, or (4) a material amendment to the agreements without the consent of the issuer.

7. RELATED PARTY TRANSACTIONS

Principal Financial Group is the Plan's custodian (see Note 3). Plan assets include investments in pooled separate accounts and a guaranteed investment contract. The guaranteed investment contract is managed by Principal. As Principal is the Plan's custodian, transactions with the custodian qualify as party-in-interest transactions under ERISA.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

9. TAX STATUS

Effective January 1, 2024, the Plan adopted a non-standardized pre-approved profit sharing plan with CODA with an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the form of plan stated in that letter is acceptable for use by employers for the benefit of their employees under IRC Section 401. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

10. RISKS AND UNCERTAINTIES

The Plan invests in a combination of investment securities that are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

11. DELINQUENT PARTICIPANT CONTRIBUTIONS

DOL Regulation 2510.3-102(a) states, in part, that employee contributions must be remitted to the Plan as soon as they can be reasonably segregated from the employer's general assets. Lost earnings on \$4,398 of Plan contributions for the year ended December 31, 2024 are currently being calculated.

12. TRANSFER OF ASSETS

In connection with the establishment of the Plan, the Company elected to transfer the account balances of participating employees from the PEO-sponsored Justworks Retirement Savings Plan into the Plan. On February 7, 2024, assets with a fair value of approximately \$7,400,000 were transferred into the Plan. The transfer consisted primarily of mutual funds and collective trust funds.

This transfer is reflected in the accompanying statement of changes in net assets available for benefits as "Transfer into the Plan from Justworks Retirement Savings Plan." The transfer represents the initial funding of the Plan, and accordingly, the beginning net assets of the Plan were \$-0-.
