We have performed audits of the financial statements of Boyd Jones Construction Co. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following brief description of the Boyd Jones Construction Co. Profit Sharing Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Boyd Jones Construction Company and Subsidiaries (the Company).

Employees, excluding those covered by a collective bargaining agreement, are eligible to make pre-tax, designated after-tax Roth and other after-tax salary reduction contributions after attaining age 20 and completing three months of service. Participants are eligible for discretionary matching contributions after attaining age 20 and completing three months of service. Employees are eligible for discretionary profit-sharing contributions after attaining age 20 and completing one year of service with at least 1,000 hours and must be employed on the last day of the Plan year. Employees of certain divisions of the Company may not be eligible for profit-sharing contributions. Eligible employees may become participants on the first day of the month coinciding with or following the date on which entry requirements are fulfilled.

#### ***Contributions***

Participants may make pre-tax, designated after-tax Roth and other after-tax salary deferral contributions up to 100% of their annual compensation as defined by the Plan, up to the maximum dollar limits allowable by law. Employees who meet eligibility requirements are automatically enrolled in the Plan with an initial pre-tax salary deferral of 4%, which is increased by one percentage point annually on May 1, until it reaches a total of 15% of their eligible compensation. At any time, a participant may elect not to contribute or may change their deferral rate as allowed under Plan provisions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make discretionary matching and profit-sharing contributions. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching and profit-sharing contributions and (b) Plan earnings or losses; and (c) charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated among participants based upon each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon eligible compensation of eligible participants. Investments are maintained in individual member accounts managed by Ascensus, LLC, as an authorized representative for Ascensus Trust Company (Ascensus).

### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions credited to participants' accounts is based on years of continuous service. A participant is 100% vested after six years of credited services, beginning at 20% vested after two years and increasing 20% each year until 100% vested.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are made on a nondiscriminatory basis and are secured by the participant's account. Interest rates are established at the current prime rate plus 1% at the time of issuance. Principal and interest rates are paid ratably through weekly payroll deductions.

### *Payment of Benefits*

Upon termination, retirement, disability, or death the participant or beneficiary may elect to receive either a partial or lump sum payment equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to December 31, 2023) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Participants may also receive in-service distributions, as defined by the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Non-vested Company matching and profit-sharing contributions of terminated participants become forfeitures of the Plan. Forfeitures are valued as of the day the participant is terminated from the Plan. Forfeitures remain in the Plan and may be used to reduce future Company contributions or pay Plan expenses. As of March 31, 2025 and 2024, forfeited non-vested accounts totaled \$97,515 and \$28,711, respectively. During the years ended March 31, 2025 and 2024, \$13,615 and \$18,531 of forfeitures were used to reduce Company contributions and/or pay Plan expenses, respectively.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

### ***Other***

Audit fees are paid by the Company and are excluded from these financial statements. Investment management and recordkeeping expenses are paid by the Plan and are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through January 14, 2026, noting no items requiring disclosure.

### 3. Information Certified by Ascensus

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of March 31, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* The self-directed brokerage accounts include investments in common stocks, mutual funds and money market funds. The common stocks, mutual funds and money market funds are valued at the daily closing price reported on the active market on which the individual securities are traded.

*Common Collective Trust:* Valued at NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to serve as a practical expedient to estimate fair value as long as certain requirements are met. It is the Plan's assessment that this trust meets those requirements. Participants can redeem the trust at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of March 31, 2025 and 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.
