Independent Auditor's Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eppendorf North America, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of July 1, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period from January 1, 2025 to July 1, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of July 1, 2025 and December 31, 2024, and for the period from January 1, 2025 to July 1, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Notes to Financial Statements July 1, 2025

Note 1 - Description of Plan

The following description of Eppendorf North America, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution retirement plan covering all eligible employees of Eppendorf North America, Inc. (the "Company"). Employees covered by a collective bargaining agreement, leased employees, residents of Puerto Rico, and other employment classifications, as defined, are excluded from participating in the Plan. Participants are eligible to receive a profit sharing contribution provided that they have completed 1,000 hours of service, as defined, during the period. Eligible participants may enter the Plan on the first day of the month after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors is responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Effective July 1, 2025, the Company's Board of Directors made the decision to merge the Plan into the Eppendorf Holdings, Inc. 401(k) Plan.

Contributions

The Company may make discretionary profit-sharing contributions to the Plan as determined annually by the Company's Board of Directors. Discretionary profit-sharing contributions are allocated in the ratio that each eligible participant's compensation, as defined by the Plan, bears to the total compensation for all eligible participants for the period. For the period ended July 1 2025, the Company elected not to make a discretionary profit-sharing contribution to the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a money market fund as investment options for participants. Contributions are subject to Internal Revenue Code ("IRC") limitations.

Participant accounts

Each participant's account is credited with allocations of the Company's discretionary profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

In the event of termination due to death, disability or normal retirement, participants shall become 100% vested in the Company's discretionary profit-sharing contribution portion of their account. For all other participants, vesting in the Company's discretionary profit-sharing contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

Following the merger with the Eppendorf Holdings, Inc. 401(k) Plan, participants will continue to vest in their discretionary profit-sharing contributions over this 6-year graded vesting schedule.

Payment of benefits

Upon termination of service for any reason, participants with an account balance of \$7,000 or less will receive a lump-sum amount equal to the value of the vested interest in their account. For participants with an account balance greater than \$1,000, but less than \$7,000, the Plan administrator will make a direct rollover of the participant's account to an individual retirement account designated by the Plan administrator, unless otherwise directed by the participant. Participants with an account balance greater than \$7,000 will have the option to receive their vested benefit in the form of a lump-sum distribution, as installments, or defer payment of benefits until a later date.

Participants who have incurred a disability, as defined by the Plan, may withdraw all or a portion of their vested account balance prior to termination.

Forfeited accounts

At July 1, 2025 and December 31, 2024, forfeited nonvested accounts totaled \$0 and \$113,247, respectively. These accounts may be used to offset Company contributions or to pay Plan administrative expenses. For the period from January 1, 2025 to July 1, 2025, forfeited nonvested accounts of \$89,767 were utilized to offset the prior year contribution receivable, \$13,017 were utilized to pay Plan expenses, and \$12,737 was transferred to the Eppendorf Holdings, Inc. 401(k) Plan.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Any discretionary profit-sharing contributions from the Company are recorded in the year in which the contributions are earned.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping and certain investment advisory fees are included in administrative expenses. Other indirect investment related expenses are included in the net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through January 16, 2026, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and for the period from January 1, 2025 to July 1, 2025.

Mutual funds and money market fund: Valued at the daily closing price as reported by the funds. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and the money market fund held by the Plan are deemed to be actively traded.

As a result of the Plan's merger, all assets were transferred to the Eppendorf Holdings, Inc. 401(k) Plan on July 1, 2025, therefore, there is no fair value table as of July 1, 2025.

Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at July 1, 2025 and December 31, 2024, and investment income for the period January 1, 2025 to July 1, 2025, that are disclosed in the accompanying financial statements were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 5 - Related party transactions and party-in-interest transactions

Plan investments included shares of mutual funds and a money market fund held by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid directly from Plan assets to the trustee, investment advisor and auditor amounted to \$48,406 for the period January 1, 2025 to July 1, 2025. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. The Plan sponsor pays directly any other fees related to the Plan's operations.

Note 6 - Tax status

The Plan has been designed using a nonstandardized pre-approved defined contribution plan document sponsored by FMR, LLC. FMR, LLC received an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the nonstandardized pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is deemed to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
